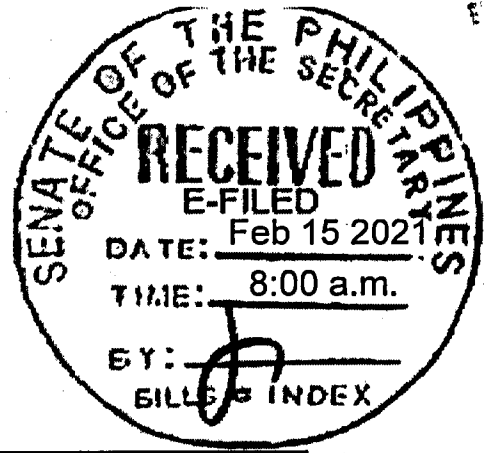

The Committees on Health and Demography, and Finance, to which was referred
House Bill No. 6727, introduced by Representatives Savellano, A.H.D.L. Tan, Ungab,
et. al., entitled:

AN ACT
INCREASING THE BED CAPACITY OF THE SINAIT DISTRICT
HOSPITAL IN SINAIT, ILOCOS SUR FROM TWENTY-FIVE (25)
BEDS TO ONE HUNDRED (100) BEDS AND APPROPRIATING
FUNDS THEREFOR

and taking into consideration **Senate Bill No. 1383**, introduced by Senator Marcos,
entitled:

AN ACT
INCREASING THE BED CAPACITY OF SINAIT DISTRICT HOSPITAL
IN SINAIT ILOCOS SUR FROM TWENTY-FIVE (25) TO ONE
HUNDRED (100) AND APPROPRIATING FUNDS THEREFOR

have considered the same and have the honor to report back to the Senate with the recommendation that House Bill No. 6727, taking into consideration Senate Bill No. 1383, be approved with the following amendments:

1. On page 1, line 4, before the word "shall", insert the phrase "**AND EXPANSION OF SERVICE CAPABILITY.**"

2. On page 2, line 16, insert two new Sections, which shall read as follows:

"SEC. 5. IF ANY PROVISION OR PART OF THIS ACT IS DECLARED UNCONSTITUTIONAL, THE REMAINING PARTS OR PROVISIONS NOT AFFECTED SHALL REMAIN IN FULL FORCE AND EFFECT."

"SEC. 6. ALL LAWS, EXECUTIVE ORDERS, ISSUANCES, RULES AND REGULATIONS INCONSISTENT WITH THIS ACT ARE HEREBY REPEALED OR MODIFIED ACCORDINGLY."

3. Renumber the succeeding section accordingly.

AN ACT INCREASING THE BED CAPACITY OF THE SINAIT DISTRICT HOSPITAL IN SINAIT, ILOCOS SUR FROM TWENTY-FIVE (25) BEDS TO ONE HUNDRED (100) BEDS AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** The authorized bed capacity of the Sinait District
2 Hospital in Sinait, Ilocos Sur is hereby increased from twenty-five
3 (25) to one hundred (100) beds. Any future increase in bed capacity
4 shall be consistent with the hospital development plan.

5 **SEC. 2.** The existing professional health care services and
6 facilities of the Sinait District Hospital are hereby upgraded to

1 conform with and be commensurate to the increase in its bed
2 capacity as provided in Section 1 hereof.

3 **SEC. 3.** The Provincial Government of Ilocos Sur shall provide
4 the necessary funds for the maintenance and other operating
5 expenses of the Sinait District Hospital. It shall also allocate funds
6 for the appropriate adjustments in its human resource complement
7 to support the increase in bed capacity and the corresponding
8 upgrading of its service facilities and professional health care
9 services. The Secretary of the Department of Health (DOH) shall
10 include in the DOH's subsidy program, support for the capital outlay
11 requirements of the said district hospital.

12 **SEC. 4.** Republic Act No. 6302, entitled "An Act Establishing
13 an Emergency Hospital in the Municipality of Sinait, Province of
14 Ilocos Sur, and Appropriating Funds Therefore" is hereby amended
15 accordingly.

16 **SEC. 5.** This Act shall take effect fifteen (15) days after its
17 publication in the *Official Gazette* or in a newspaper of general
18 circulation.
