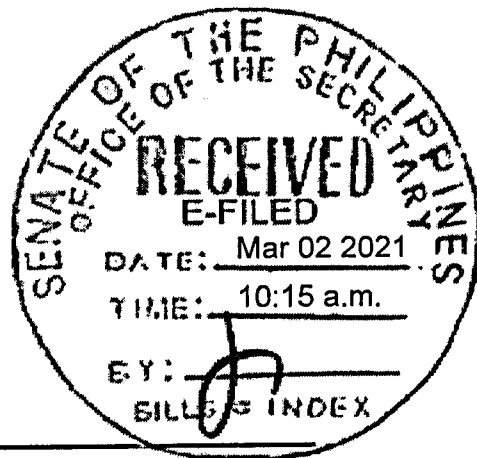

**AN ACT  
GRANTING PHILIPPINE CITIZENSHIP TO BIENVENIDO MOREJON  
MARAÑON**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1     **SECTION 1.** Mr. Bienvenido Morejon Marañon is hereby granted Philippine  
2 citizenship with all the rights, privileges and prerogatives, as well as the duties  
3 and obligations appurtenant thereto under the Constitution and the laws of the  
4 Republic of the Philippines.

6     **SEC. 2.** Mr. Marañon shall take the Oath of Allegiance to the Republic of the  
7 Philippines before an officer duly authorized to administer the same. The Oath  
8 of Allegiance shall be registered with the Bureau of Immigration.

9  
10     **SEC. 3.** Upon registration of the Oath of Allegiance, the Bureau of  
11 Immigration shall issue a Certificate of Naturalization to Mr. Marañon who shall  
12 thereupon enter into the full enjoyment of Philippine citizenship.

13  
14     **SEC. 4.** This Act shall take effect fifteen (15) days after its publication in  
15 the Official Gazette or in a newspaper of general circulation.
