AN ACT PROVIDING FOR THE CONSTRUCTION OF A NATIONAL HIGHWAY FROM LANA DEL NORTE INTERIOR CIRCUMFERENTIAL ROAD IN THE MUNICIPALITY OF TAGOLOAN, PROVINCE OF LANA DEL NORTE TO THE MUNICIPALITY OF TALAKAG, PROVINCE OF BUKIDNON, WITH A CROSSROAD AT BARANGAY MALIMBATO, MUNICIPALITY OF TAGOLOAN, PROVINCE OF LANA DEL NORTE AND CONNECTING ROADS TO THE NATIONAL HIGHWAY IN ILIGAN CITY THROUGH BARANGAY PUGAAN, ILIGAN CITY AND TO THE NATIONAL HIGHWAY IN MARAWI CITY THROUGH THE MUNICIPALITY OF KAPAL, PROVINCE OF LANA DEL SUR, TO BE KNOWN AS THE MUSLIM-CHRISTIAN UNITY HIGHWAY AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. There shall be constructed, under the supervision
2 of the Department of Public Works and Highways (DPWH), a
3 national highway from the Lanao del Norte Interior Circumferential
4 Road in the Municipality of Tagoloan, Province of Lanao del Norte
5 to the Municipality of Talakag, Province of Bukidnon, with a
6 crossroad at Barangay Malimbato, Municipality of Tagoloan,
7 Province of Lanao del Norte and connecting roads to the national
8 highway in Iligan City through Barangay Pugaan, Iligan City and

1 to the national highway in Marawi City through the Municipality
2 of Kapai, Province of Lanao del Sur. The aforesaid stretch of road
3 shall be known as the Muslim-Christian Unity Highway.

4 SEC. 2. The amount necessary to defray the cost of
5 undertaking and completing the feasibility study and detailed
6 engineering for this project, and other activities related thereto
7 shall be included in the annual General Appropriations Act (GAA).
8 Thereafter, the Secretary of the DPWH shall include in the
9 Department's program the construction of the Muslim-Christian
10 Unity Highway, the funding of which shall be included in the
11 annual GAA.

12 SEC. 3. This Act shall take effect fifteen (15) days after its
13 publication in the *Official Gazette* or in a newspaper of general
14 circulation.
