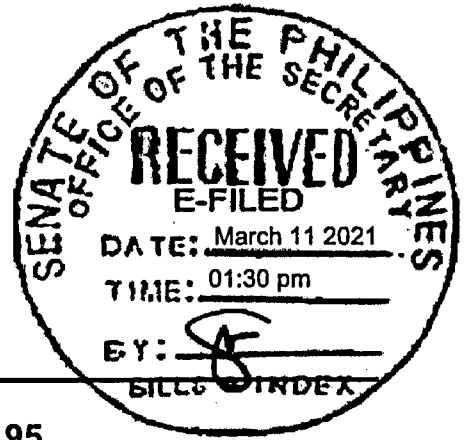



AN ACT CREATING THE ILIGAN CITY DISTRICT ENGINEERING
OFFICE AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. A district engineering office is hereby created in
2 the Lone Legislative District of the City of Iligan to be known as the
3 Iligan City District Engineering Office.

4 SEC. 2. The Secretary of the Department of Public Works and
5 Highways shall include in the Department's program the
6 operationalization of a separate district engineering office in the
7 City of Iligan, the funding of which shall be included in the annual
8 General Appropriations Act.

9 SEC. 3. This Act shall take effect fifteen (15) days after its
10 publication in the *Official Gazette* or in a newspaper of general
11 circulation.
