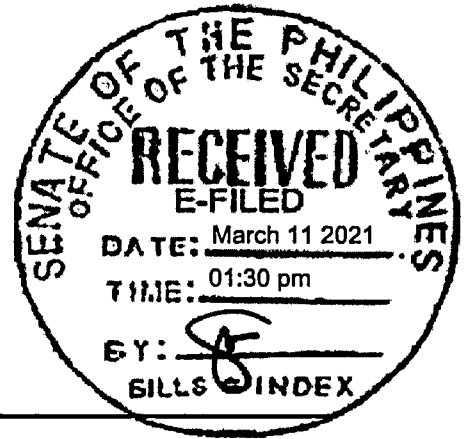





AN ACT CREATING A NEW DISTRICT ENGINEERING OFFICE IN THE
THIRD LEGISLATIVE DISTRICT OF THE PROVINCE OF
ZAMBOANGA DEL NORTE AND APPROPRIATING FUNDS
THEREFOR

*Be it enacted by the Senate and House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There shall be established, under the supervision
2 of the Department of Public Works and Highways, an additional
3 district engineering office for the Third Legislative District of the
4 Province of Zamboanga del Norte. It shall be known as the Fourth
5 District Engineering Office and shall be located in the Municipality
6 of Siocon, Province of Zamboanga del Norte.

7 SEC. 2. The Fourth District Engineering Office shall serve the
8 municipalities of Baliguan, Siraway, Siocon, and Sibuco, all within
9 the Third Legislative District of the Province of Zamboanga del
10 Norte.

11 SEC. 3. The Secretary of Public Works and Highways shall
12 include in the Department's program the operationalization of the
13 Fourth District Engineering Office in the Province of Zamboanga del
14 Norte, the funding of which shall be included in the annual General
15 Appropriations Act.

1 SEC. 4. This Act shall take effect fifteen (15) days after its
2 publication in the *Official Gazette* or in a newspaper of general
3 circulation.
