AN ACT INCREASING THE BED CAPACITY OF THE TUMAUINI COMMUNITY HOSPITAL IN THE MUNICIPALITY TUMAUINI, PROVINCE OF ISABELA FROM FIFTEEN (15) BEDS TO ONE HUNDRED (100) BEDS, UPGRADING ITS PROFESSIONAL HEALTH CARE SERVICES AND FACILITIES, AUTHORIZING THE INCREASE OF ITS MEDICAL PERSONNEL AND APPROPRIATING FUNDS THEREFOR

EXPLANATORY NOTE

Article II, Section 15 of the 1987 Philippine Constitution mandates that, "The State shall protect the right to health of the people and instill health consciousness among them." It is mandated by the highest law of the land to ensure that all communities have access to quality and accessible healthcare.

The Tumauini Community Hospital is classified as Level I hospital by the Department of Health. It has an authorized bed capacity of fifteen (15) beds but based on 2018 Statistical Report it is implementing an actual bed capacity of thirty-two (32) beds. It serves forty-six (46) barangays of the municipality nd caters to some patients coming from the municipalities of Cabagan, Sto. Tomas, Delfin Albano and the City of Ilagan. Hence, it caters patients beyond its capacity.

This bill therefor seeks to increase the bed capacity of the Tumauini Community Hospital in Tumauini, Province of Isabela from fifteen (15) to one hundred (100) beds. This will make Tumauini Community Hospital provide the quality health care for the people in the community and accommodate the increasing number of patients.

In view of the foregoing, the immediate passage of this measure earnestly sought.



AN ACT INCREASING THE BED CAPACITY OF THE TUMAUINI
COMMUNITY HOSPITAL IN THE MUNICIPALITY TUMAUINI,
PROVINCE OF ISABELA FROM FIFTEEN (15) BEDS TO ONE HUNDRED
(100) BEDS, UPGRADING ITS PROFESSIONAL HEALTH CARE
SERVICES AND FACILITIES, AUTHORIZING THE INCREASE OF ITS
MEDICAL PERSONNEL AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

- SECTION 1. The authorized bed capacity of Tumauini Community Hospital, Tumauini, Province of Isabela, is hereby increased from fifteen (15) beds to one hundred (100) beds.
 - SEC. 2. The existing service facilities of the Tumauini Community Hospital are hereby upgraded to conform with and be commensurate to the bed capacity increase as provided for in Section 1 hereof. Additional necessary medical, health services and auxiliary personnel shall be recruited to meet the service delivery requirements of the Tumauini Community Hospital in accordance with the guidelines of the Department of Health.
- SEC. 3. The amount necessary for the initial implementation of this Act shall be charged against the current year's appropriation for the organizational adjustment fund. Thereafter, such sums as necessary for its continued operation shall be included in the Annual General Appropriations Act.
 - SEC. 4. If any part or provision of this Act is held unconstitutional or invalid, other parts or provisions hereof which are not affected shall continue to remain in full force and effect.
 - SEC. 5. All laws, decrees, executive orders, rules and regulations or parts thereof inconsistent with or contrary to the provisions of this Act are deemed amended, repealed or modified accordingly.

SEC. 6. This Act shall take effect fifteen (15) days after the completion of its publications in the *Official Gazette* or in any two (2) newspapers of general circulation.
