### TO PROVIDE EATING DISORDERS AWARENESS, PREVENTION, AND EDUCATION AMONG ELEMENTARY, SECONDARY AND COLLEGE STUDENTS, THEIR PARENTS AND GUARDIANS

#### **EXPLANATORY NOTE**

With heavy consumption of social media nowadays, many adolescents and youth, especially females, have become prone to developing unhealthy concerns about their body image, weight and shape, and in the long run, cultivated body dissatisfaction, negative self-image and low self-esteem. Amid the prevalent notion of being thin as being healthy and attractive, some would resort to extreme dieting and harmful eating behaviors.

While this is a simplistic view of eating disorders which are triggered by a myriad of risk factors – biological/genetic, environmental, psychological and emotional – these conditions are serious health issues and potentially life threatening. For instance, anorexia nervosa (an eating disorder characterized by self-starvation, severe food restrictions, and excessive weight loss) has numerous complications such as anemia, bone and muscle loss, heart failure, gastrointestinal and kidney problems, among others, and could lead to death at its most severe<sup>1</sup>.

Considering the impact of these eating disorders to our youth, this bill seeks to provide awareness and education to students at all levels, as well as to their parents and guardians. It also mandates the Department of Health, the Department of

Education and the Commission on Higher Education to work together and provide programs which shall improve the identification of students with eating disorders and train educators and school personnel on eating disorder prevention and assistance methods. Lastly, this measure requires the same agencies to conduct a study to determine the prevalence of eating disorders among students and their effects on the educational advancement and achievement.

The immediate passage of this bill is sought.

#### AN ACT

## TO PROVIDE EATING DISORDERS AWARENESS, PREVENTION, AND EDUCATION AMONG ELEMENTARY, SECONDARY AND COLLEGE STUDENTS, THEIR PARENTS AND GUARDIANS

Be it enacted by the Senate and House of Representative of the Philippines in Congress assembled:

Section 1. Short Title. – This Act shall be known as the "Eating Disorders
 Awareness, Prevention and Education Act."

Sec. 2. *Declaration of Policy.* — It is a policy of the State to protect and promote the right of the people to health and instill health consciousness among them. The State also recognizes the vital role of the youth in nation building and shall promote and protect their physical, moral, spiritual, intellectual and social wellbeing.

Sec. 3. *Definition of Terms.* – As used in this Act, the following terms shall
mean:

a) "Eating disorder" means a disturbance in eating behavior, such as extreme
and unhealthy reduction of food intake (anorexia nervosa) or severe
overeating (bulimia nervosa and/or binge eating disorder), as well as
feelings of distress or extreme concern about body shape or weight.

b) "Anorexia nervosa" means an eating disorder characterized by self starvation, severe food restrictions, and excessive weight loss.

	2	consumption followed by inappropriate compensatory behaviors, such as

	4	d) "Binge eating disorder" means frequent episodes of uncontrolled

	9	g) "CHED" means the Commission on Higher Education.
	10	h) "DOH" is the Department of Health.

	12	Sec. 4. Innovative Assistance for the Identification, Training, and Educational
	13	Awareness of Eating Disorders. — The DepEd, CHED, and DOH shall provide programs
	14	to:
• • •	15	a) Improve the identification of students with eating disorders – anorexia
	16	nervosa, bulimia nervosa, binge eating disorder, and other eating disorders,
	17	not otherwise specified, in order that they may receive appropriate medical
	18	treatment;
	19	b) Increase awareness of such disorders among parents and students; and
	20	c) Train educators such as teachers, school nurses, school social workers,
	21	coaches, school counselors, and administrators on effective eating disorder

	23	Sec. 5. Public Service Announcements. – The Secretary of DepEd and the
	24	Chairman of CHED, in consultation with the Secretary of DOH, shall carry out a
	25	program to develop, distribute, and promote the broadcasting of public service
	26	announcements to improve public awareness, and to promote the identification and
	27	prevention of eating disorders.
	28	Sec. 6. <i>Eating Disorders Research and Report.</i> – Not later than eighteen (18)
in the second	29	months after the enactment of this Act, the DepEd, the CHED, and the DOH shall
	30	conduct a study on the impact eating disorders have on educational advancement and
	31	achievement. The study shall:

a) Determine the prevalence of eating disorders among students and the 1 morbidity and mortality rates associated with eating disorders; 2 b) Evaluate the extent to which students with eating disorders are more likely 3 to miss school, have delayed rates of development, or have reduced 4 cognitive skills: 5 c) Report on current national and local programs to educate youth about the 6 7 dangers of eating disorders, as well as evaluate the value of such programs; and 8 d) Make recommendation on measures that could be undertaken to strengthen 9 eating disorder prevention and awareness programs. 10 Sec. 7. Separability Clause. - If any provision or part hereof is held invalid or 11 unconstitutional, the remainder of the law or the provision or part not otherwise 12 affected shall remain valid and subsisting. 13 Sec. 8. *Repealing Clause.* – Any law, presidential decree or issuance, executive 14 order, letter of instruction, administrative order, rule, or regulation contrary to or 15 inconsistent with the provisions of this Act are hereby repealed, modified, or amended 16 17 accordingly. 18 Sec. 9. Effectivity. - This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a newspaper of general circulation. 19
