

AN ACT

CREATING FOUR (4) ADDITIONAL BRANCHES OF THE REGIONAL TRIAL COURT IN THE FOURTH JUDICIAL REGION TO BE STATIONED IN THE MUNICIPALITIES OF ROSARIO AND SAN JUAN, PROVINCE OF BATANGAS, AND APPROPRIATING FUNDS THEREFOR, AMENDING FOR THE PURPOSE SECTION 14(E) OF BATAS PAMBANSA BLG. 129, OTHERWISE KNOWN AS "THE JUDICIARY REORGANIZATION ACT OF 1980", AS AMENDED

EXPLANATORY NOTE

Section 16, Article III of the 1987 Philippine Constitution states that, "All persons shall have the right to a speedy disposition of their cases before judicial, quasi-judicial, or administrative bodies." However, the real ty is that delays in the resolution of cases are prevalent. The twin problems of docket congestion and case delay continue to beset the nation's trial courts as the volume of cases filed consistently rise while the disposition of cases is rather slow. As the population increases, it pushes the judge-to-people ratio to an undesireable low level.

The problem of congestion is also evident in the Regional Trial Courts (RTC). In the Municipality of Rosario, the existing RTC serves six (6) municipalities, namely: Ibaan, Lobo, Padre Garcia, Rosario, San Juan, and Taysan, which have a combined population of more than 400,000.

This bill seeks to create four (4) additional branches of the Regional Trial Court in the Fourth Judicial Region, three (3) branches in the Municipality of Rosario and one (1) branch in the Municipality of San Juan, Province of Batangas.

The Municipality of Rosario and Municipality of San Juan are both located in District 4 of the Province, which has a population of 116,764 and 108,585 respectively, as of 2015.¹ In the Municipality of Rosario, which is the sixth most populous municipality in the Province, the level of urbanization has steadily risen over the years and has peaked in 2015 when the urban population comprised 27% of the total population². On the other hand, the Municipality of San Juan has forty-two (42) barangays and is the second largest municipality in the Province of Batangas.³

Under the Fourth Judicial Region, there are existing twenty-one Regional Trial Courts but only one branch is located in the Municipality of Rosario and none in the Municipality of San Juan. The need to create new Regional Trial Courts in these municipalities is clear. With the increasing population, more resources are needed to hasten the resolution of court cases in order to strengthen the administration of justice.

In view of the foregoing, the immediate approval of this bill is earnestly sought.



AN ACT

CREATING FOUR (4) ADDITIONAL BRANCHES OF THE REGIONAL TRIAL COURT IN THE FOURTH JUDICIAL REGION TO BE STATIONED IN THE MUNICIPALITIES OF ROSARIO AND SAN JUAN, PROVINCE OF BATANGAS, AND APPROPRIATING FUNDS THEREFOR, AMENDING FOR THE PURPOSE SECTION 14(E) OF BATAS PAMBANSA BLG. 129, OTHERWISE KNOWN AS "THE JUDICIARY REORGANIZATION ACT OF 1980", AS AMENDED

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- Section 1. Four (4) additional branches of the Regional Trial Court in the Fourth Judicial Region are hereby created and stationed in the Province of Batangas, as follows:
 - (a) Three (3) branches in the Municipality of Rosario; and
 - (b) One (1) branch in the Municipality of San Juan.
 - The Supreme Court shall assign the respective branch numbers for the newly created branches of the Regional Trial Court.
 - Sec. 2. The Chief Justice of the Supreme Court, in coordination with the Secretary of the Department of Justice, shall immediately include in the Court's program the operationalization of the four (4) additional branches of the Regional Trial Court in the municipalities of Rosario and San Juan, Province of Batangas. The funds necessary for the operation of the courts herein created shall be appropriated and released only upon the actual organization of the courts and the appointment of its personnel.
 - Sec. 3. Section 14(e) of Batas Pambansa Blg. 129, otherwise known as "The Judiciary Reorganization Act of 1980", as amended, and all other laws, rules and

- regulations which are inconsistent with this Act are hereby amended, repealed or
- 2 modified accordingly.
- Sec. 4. This Act shall take effect fifteen (15) days after its publication in the
- 4 Official Gazette or in a newspaper of general circulation.
