AN ACT
ESTABLISHING THE BOHOL FIRST CONGRESSIONAL DISTRICT LIBRARY IN
THE MUNICIPALITY OF BALILIHAN, PROVINCE OF BOHOL, AND
APPROPRIATING FUNDS THEREFOR.

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. There shall be established in the Municipality of Balilihan, Province of
2 Bohol the Bohol First Congressional District Library, which shall be under the direct control and
3 supervision of the National Library of the Philippines (NLP).
4

5 SEC. 2. The Director of the NLP shall appoint the following to manage the Bohol
6 First Congressional District Library:
7

- 8 (a) Librarian III;
9 (b) Librarian I;
10 (c) Administrative Assistant III;
11 (d) Computer File Librarian I;
12 (e) Administrative Aide VI; and
13 (f) Watchman (Security Guard).
14

15 The appointments of said positions shall be in accordance with the *Compensation and*
16 *Position Classification System* and other civil service rules and regulations. In addition, their
17 salaries and allowances shall be in accordance with Republic Act No. 11466, otherwise
18 known as the "*Salary Standardization Law of 2019*," and other applicable laws.
19

20 SEC. 3. The NLP shall include in its program the implementation of this Act, the
21 funding of which shall be included in the annual General Appropriations Act.
22

23 SEC. 4. Within sixty (60) days from the effectivity of this Act, the NLP shall
24 promulgate the necessary rules and regulations for the proper implementation of this Act.

26 SEC. 5. If any provision of this Act is declared unconstitutional, the remainder of this
27 Act or any provision not affected thereby shall remain in full force and effect.

1 SEC. 6. All laws, executive orders, presidential decrees, proclamations, rules,
2 regulations, issuances, and enactments or parts thereof inconsistent with this Act are hereby
3 repealed or modified accordingly.
4

5 SEC. 7. This Act shall take effect fifteen (15) days after its publication in the *Official*
6 *Gazette* or in a newspaper of general circulation.
