#### RECONSIDERATION OF THE APPROVAL OF THE JOURNAL

Upon motion of Senator Pangilinan, there being no objection, the Body reconsidered the approval of the Journal of Session No. 16.

## APPROVAL OF THE JOURNAL, AS CORRECTED

Upon motion of Senator Pangilinan, there being no objection, the Body approved the Journal of Session No. 16 subject to the correction of Senator Enrile on page 355, right column, first paragraph, seventh line, between the words "including" and "investments", to insert the phrase DIVIDENDS FROM, and on page 356, left column, second paragraph, first line, to change the words "Rogers stock" to ROAD USER'S TAX.

#### PRIVILEGE SPEECH OF SENATOR GORDON

Availing himself of the privilege hour, Senator Gordon observed that many Filipinos are bereft of confidence in the future probably because many Filipino leaders were not able to write about the country's past very well.

He stated that the history of the defense of Bataan during World War II, where 60,000 Filipinos and 10,000 Americans fought, was written from the American viewpoint.

Senator Gordon stated that even before Bataan, there were incidents where Filipino heroes rose to the occasion — young men and women visionaries — who tried to break the psychological bondage to the colonial past. He imagined how Jose Rizal must have been amazed at the martyrdom of Fathers Gomez, Burgos and Zamora whose executions shocked the nation; how he must have been sickened by the hypocrisy of the Spanish friars to the point that he vowed not to be a Jesuit though he had wanted to be one; how the ideas of independence must have evolved in his mind.

He stated that on September 3, 1896, a band of Filipinos won their first victory against Spain, and every August  $26^{th}$  of the year, the nation commemorates the "Cry of Balintawak." He observed that very few people are aware that after August 26, when the revolution was discovered by the Spaniards, the Filipinos had no weapons and had to resort to the so-called *agaw armas* operations against the Spaniards; there was nobody supplying them with money or weapons or any logistics to fight the revolution, and so, Filipinos lost battle after battle. In fact, he recalled, even Andres Bonifacio was unable to come on time during the Battle of Manila a few days after the Battle of Pinaglabanan.

On September 2, after Baldomero Aguinaldo tried a stab at Imus, Cavite, he said that Filipinos were beginning to lose hope and when they lost hope, the original eight provinces involved in the revolution, started to think in terms of disbanding. It would become one of the 300 rebellions of the Philippines that never succeeded, he said.

He recalled that Col. Jose Tagle of Imus went to Gen. Emilio Aguinaldo and suggested that Filipino soldiers take arms from the camarin in Imus that was guarded by the friars and guardia civil. At that time, he said, there was no organized army and the soldiers only had escopetas or pellet guns, and the rest used *tabaks* or spears; nonetheless, 600 soldiers - 200 under Colonel Tagle and 400 under General Aguinaldo --- marched towards the *camarin* using a Filipino band which, at that time, was the fashion in Europe to coordinate an orderly attack. He said that it was the Filipinos' way of calling the attention of their kababayans in Cavite to join them in the cause, and soon, the 600 men grew to 2,000 men who stormed the *camarin* only to be met by a powerful volley of fire that killed many people, including one of the friends of General Aguinaldo.

He stated that General Aguinaldo left the battle at the *camarin* to meet Spanish General Aguirre, who, at that time, was attacking Zapote. He said that General Aguinaldo suffered another defeat and it created a little ruckus because people believed he was killed in battle; apparently, General Aguinaldo only played dead and went back to Imus limping. To the surprise of the general, he narrated, Colonel Tagle and his men succeeded in taking over the *camarin* and retrieved, in the process, 30 Remington rifles, two modern Winchester rifles, and a Montana cannon. He said that all these accounts are in the book of General Aguinaldo entitled, *The Memoirs of General Aguinaldo*.

Senator Gordon recalled that the following day, General Aguirre came and led an attack against the Filipinos but General Aguinaldo and Colonel Tagle executed a plan that had the Spaniards retreating. He stated that General Aguirre, as he was retreating, dropped his *sable del mando* which was retrieved by Filipino forces, given to Colonel Tagle, and turned over to General Aguinaldo. He said that the sword is now in the Aguinaldo Shrine in Kawit, Cavite.

Senator Gordon stated that the story is in the books of General Aguinaldo and of Onofre Corpuz, but little was written about Filipinos who served the war. He noted that many of the country's heroes came mostly from the *illustrado* class but the exploits of many heroes were not written about because they lacked the educational skills to write about their victories.

Senator Gordon disclosed that Imus was the hometown of his grandmother, Veronica Tagle, who happened to be the daughter of Col. Jose Tagle. He said that his grandmother married his grandfather, John Gordon, a soldier of the United States Army, and moved to Olongapo City where they raised his father, James Leonard Gordon, who chose to become a Filipino and was assassinated in 1967. He added that John Gordon never returned to the United States of America and died here in 1952.

Senator Gordon said that he posited the story primarily because Filipinos tend to forget. He recalled that when he was a delegate to the Constitutional Convention, he raised a question about the role of the youth in the Convention, and former President Garcia replied, "A man who has seen a long past is capable of seeing a far future." He said that the statement never left

him because he took up history and government and he has a fascination with history. He stated that Robert Frost defined "hired man" as one who has no confidence, who is not able to look at his past with pride and therefore incapable of looking at the future with hope.

He urged the Body to focus the mindset of the young people on these incidents which are not written in full so that the young would gain confidence and the values of courage, duty, honor and commitment.

He noted that the Filipinos at that time had the love of country, freedom and independence in their hearts unlike most of the Filipinos today who do not know what they want. He stressed the need to inculcate in the youth the sense of duty, dignity, determination and pride of character so that in the process, they learn about their past, and adequately paint a picture of the kind of person they want to be.

Senator Gordon stated that the battle of Imus, according to historical experts on the revolution, is only one of the three major victories of the past that rallied the Filipinos against hopelessness and in the process, they fought together to beat a Spanish general who had horses and superior weapons. He stressed that the Filipinos won because of their courage, integrity, intellect, and dedication. As a result, he said, the eight provinces rejoined the revolution.

He recalled that the late Senator Ople told him once, "Your grandfather had started the revolution." He said that he has always thought that history has always helped define and paint the picture of the future of the people, and that he often challenges the youth to draw a picture of who they are and what they can be. He exhorted the youth never to fear the future but to always look at it as their friend, that all the challenges in life will come and go only if they have the courage to shape their future.

Senator Gordon expressed hope that his challenge would bring forth a new thrust of faith, hope and courage so that the Filipinos would change. He stressed that the heroes of the past did not depend on other people but on their vision, their faith, and their country. In closing, he quoted Ralph Waldo Emerson, to wit:

Not gold but only men can make A nation great and strong; Men who for truth and honor's sake Stand fast and suffer long. Brave men who work while others sleep. Men who dare while others shy They build the nation's pillars deep And lift them to the skies.

#### INTERPELLATION OF SENATOR EJERCITO ESTRADA (J.)

Asked about the significance of the Labanan sa Imus and the Battle of Pinaglabanan, Senator Gordon stated that in these encounters, the Filipinos were filled with courage and faith, and shared a vision of an independent Philippines. He said that although the Katipuneros knew that they would be defeated in Pinaglabanan, they still made a gallant stand. He stressed that it is important to commemorate these events, manifesting that at some future time he would file a bill making these battles part of the history subject in public schools.

Upon further query, Senator Gordon stated that the battle spread to eight provinces, namely, Morong (Rizal), Bulacan, Cavite, Nueva Ecija, Bataan, Pampanga, Tarlac and Batangas. He added that San Juan was part of Morong at that time.

#### INTERPELLATION OF SENATOR DEFENSOR SANTIAGO

Senator Defensor Santiago took note that in his historical narrative, Senator Gordon mentioned the role of the masses albeit indirectly. She stated that today, the view of history professors and scholars, including those from the University of the Philippines, is that history should be written from the standpoint of the masses who had everything to lose by joining movements, especially against colonial masters, and not from the standpoint of the leaders of mass movements who usually belong to the higher social classes, who had their own interests to protect. She said that while these people led the mass movements "in heroic fashion," they were actually protecting their own political interests. On the other hand, she said, the masses, the real heroes, heeded the call to protect their country in spite of their lack of resources.

Asked what measures he would recommend so that history would be written in a perspective advocated by the scholars, Senator Gordon that a commission be formed to proposed encourage volunteers to conduct interviews and validate them and, thus, put the country's oral history in writing. He stated that he was in the process of conceptualizing the idea which would be put in a bill. Further, he underscored that history should be revisited because of the conflicting opinions about the roles played by major historical figures like Bonifacio and Aguinaldo, for instance, in the country's history. He observed that during the revolution against Spain, the Filipinos did not have a common vision based on an ideology so that everything was Hence, he said, the reduced to personalities. Filipinos were divided between the Magdiwang faction of Bonifacio and the Magdalo faction of Aguinaldo.

#### INTERPELLATION OF SENATOR ENRILE

Asked by Senator Enrile whether he sees a "sunrise future" for the Philippines in spite of the present condition, Senator Gordon replied that he has always believed in the Philippines. He revealed that his faith has been bolstered by several developments — by the nationalism of his father who opted to become a Filipino citizen; by the spirit of comradeship of Filipino volunteers in Subic and Intramuros; by the honor accorded by the Koreans to Lapu-Lapu who had been ignored by his fellow Filipinos. However, he expressed displeasure that some Filipino leaders have failed to fulfill their duties; that some Filipinos have continued to rely on doleouts or have become overly critical. He believed that the country needs a "sunrise" in keeping with the martyrdom of Rizal, and Fathers Gomez, Burgos and Zamora who all died at Bagumbayan.

Senator Enrile agreed that Filipinos should remain hopeful that they would have a better future. However, he observed that Filipinos have always remained divided. He pointed out that during the rebellion against Spain, Bonifacio led his Magdiwang faction in the Battle of Pinaglabanan; and five days later, Aguinaldo led his Magdalo faction in the *Labanan sa Imus*.

Asked whether the division persists to this day, Senator Gordon lamented that the leadership has failed to give a vision that the entire nation could follow. He noted that Singapore, which is about the size of Negros, and South Korea, which the Filipinos helped during the Korean War, are more progressive than the Philippines. He pointed out that the Philippines, which used to be the most literate nation in Asia, ranks No. 4 today. He stated that the Filipinos seem to have a "psychological hangover" from their colonial past which prevents them from becoming united.

Asked whether a Filipino helped the American forces capture General Aguinaldo, Senator Gordon replied in the affirmative.

On a historical footnote, Senator Gordon disclosed that the Macabebe Scouts, who were loyal to Bonifacio, joined the Americans because they were so incensed by Aguinaldo and his Magdalo faction.

Senator Enrile recalled that during World War II, many Filipinos joined the Japanese occupiers. He disclosed that at age 17, as a member of the underground, he fought against the Japanese and was incarcerated for 90 days by the *kempetai*.

Senator Gordon said that indeed in his privilege speech he mentioned that Senator Enrile was one of those who fought to prevent the take-over of Australia by the Japanese. He said that as suggested by Senator Arroyo, Australia should pay the Philippines, including Senator Enrile, for the favor.

Senator Enrile clarified that General MacArthur, in fact, went to Australia to prepare his country's efforts to regain the Philippines from the Japanese; otherwise, the Japanese would still be ruling the Philippines until now.

Stressing the need for the country to go to war against poverty, violence and all other ills caused primarily by the lack of unity among Filipinos, Senator Enrile asked whether it would need a new Bonifacio or an Aguinaldo to do

res-

this. Senator Gordon replied that the Filipinos should not fight against these ills alone but also to fight for their dignity in order to regain their strength as a nation.

Senator Enrile believed that the killing of judges, media men and ordinary people would not happen again if Filipinos become united and learned to recognize the rule of law. Senator Gordon added that change should start from the individual himself.

Senator Enrile exhorted the Body, especially the younger members of the Senate who look back to the nation's past and forward to a "sunrise future," to forge on and fulfill their dreams.
