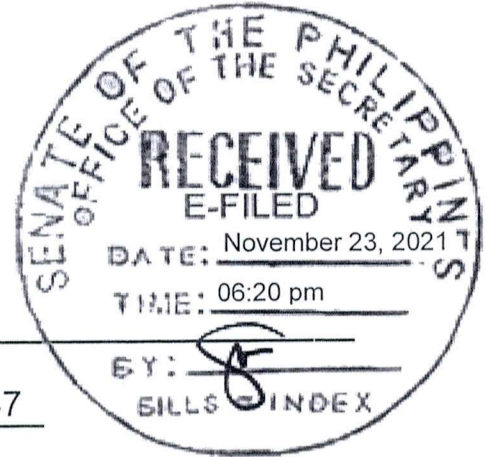

**MR. PRESIDENT:**

The Committees on Basic Education, Arts and Culture; and Finance, to which were referred **House Bill No. 9658**, introduced by Representatives Fuentesbella, Romulo, Yap (E.) and Castro (F.L.), entitled:

**"AN ACT**

**CONVERTING THE PINAGLABANAN HIGH SCHOOL IN BARANGAY PINAGLABANAN, MUNICIPALITY OF GOA, PROVINCE OF CAMARINES SUR INTO A NATIONAL HIGH SCHOOL TO BE KNOWN AS PINAGLABANAN NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR"**

have considered the same and have the honor to report it back to the Senate with the recommendation that House Bill No. 9658 be approved with the following amendments:

1. In lines 1 to 3, delete the entire Section 1 and replace it with a new Section 1 to read as follows:

**"SECTION 1. THE NAME OF PINAGLABANAN HIGH SCHOOL IN BARANGAY PINAGLABANAN, MUNICIPALITY OF GOA, PROVINCE OF CAMARINES SUR IS HEREBY CHANGED TO PINAGLABANAN NATIONAL HIGH SCHOOL."**

2. In lines 5 to 6, delete the entire Section 2 and replace it with a new Section 2 to read as follows:

**"SEC. 2. THE MAIN CAMPUS OF THE PINAGLABANAN NATIONAL HIGH SCHOOL SHALL CONTINUE TO REMAIN IN ITS PRESENT LOCATION IN BARANGAY PINAGLABANAN, MUNICIPALITY OF GOA, PROVINCE OF CAMARINES SUR."**

3. In lines 8 to 12, delete the entire Section 3.
4. In lines 14 to 15, delete the entire Section 4.
5. Renumber the succeeding Section accordingly.
6. Finally, amend the title to read as follows:



AN ACT  
CONVERTING THE PINAGLABANAN HIGH SCHOOL IN BARANGAY  
PINAGLABANAN, MUNICIPALITY OF GOA, PROVINCE OF CAMARINES SUR  
INTO A NATIONAL HIGH SCHOOL TO BE KNOWN AS PINAGLABANAN  
NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1 SECTION 1. The Pinaglabanan High School in Barangay Pinaglabanan, Municipality  
2 of Goa, Province of Camarines Sur is hereby converted into a national high school to be  
3 known as Pinaglabanan National High School.

4  
5 SEC. 2. All personnel, assets, liabilities and records of the Pinaglabanan High School  
6 are hereby transferred to and absorbed by the Pinaglabanan National High School.

7  
8 SEC. 3. The Secretary of Education shall immediately include in the Department's  
9 program the operationalization of the Pinaglabanan National High School, the initial funding  
10 of which shall be charged against the current year's appropriation of the Pinaglabanan High  
11 School. Thereafter, the amount necessary for the continued operation of the school shall be  
12 included in the annual General Appropriations Act.

13  
14 SEC. 4. Within sixty (60) days after the approval of this Act, the Secretary of  
15 Education shall promulgate the rules and regulations implementing the provisions of this Act.

16  
17 SEC. 5. This Act shall take effect fifteen (15) days after its publication in the *Official*  
18 *Gazette* or in a newspaper of general circulation.
