AN ACT ESTABLISHING THE LAND TRANSPORTATION
OFFICE (LTO) DISTRICT OFFICE IN MANOLO FORTICH,
BUKIDNON AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

1 SECTION 1. There is hereby established a district office of the
2 Land Transportation Office to be located at the Municipality of
3 Manolo Fortich, Province of Bukidnon.

4 SEC. 2. The Secretary of the Department of Transportation
5 shall immediately include in the Department's program the
6 operationalization of an LTO district office in Manolo Fortich,
7 Province of Bukidnon, the funding of which shall be included in
8 the annual General Appropriations Act.

9 SEC. 3. This Act shall take effect fifteen (15) days after its
10 publication in the *Official Gazette* or in a newspaper of general
11 circulation.
