MR. PRESIDENT:

The Committee on Higher, Technical and Vocational Education, to which was referred **House Bill No. 9528**, introduced by Representatives Adiong, Go (M.), Cuaresma, Sy-Alvarado, Celeste, and Savellano, entitled:

"AN ACT

RENAMING THE ADIONG MEMORIAL POLYTECHNIC STATE COLLEGE IN THE MUNICIPALITY OF DITSAAN RAMAIN, PROVINCE OF LANA DEL SUR, AS THE "ADIONG MEMORIAL STATE COLLEGE", AND EXTENDING THE TERM OF OFFICE OF THE PRESIDENT"

has considered the same and has the honor to report it back to the Senate with the recommendation that House Bill No. 9528, be approved with the following amendments:

1. On lines 5 to 13, delete entire Section 2;
2. On lines 15 to 16, renumber Section 3 into becoming Section 2;
3. After line 16, insert a new Section 3 to be read as follows:

"SEC. 3. ALL LAWS, PRESIDENTIAL DECREES, EXECUTIVE ORDERS, RULES AND REGULATIONS CONTRARY TO OR INCONSISTENT WITH THE PROVISIONS OF THIS ACT ARE REPEALED OR MODIFIED ACCORDINGLY."

4. Finally, to amend the title of the bill which shall now read as follows:

**"AN ACT
RENAMING THE ADIONG MEMORIAL POLYTECHNIC
STATE COLLEGE IN THE MUNICIPALITY OF DITSAAN
RAMAIN, PROVINCE OF LANA DEL SUR, AS THE
"ADIONG MEMORIAL STATE COLLEGE""**

AN ACT

RENAMING THE ADIONG MEMORIAL POLYTECHNIC STATE COLLEGE IN THE
MUNICIPALITY OF DITSAAN RAMAIN, PROVINCE OF LANAOS DEL SUR, AS THE
"ADIONG MEMORIAL STATE COLLEGE", AND EXTENDING THE TERM OF
OFFICE OF THE PRESIDENT"

*Be it enacted by the Senate and the House of Representatives of the Philippines in Congress
Assembled.*

1 **SECTION 1.** The Adiong Memorial Polytechnic State College located in the Municipality
2 of Ditsaan-Ramain, Province of Lanao del Sur, is hereby renamed as the Adiong Memorial State
3 College, hereinafter referred to as the AMSC.
4

5 **SEC. 2.** The President of the AMSC shall render full-time service for a term of four (4)
6 years, subject to reappointment to another term: *Provided,* That upon effectivity of this Act, the
7 incumbent President shall continue to serve until the expiration of the term of the original
8 appointment, and may be eligible for reappointment to another term of four (4) years.
9

10 The salary of the President of the AMSC shall be in accordance with Republic Act No.
11 11466 or the "Salary Standardization Law of 2019", and such other laws amendatory thereto,
12 which may hereinafter be enacted, and shall be comparable to that being received by the Presidents
13 of similar educational institutions.

15 **SEC. 3.** The provisions of Republic Act No. 8292, otherwise known as the "Higher
16 Education Modernization Act of 1997", shall form part of this Act.

18 **SEC. 4.** This Act shall take effect fifteen (15) days after its publication in the *Official*
19 *Gazette* or in a newspaper of general circulation.
