Submitted jointly by the Committees on Basic Education, Arts and Culture; and Finance on JAN 25 2022.

Re: House Bill No. 7770.

Recommending its approval with amendments, taking into consideration Senate Bill No. 2119.

Sponsor: Senator Win Gatchalian

MR. PRESIDENT:

The Committees on Basic Education, Arts and Culture; and Finance, to which were referred **House Bill No. 7770**, introduced by Representatives Mangaoang, Romulo and Yap (E.), entitled:

**"AN ACT
ESTABLISHING THE KALINGA HERITAGE MUSEUM AND
CULTURAL CENTER IN THE CITY OF TABUK, PROVINCE OF
KALINGA, DEFINING ITS PURPOSES AND OBJECTIVES, AND
APPROPRIATING FUNDS THEREFOR"**

and taking into consideration **Senate Bill No. 2119**, introduced by Senator Imee R. Marcos, entitled:

**"AN ACT
ESTABLISHING THE KALINGA HERITAGE MUSEUM AND
CULTURAL CENTER IN THE CITY OF TABUK, PROVINCE OF
KALINGA, DEFINING ITS PURPOSES AND OBJECTIVES, AND
APPROPRIATING FUNDS THEREFOR"**

have considered the same and have the honor to report it back to the Senate with the recommendation that House Bill No. 7770, taking into consideration Senate Bill No. 2119, be approved with the following amendments:

1. On page 1, on Section 1, lines 1 to 3, delete the first sentence and replace it with a new sentence to read as follows:

**"THERE IS HEREBY ESTABLISHED A CULTURAL CENTER AND
MUSEUM IN THE PROVINCE OF KALINGA, TO BE KNOWN AS THE
KALINGA CULTURAL CENTER AND MUSEUM TO PROMOTE CULTURE
AND THE ARTS."**

2. On the same page, line 3, after the phrase "for the", delete the word "collection" and replace it with the word "**PROTECTION**".
3. On the same page, line 4, delete the phrase "and enhancement" and replace it with the phrase "**PRESENTATION AND PROMOTION**".
4. Still on page 1, lines 8 to 12, delete the entire Section 2 and replace it with a new Section 2 to read as follows:

**"SEC. 2. THE KALINGA CULTURAL CENTER AND MUSEUM SHALL BE A
COLLABORATION BETWEEN THE PROVINCIAL GOVERNMENT OF
KALINGA AND THE NATIONAL COMMISSION FOR CULTURE AND THE**

ARTS (NCCA) WITH ITS CONCERNED AFFILIATED CULTURAL AGENCIES AND PERTINENT ACADEMIC AND PRIVATE SECTOR PARTNERS, AND MEMBERS OF THE COMMUNITY, WITH ITS SITE, STRUCTURES, GOVERNANCE, ORGANIZATION, OPERATIONS, AND DEVELOPMENT TO BE PROVIDED FOR BY MUTUAL AGREEMENT BETWEEN THE PARTIES, TO BE EXECUTED AND PUBLISHED WITHIN ONE (1) YEAR FROM THE EFFECTIVITY OF THIS ACT."

5. Still on the same page, on Section 3, lines 14 and 15, after the word "To", delete the phrase "implement its activities and functions, the Kalinga Heritage Museum and Cultural Center" and replace it with the phrase "**FULFILL ITS PURPOSES AND ACHIEVE ITS OBJECTIVES, THE KALINGA CULTURAL CENTER AND MUSEUM**".
6. On page 2, line 14, after the word "region", delete the period and replace it with a semi-colon (;).
7. On the same page, after line 14, insert new sub-paragraphs (h) and (i) to read as follows:

"H. CONDUCT PERFORMANCES ON KALINGA MUSIC, DANCES, ARTS, LITERARY WORKS, EPICS, STORIES, HISTORICAL ACCOUNTS AND LEGENDS; AND

I. CARRY OUT ANY OTHER RELEVANT AND APPROPRIATE ACTIVITIES."

8. On the same page, on Section 4, line 17, after the word "construction", delete the phrase "and establishment" and replace it with the phrase "**OR ESTABLISHMENT, OR BOTH,**".

9. On the same page, line 18, delete the name "Kalinga Heritage Museum and Cultural Center" and replace it with the name "**KALINGA CULTURAL CENTER AND MUSEUM**".
10. Still on page 2, on Section 5, line 21, delete the name "National Commission for Culture and the Arts" and replace it with the acronym "**NCCA**".
11. Still on the same page, on Section 6, line 26, after the preposition "with", insert the phrase "**THE PROVINCIAL GOVERNMENT OF KALINGA, OTHER**".
12. On the same page and line, after the word "government," insert the phrase "**AND PRIVATE STAKEHOLDERS,**".
13. Still on page 2, on Section 7, line 29, before the word "this", insert the phrase "**NOTWITHSTANDING THE NON-ISSUANCE OF THE IMPLEMENTING RULES AND REGULATIONS,**".
14. Finally, amend the title to read as follows:

**"AN ACT
ESTABLISHING THE KALINGA CULTURAL CENTER AND MUSEUM IN
THE PROVINCE OF KALINGA, DEFINING ITS PURPOSES AND
OBJECTIVES, AND APPROPRIATING FUNDS THEREFOR"**

HOUSE BILL NO. 7770
(In substitution of House Bill No. 593)

Introduced by Representatives Mangaoang, Romulo and Yap (E.)

AN ACT
ESTABLISHING THE KALINGA HERITAGE MUSEUM AND CULTURAL
CENTER IN THE CITY OF TABUK, PROVINCE OF KALINGA, DEFINING ITS
PURPOSES AND OBJECTIVES, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. There is hereby established a heritage museum and cultural center in
2 the City of Tabuk, Province of Kalinga, to be known as Kalinga Heritage Museum and
3 Cultural Center. It shall serve as the institutional medium for the collection, preservation,
4 and enhancement of the cultural, artistic, archaeological, social, historical, religious and
5 philosophical heritage of the Kalinga land and its people in view of the richness of their
6 legacies and of their relevance to their contemporary and future aspirations.

7
8 SEC. 2. The Kalinga Heritage Museum and Cultural Center shall be supervised by
9 the National Commission for Culture and the Arts (NCCA) and, in cooperation with
10 concerned public and private institutions with similar orientation or interest in its affairs, seek
11 technical assistance or obtain grants, endowments or donations in cash or in kind, to enable it
12 to carry out and discharge its duties and functions effectively.

14 SEC. 3. To implement its activities and functions, the Kalinga Heritage Museum and
15 Cultural Center shall:

17 a. Compile musical notes and lyrics of Kalinga traditional songs, ballads, and
18 contemporary music compositions, and collect samples of musical instruments of
19 Kalinga origin, design, and creation;

21 b. Publish and disseminate Kalinga literary works, epics, stories, and historical
22 accounts;
23
24 c. Compile Kalinga literature, film, or audio-visual recordings of cultural
25 performances in music, dance, oral literature, and festival celebration;

- 1 d. Compile Kalinga epigrams, proverbs, legends, and the origin and etymology of
2 Kalinga words, names of barangays, municipalities and other places of interests
3 and their respective histories;
4
5 c. Gather and document Kalinga religious practices and traditions, and the
6 background and origin of Kalinga fiestas and festivals;
7
8 f. Compile photographs of and showcase by appropriate exhibits, Kalinga
9 landmarks, historical sites and scenic views, and acquire and display varied range
10 of Kalinga arts and artifacts;
11
12 g. Gather specimens of archaeological findings, collect stones, rocks, and other
13 geological materials, and preserve by appropriate methods samples of flora and
14 fauna indigenous to the Kalinga region.
15

16 SEC. 4. The Provincial Government of Kalinga shall provide the land necessary for
17 the construction and establishment of the main venue and ancillary offices and facilities of
18 the Kalinga Heritage Museum and Cultural Center.
19

20 SEC. 5. The amount necessary for the implementation of this Act shall be charged
21 against the current year's budget of the National Commission for Culture and the Arts
22 (Proper). Thereafter, such amount as may be necessary for its continued implementation
23 shall be included in the annual General Appropriations Act.
24

25 SEC. 6. Within sixty (60) days from the effectivity of this Act, the NCCA, in
26 coordination with concerned agencies of the government, shall promulgate the necessary
27 rules and regulations for the effective implementation of this Act.
28

29 SEC. 7. This Act shall take effect fifteen (15) days after its publication in the *Official*
30 *Gazette* or in a newspaper of general circulation.
