

AN ACT
RENAMING THE MUNICIPALITY OF LISTA IN THE PROVINCE OF IFUGAO AS THE
MUNICIPALITY OF ALFONSO LISTA

*Be it enacted by the Senate and the House of Representatives of the
Philippines in Congress assembled:*

1 **SECTION 1.** The Municipality of Lista in the Province Ifugao is hereby
2 renamed as Alfonso Lista.

3 **SEC. 2.** The renaming of the Municipality of Lista shall be effective upon
4 ratification of the majority of the votes cast by qualified voters in a plebiscite to be
5 conducted and supervised by the Commission on Elections (COMELEC) in the
6 present Municipality of Lista in compliance with Section 13 (g) of Republic Act No.
7 7160, as amended, otherwise known as the "Local Government Code of 1991".

8 The expenses for such plebiscite shall be borne by the Municipality of Lista,
9 Province of Ifugao.

10 **SEC. 3.** This Act shall take effect fifteen (15) days after its publication in the
11 Official Gazette or in a newspaper of general circulation.
