BY REURESENTATIVES FUENTEBELLA AND TEVES (J.)

AN ACT RENAMING BARANGAY STA. MARIA IN THE MUNICIPALITY OF PRESENTACION, PROVINCE OF CAMARINES SUR AS BARANGAY PARUBCAN

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Barangay Sta. Maria in the Municipality of Presentacion, Province of Camarines Sur is hereby renamed as Barangay Parubean.

SECTION 2. The renaming of Barangay Sta. Maria as Barangay Parubcan shall be effective upon ratification of the majority of the votes cast by qualified voters in a plebiscite to be conducted and supervised by the Commission on Elections (COMELEC) in the present Barangay Sta. Maria in compliance with Section 13 (g) of Republic Act No. 7160, as attended, otherwise known as the Local Government Code of 1991.

The expenses for such plebiseite shall be borne by the Municipality of Presentacion, Camarines Sur.

SECTION 3. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
