AN ACT
CREATING A DISTRICT ENGINEERING OFFICE IN THE SECOND LEGISLATIVE
DISTRICT OF DAVAO CITY, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** A district engineering office of the Department of Public Works and
2 Highways is hereby created in the Second Legislative District of Davao City, to be located at the
3 DPWH Depot in Barangay Panacan, Davao City, and to be known as the Davao City Third
4 District Engineering Office.

6 **SEC. 2.** The Davao City Third District Engineering Office shall serve the barangays of
7 Agdao Proper; Paciano Bangoy; Centro; Kapt. T. Monteverde; Lapu-lapu; Leon Garcia, Sr.; R.
8 Castillo; San Antonio; Ubalde; V. Duterte; W. Aquino; Acacia; Buhangin Proper; Cabantian;
9 Callawa; Communal; Indangan; Mandug; Pampanga; A. Angliongto, Sr.; Hizon, Sr.; Sasa;
10 Tigatto; Waan; Bunawan Proper; Gatungan; Ilang; Lasang; Mahayag; Mudiang; Panacan; San
11 Isidro; Tibungco; Colosas; Fatima; Lumiad; Mabuhay; Malabog; Mapula; Panalum; Pandaitan;
12 Paquibato Proper; Paradise Embac; Salapawan; Sumimao and Tapak.

14 **SEC. 3.** The Secretary of Public Works and Highways shall include in the Department's
15 program the operationalization of the Davao City Third District Engineering Office, the funding
16 of which shall be included in the annual General Appropriations Act.

18 **SEC. 4.** This Act shall take effect fifteen (15) days after its publication in the *Official*
19 *Gazette* or in a newspaper of general circulation.
