CREATING A DISTRICT ENGINEERING OFFICE IN THE SECOND LEGISLATIVE DISTRICT OF THE PROVINCE OF AKLAN, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. There shall be established under the supervision of the Department of Public Works and Highways, a district engineering office for the Second Legislative District of the Province of Aklan. It shall be known as the Second District Engineering Office and shall be located in the Municipality of Ibajay, Province of Aklan.

SEC. 2. The Second District Engineering Office shall serve the municipalities of Buruanga, Ibajay, Lezo, Makato, Malay, Malinao, Nabas, Numancia, and Tangalan.

SEC. 3. The Secretary of Public Works and Highways shall include in the Department's program the operationalization of the Second District Engineering Office in the Province of Aklan, the funding of which shall be included in the annual General Appropriations Act.

13 SEC. 4. This Act shall take effect fifteen (15) days after its publication in the Official Gazette 14 or in a newspaper of general circulation.
