

AN ACT
RECONSTITUTING THE NUEVA VISCAYA DISTRICT ENGINEERING OFFICE IN
THE PROVINCE OF NUEVA VISCAYA INTO THREE SEPARATE DISTRICT
ENGINEERING OFFICES, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** The Nueva Viscaya District Engineering Office, under the supervision of
2 the Department of Public Works and Highways, shall be reconstituted into three (3) separate
3 district engineering offices to be named as Nueva Viscaya First, Second and Third District
4 Engineering Offices, respectively.

6 **SEC. 2.** The Nueva Viscaya First District Engineering Office shall serve the
7 municipalities of Solano, Bagabag, Diadi, Villaverde and Quezon. The Nueva Viscaya Second
8 District Engineering Office shall serve the municipalities of Aritao, Dupax del Norte, Dupax del
9 Sur, Sta. Fe, and Alfonso Castañeda. The Nueva Viscaya Third District Engineering Office shall
10 serve the municipalities of Bambang, Bayombong, Kasibu, Kayapa and Ambaguio.

12 **SEC. 3.** The Secretary of Public Works and Highways shall include in the Department's
13 program the operationalization of the three (3) district engineering offices, the funding of which
14 shall be included in the annual General Appropriations Act.

16 **SEC. 4.** This Act shall take effect fifteen (15) days after its publication in the Official
17 Gazette or in a newspaper of general circulation.
