



**AN ACT  
CREATING A DISTRICT ENGINEERING OFFICE IN THE ISLAND GARDEN CITY OF  
SAMAL, SECOND LEGISLATIVE DISTRICT OF THE PROVINCE OF DAVAO DEL NORTE,  
AND APPROPRIATING FUNDS THEREFOR**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           **SECTION 1.** A district engineering office of the Department of Public Works and Highways is  
2 hereby created in the Island Garden City of Samal (IGaCOS), Second Legislative District, Province of  
3 Davao Del Norte, which shall be referred to as the IGaCOS Second District Engineering Office.

5           **SEC. 2.** The IGaCOS Second District Engineering Office shall serve the cities of Panabo and  
6 Island Garden City of Samal and the municipalities of Dujali, Carmen and Santo Tomas, all located in  
7 the Province of Davao Del Norte.

9           **SEC. 3.** The Secretary of Public Works and Highways shall include in the Department's program  
10 the operationalization of the IGaCOS Second District Engineering Office, the funding of which shall be  
11 included in the annual General Appropriations Act.  
12

13           **SEC. 4.** This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or  
14 in a newspaper of general circulation.
