# AN ACT ESTABLISHING A FOUR (4) LANE VIADUCT OR BYPASS ROAD IN THE CITY OF SAN JOSE DEL MONTE, PROVINCE OF BULACAN, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. The Department of Public Works and Highways (DPWH) shall cause
the construction of a four (4) lane Viaduct or Bypass Road in the City of San Jose Del
Monte, Province of Bulacan which shall connect all existing major roads going in and
out of the City including all major roads which will be built in the near future.

5 SEC. 2. The amount necessary to defray the cost of undertaking and completing 6 the feasibility study and detailed engineering for this project and other activities related 7 thereto shall be included in the Annual General Appropriations Act (GAA). Thereafter, 8 the Secretary of the DPWH shall include in the Department's program the construction 9 of said road, the funding of which shall be included in the annual GAA.

SEC. 3. This Act shall take effect fifteen (15) days after its publication in the
Official Gazette or in a newspaper of general circulation.
