





AN ACT

PROVIDING FOR THE CONSTRUCTION OF A 240-KILOMETER TRANS-MINDANAO SUPERHIGHWAY CONNECTING FOUR PROVINCIAL CAPITALS IN THE CARAGA AND NORTHERN MINDANAO REGIONS TO THE LAGUINDINGAN INTERNATIONAL AIRPORT, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** The Department of Public Works and Highways (DPWH) shall construct a
2 two hundred forty-kilometer (240km) trans-Mindanao Superhighway connecting the Municipality
3 of Tandag in the Province of Surigao del Sur, to the Laguindingan International Airport. This
4 highway will traverse the Municipality of Prosperidad in the Province of Agusan del Sur, the
5 Municipalities of Malaybalay and Talakag, both in the Province of Bukidnon, and shall continue
6 through to the Talakag-Barangay Dansolihon highway and the Barangay Dansolihon-Barangay
7 San Simon-Laguindingan Airport highway in Cagayan de Oro City.

8 **SEC. 2.** The amount necessary to defray the cost of undertaking and completing the
9 feasibility study and detailed engineering design for this project and other activities related thereto
10 shall be included in the General Appropriations Act (GAA). Thereafter, the Secretary of DPWH
11 shall include in the Department's program the construction of said road, the funding of which shall
12 be included in the GAA.

13 **SEC. 3.** This Act shall take effect fifteen (15) days after its publication in the *Official*
14 *Gazette* or in a newspaper of general circulation.
