AN ACT

PROVIDING FOR THE CONSTRUCTION OF A NATIONAL HIGHWAY IN THE MUNICIPALITY OF BALO-I, PROVINCE OF LANAO DEL NORTE TO BE KNOWN AS THE BALO-I BYPASS ROAD AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled;

- SECTION 1. There shall be constructed, under the supervision of the Department of Public Works and Highways(DPWH), a national highway from Sitio Dumaguing, Brgy. East Poblacion to Sitio Dilimbayan, in the Municipality of Balo-I, to be known as the Balo-I Bypass Road.
- SEC. 2. The amount necessary to defray the cost of undertaking and completing the feasibility study and detailed engineering design for this project and other activities related thereto shall be included in the General Appropriations Act (GAA). Thereafter, the Secretary of DPWH shall include in the Department's program the construction of said road, the funding of which shall be included in the GAA.
- SEC. 3. This Act shall take effect fifteen (15)days after its publication in the Official Gazette or in a newspaper of general circulation.
