AN ACT

ESTABLISHING IN THE CITY OF ILOILO, PROVINCE OF ILOILO, A CITY HOSPITAL TO BE  
KNOWN AS THE ILOILO CITY HOSPITAL, AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress  
assembled:*

1           SECTION 1. There shall be established in the City of Iloilo, Province of Iloilo, a tertiary  
2 general hospital to be known as the Iloilo City Hospital (ICH), which shall be under the direct  
3 control and supervision of the City Government of Iloilo.  
4

5           SEC. 2. The City Government of Iloilo shall manage the ICH, and prepare, in consultation  
6 with the Department of Health, a hospital development plan aligned with the Philippine Health  
7 Facility Development Plan. Any future increase in bed capacity, healthcare facilities, service  
8 capability, and human resource complement shall be based on the hospital development plan.  
9

10          SEC. 3. The City Government of Iloilo shall provide the necessary funds for the  
11 establishment of the ICH. The Secretary of Health shall include in the Department's subsidy  
12 program, support for the capital outlay requirements of the said hospital.  
13

14          SEC. 4. If any provision or part of this Act is declared unconstitutional, the remaining parts  
15 or provisions not affected shall remain in full force and effect.  
16

17          SEC. 5. All laws, executive orders, issuances, rules and regulations inconsistent with this  
18 Act are hereby repealed or modified accordingly.  
19

20          SEC. 6. This Act shall take effect fifteen (15) days after its publication in the *Official Gazette*  
21 or in a newspaper of general circulation.
