AN ACT
ESTABLISHING IN THE MUNICIPALITY OF KALIBO, PROVINCE OF AKLAN, A
GERIATRIC MEDICAL CENTER TO BE KNOWN AS THE AKLAN GERIATRIC
MEDICAL CENTER, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** There shall be established in the Municipality of Kalibo, Province of
2 Aklan, a geriatric medical center to be known as the Aklan Geriatric Medical Center,
3 which shall be under the direct control and supervision of the Provincial Government of
4 Aklan.

5
6 **SEC. 2.** Any future increase in bed capacity, healthcare facilities, service
7 capability, and human resource complement shall be based on the hospital
8 development plan which shall be prepared by the Chief of Hospital in consultation with
9 the Department of Health (DOH).

10
11 **SEC. 3.** The Provincial Government of Aklan shall provide the necessary funds
12 for the establishment of the Aklan Geriatric Medical Center. The Secretary of Health
13 shall include in the Department's subsidy program, support for the capital outlay
14 requirements of the said hospital.

15
16 **SEC. 4.** If any provision or part of this Act is declared unconstitutional, the
17 remaining parts or provisions not affected shall remain in full force and effect.

18
19 **SEC. 5.** All laws, executive orders, issuances, rules and regulations, inconsistent
20 with this Act are hereby repealed or modified accordingly.

21
22 **SEC. 6.** This Act shall take effect fifteen (15) days after its publication in the
23 *Official Gazette* or in a newspaper of general circulation.
