AN ACT
ESTABLISHING IN THE CITY OF PANABO, PROVINCE OF DAVAO DEL NORTE, A
DISTRICT HOSPITAL TO BE KNOWN AS THE PANABO CITY DISTRICT HOSPITAL, AND
APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** There shall be established in the City of Panabo, Province of Davao del
2 Norte, a district hospital to be known as the Panabo City District Hospital, which shall be under
3 the direct control and supervision of the Provincial Government of Davao del Norte.

5 **SEC. 2.** The Provincial Government of Davao del Norte shall manage the Panabo City
6 District Hospital, and prepare, in consultation with the Department of Health (DOH), a hospital
7 development plan that is aligned with the Philippine Health Facility Development Plan. Any
8 future increase in bed capacity, healthcare facilities, service capability, and human resource
9 complement shall be based on the hospital development plan.

11 **SEC. 3.** The Provincial Government of Davao del Norte shall provide the necessary
12 funds for the establishment of the Panabo City District Hospital. The Secretary of the DOH shall
13 include in the Department's subsidy program, support for the capital outlay requirements of the
14 Panabo City District Hospital.

16 **SEC. 4.** If any provision or part of this Act is declared unconstitutional, the remaining
17 parts or provisions not affected shall remain in full force and effect.
18

19 **SEC. 5.** All laws, executive orders, issuances, rules and regulations, inconsistent with
20 this Act are hereby repealed or modified accordingly.
21

22 **SEC. 6.** This Act shall take effect fifteen (15) days after its publication in the *Official*
23 *Gazette* or in a newspaper of general circulation.
