AN ACT

INCREASING THE BED CAPACITY OF THE GOV. FAUSTINO N. DY, SR. MEMORIAL HOSPITAL IN THE CITY OF ILAGAN, PROVINCE OF ISABELA FROM ONE HUNDRED (100) TO FIVE HUNDRED (500) BEDS, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** The authorized bed capacity of the Gov. Faustino N. Dy, Sr.
2 Memorial Hospital in the City of Ilagan, Province of Isabela is hereby increased from
3 one hundred (100) to five hundred (500) beds. Any future increase in bed capacity shall
4 be consistent with its hospital development plan that shall be prepared by the Chief of
5 Hospital of the Gov. Faustino N. Dy, Sr. Memorial Hospital and submitted to the
6 Department of Health (DOH).

7
8 **SEC. 2.** The existing professional health care services and facilities of the Gov.
9 Faustino N. Dy, Sr. Memorial Hospital shall also be upgraded to conform with and be
10 commensurate to the bed capacity increase as provided for in Section 1 hereof.

12 **SEC. 3.** The existing workforce of the Gov. Faustino N. Dy, Sr. Memorial
13 Hospital, which includes doctors, nurses and support personnel, shall also be increased
14 correspondingly.

16 **SEC. 4.** The Provincial Government of Isabela shall provide the necessary funds
17 to cover the maintenance and other operating expenses of the Gov. Faustino N. Dy, Sr.
18 Memorial Hospital. It shall also appropriate funds for the additional human resource
19 complement to support the increase in bed capacity and the corresponding upgrading of
20 its service facilities and professional health care services.

1 **SEC. 5.** The Secretary of the DOH shall include in the Department's subsidy
2 program its support for the capital outlay requirements of the hospital.
3

4 **SEC. 6.** If any provision or part of this Act is declared unconstitutional, the
5 remaining parts or provisions not affected shall remain in full force and effect.
6

7 **SEC. 7.** All laws, executive orders, issuances, rules and regulations, inconsistent
8 with this Act are hereby repealed or modified accordingly.
9

10 **SEC. 8.** This Act shall take effect fifteen (15) days after its publication in the
11 *Official Gazette* or in a newspaper of general circulation.
