**AN ACT**  
**INCREASING THE BED CAPACITY OF THE UNAYAN MUNICIPAL HOSPITAL IN THE**  
**MUNICIPALITY OF BINIDAYAN, PROVINCE OF LANA DEL SUR, FROM TEN (10)**  
**TO FIFTY (50) BEDS, AND APPROPRIATING FUNDS THEREFOR**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1       **SECTION 1.** The authorized bed capacity of the Unayan Municipal Hospital in the  
2 Municipality of Binidayan, Province of Lanao Del Sur, is hereby increased from ten (10)  
3 to fifty (50) beds. Any future increase in bed capacity shall be consistent with the hospital  
4 development plan that shall be prepared by the Chief of Hospital of the Unayan Municipal  
5 Hospital and submitted to the Bangsamoro Autonomous Region in Muslim Mindanao –  
6 Ministry of Health.

8       **SEC. 2.** The existing professional health care services and facilities of the Unayan  
9 Municipal Hospital shall also be upgraded to conform with and be commensurate to the  
10 increase in bed capacity as provided for in Section 1 hereof.

11  
12       **SEC. 3.** The existing workforce of the Unayan Municipal Hospital, which includes  
13 doctors, nurses, and support personnel, shall be increased correspondingly.

14  
15       **SEC. 4.** The Bangsamoro Autonomous Government shall provide the necessary  
16 funds to cover the maintenance and other operating expenses of the Unayan Municipal  
17 Hospital. It shall also appropriate funds for the additional human resource complement to  
18 support the increase in bed capacity and the corresponding upgrading of its service  
19 facilities and professional health care services.

20  
21       **SEC. 5.** The Secretary of the DOH shall include in the Department's subsidy  
22 program, support for the capital outlay requirements of the Unayan Municipal Hospital.

1       **SEC. 6.** All laws, decrees, executive orders and rules and regulations contrary to  
2 or inconsistent with the provisions of this Act are hereby repealed or amended  
3 accordingly.

5       **SEC. 7.** This Act shall take effect fifteen (15) days after its publication in the *Official*  
6 *Gazette* or in a newspaper of general circulation.
