BY REPRESENTATIVES UMALI (A.) AND TAMBUNTING, PER COMMITTEE REPORT NO. 649

AN ACT
INCREASING THE BED CAPACITY OF THE ROXAS DISTRICT HOSPITAL IN THE MUNICIPALITY OF ROXAS, PROVINCE OF ORIENTAL MINDORO FROM FIFTY (50) TO ONE HUNDRED (100) BEDS, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** The bed capacity of the Roxas District Hospital (RDH) in the Municipality of
2 Roxas, Province of Oriental Mindoro is hereby increased from fifty (50) to one hundred (100)
3 beds. Any future increase in bed capacity shall be consistent with the hospital development plan
4 that shall be prepared by the Chief of Hospital of the RDH and submitted to the Department of
5 Health (DOH).

7 **SEC. 2.** The existing professional health care services and facilities of the RDH are
8 hereby upgraded to conform with and be commensurate to the increase in bed capacity as
9 provided for in Section 1 hereof.

11 **SEC. 3.** The existing workforce of the RDH, which includes doctors, nurses, and support
12 personnel, shall also be increased correspondingly.

14 **SEC. 4.** The Provincial Government of Oriental Mindoro shall provide the necessary
15 funds to cover the maintenance and other operating expenses of the RDH. It shall also
16 appropriate funds for the additional human resource complement to support the increase in bed
17 capacity and the corresponding upgrading of its service facilities and professional health care
18 services.

20 **SEC. 5.** The Secretary of the DOH shall include in the Department's subsidy program
21 support for the capital outlay requirements of the RDH.

23 **SEC. 6.** If any provision or part of this Act is declared unconstitutional, the remaining
24 parts or provisions not affected shall remain in full force and effect.
25

26 **SEC. 7.** All laws, executive orders, issuances, rules and regulations, inconsistent with
27 this Act are hereby repealed or modified accordingly.

29 **SEC. 8.** This Act shall take effect fifteen (15) days after its publication in the *Official*
30 *Gazette* or in a newspaper of general circulation.
