MR. PRESIDENT:

The Committees on Health and Demography, and Finance, to which were referred **House Bill No. 8197**, introduced by Representatives Balindong, Ebcas, and Adiong, entitled:

**"AN ACT
INCREASING THE BED CAPACITY OF THE DR. SERAPIO B.
MONTAÑER, JR. MEMORIAL HOSPITAL IN THE MUNICIPALITY
OF MALABANG, PROVINCE OF LANA O DEL SUR, AND
APPROPRIATING FUNDS THEREFOR"**

have considered the same and have the honor to report it back to the Senate with the recommendation that House Bill No. 8197, be approved with the following amendment:


1. On page 1, line 19, after the article "The", delete the phrase "Provincial Government of Lanao Del Sur" and replace it with "**BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO (BARMM)**".

Thus, SEC. 4, as amended, shall read as follows:

SEC. 4. The **BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO (BARMM)** shall provide the necessary funds for the maintenance and other operating expenses of the Dr. Serapio B. Montañer Jr. Memorial Hospital. It shall also appropriate funds for human resource complement to support the increase in bed capacity and the corresponding upgrading of its service facilities and professional health care services. The Secretary of Health shall include in the Department's subsidy program, support for the capital outlays of the said hospital.

AN ACT

INCREASING THE BED CAPACITY OF THE DR. SERAPIO B. MONTAÑER, JR. MEMORIAL HOSPITAL IN THE MUNICIPALITY OF MALABANG, PROVINCE OF LANA DEL SUR, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** The authorized bed capacity of the Dr. Serapio B. Montañer, Jr.
2 Memorial Hospital in the Municipality of Malabang, Province of Lanao Del Sur is hereby
3 increased from twenty-five (25) to one hundred (100) beds. Any future increase in bed
4 capacity shall be consistent with its hospital development plan which shall be prepared
5 by the Department of Health (DOH).

7 **SEC. 2.** The existing professional health care services and facilities of the Dr.
8 Serapio B. Montañer, Jr. Memorial Hospital are hereby upgraded to conform with and
9 be commensurate to the increase in its authorized bed capacity as provided for in
10 Section 1 hereof.

12 **SEC. 3.** The existing workforce of the Dr. Serapio B. Montañer, Jr. Memorial
13 Hospital shall be increased correspondingly. The Secretary of the DOH shall, after
14 consultation with the Chief of Hospital of the Serapio B. Montañer, Jr. Memorial
15 Hospital, and in coordination with the Secretary of the Department of Budget and
16 Management and the Commissioner of the Civil Service Commission, determine the
17 additional new positions to be created and filled up.

19 **SEC. 4.** The Provincial Government of Lanao Del Sur shall provide the
20 necessary funds for the maintenance and other operating expenses of the Dr. Serapio
21 B. Montañer Jr. Memorial Hospital. It shall also appropriate funds for human resource
22 complement to support the increase in bed capacity and the corresponding upgrading of
23 its service facilities and professional health care services. The Secretary of Health shall

1 include in the Department's subsidy program, support for the capital outlays of the said
2 hospital.

4 **SEC. 5.** If any provision or part of this Act is declared unconstitutional, the
5 remaining parts or provisions not affected shall remain in full force and effect.

6

7 **SEC. 6.** All laws, executive orders, issuances, rules and regulations, inconsistent
8 with this Act are hereby modified accordingly.

9

10 **SEC. 7.** This Act shall take effect fifteen (15) days after its publication in the
11 *Official Gazette* or in a newspaper of general circulation.
