
have considered the same and have the honor to report it back to the Senate with the recommendation that House Bill No. 9814 be approved with the following amendment:

**"SEC. 6. NATIONAL TAX ALLOTMENT SHARES. – BARANGAY BATUCAN SHALL BE ENTITLED TO AN ALLOTMENT DERIVED FROM NATIONAL TAXES PURSUANT TO SECTION 285 OF THE LOCAL GOVERNMENT CODE OF 1991, AS AMENDED."**





AN ACT

SEPARATING THE SITIO OF BATUCAN FROM BARANGAY DEL MONTE IN THE MUNICIPALITY OF TALACOGON, PROVINCE OF AGUSAN DEL SUR, AND CONSTITUTING IT INTO A DISTINCT AND INDEPENDENT BARANGAY TO BE KNOWN AS BARANGAY BATUCAN

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           **SECTION 1. *Creation of Barangay Batucan.*** – The sitio of Batucan is hereby separated  
2 from Barangay Del Monte in the Municipality of Talacogon, Province of Agusan del Sur and  
3 constituted as a distinct and independent barangay to be known as Barangay Batucan.

4           **SEC. 2. *Territorial Boundaries.*** – The territorial boundaries of Barangay Batucan are  
5 hereby described as follows:

1           **SEC. 3. Conduct and Supervision of Plebiscite.** – The plebiscite conducted and supervised  
2 by the Commission on Elections (COMELEC) pursuant to Provincial Ordinance No. 10, Series of  
3 1996 of the *Sangguniang Panlalawigan* of the Province of Agusan del Sur, which ratified the  
4 creation of Barangay Batucan as proclaimed by the Plebiscite Board of Canvassers on February  
5 28, 1998 shall serve as substantial compliance with the plebiscite requirement under Section 10  
6 of the Local Government Code of 1991, as amended.

7           **SEC. 4. Incumbent Barangay Officials.** – The incumbent elected barangay officials of  
8 Barangay Batucan shall continue to hold office until such time that their successors have been  
9 duly elected and qualified.

10           **SEC. 5. Public Infrastructure and Facilities.** – All public infrastructure and facilities  
11 existing therein at the time of the approval of this Act are hereby transferred without cost or  
12 compensation to and shall be administered by the new Barangay Batucan.

13           **SEC. 6. Internal Revenue Allotment Shares.** – Barangay Batucan shall be entitled to  
14 internal revenue allotment (IRA) shares pursuant to Section 285 of the Local Government Code  
15 of 1991, as amended.

16           **SEC. 7. Effectivity.** – This Act shall take effect fifteen (15) days after its publication in the  
17 *Official Gazette* or in a newspaper of general circulation.
