#### MANIFESTATION OF SENATE PRESIDENT ZUBIRI

Senate President Zubiri congratulated the team of senators headed by Senator Angara that went to the European Union to discuss the General Scheme of Preferences Plus (GSP+).

As to the delegation he headed that visited the French Parliament in Paris, Senate President Zubiri believed that the delegation was able to convey the message that the Philippines is back on track, as he invited the French government to reinvest in the country.

He also informed the Body that he had received feedback from the EU that it was about to sign a Free Trade Agreement (FTA) with Indonesia in two weeks and with Thailand, and that it had already drafted FTAs with Vietnam and Singapore, putting pressure on the Philippines. He noted the need to push the Department of Trade and Industry (DTI) and the Department of Foreign Affairs (DFA) to act on it and to urge the French Senate and other EU parliamentarians to consider an FTA with the Philippines, and to open up opportunities, particularly in the manufacturing and agriculture sectors.

#### MANIFESTATION OF SENATOR VILLANUEVA

Senator Villanueva stated that he would never forget the moment when the French Senate acknowledged the Philippine senators in its plenary session. He said he was grateful for being a part of the trip and he promised that the fruits of their labor would not be in vain.

In this connection, Senate President Zubiri recalled that in 2017, a delegation of senators headed by then-Senate President Pimentel visited the French Parliament; however, the delegation was not recognized in plenary because the Parliament was on recess. Nonetheless, he stated that the Philippine delegation had a successful meeting with its counterpart.

#### MANIFESTATION OF SENATE PRESIDENT PRO TEMPORE LEGARDA

Senator Legarda joined Senate President Zubiri in congratulating the various delegations that traveled to Thailand, the EU, France, and Vietnam. She recalled that during the 17<sup>th</sup> Congress, the Senate unanimously ratified the Partnership Cooperation Agreement (PCA), which was the legal framework that established the body that would negotiate the FTA. She explained that without the PCA, the working committee would not be able to meet early that year to establish the legal framework for an FTA.

She believed that the PCA, which was presented to the DFA, signed, and transmitted to the Senate in 2017, should have been presented to the latter in 2012 during the Aquino administration. She stated that the Body unanimously concurred in the PCA during the tenure of then-Senate President Pimentel when she was the chairperson of the Committee on Finance.

She asserted that it was critical that the Senate exert pressure and remind the new DTI Secretary, as head of the PCA body, to push for the enactment of an FTA, as ASEAN neighbors such as Indonesia and Vietnam, which share the same population, problems, and vulnerability as the Philippines, had already been granted FTAs. She stated that during the DTI's budget deliberations, she would inquire about the department's efforts, strides, and accomplishments to ensure that the country does not fall behind Indonesia, Singapore, and Vietnam in terms of the FTA.

She believed that it was timely to provide the Body with a thorough report on the various delegations that went on several missions during the break, as there are regions in the country under a state of calamity as a result of the recent typhoons. She informed the Body that President Marcos was scheduled to visit her province in Panay Region the next day, but she would be unable to join him because, as vice chairperson of the Committee on Finance, she would be attending the plenary session for the sponsorship of the General Appropriations Bill (GAB).

She then urged the Executive department to help all provinces and local communities, including Antique, where roads continued to be inaccessible and bridges had collapsed. She noted that Senate President Zubiri also stated on social media that Mindanao, particularly the BARMM, had been severely affected by the recent typhoons.

However, she commended the DPWH Regional Office, which had been working round the clock with little resources other than the Quick Response Fund, as well as the private sector, for their efforts in rebuilding the collapsed bridges.

In this regard, she stated that during the deliberations on the DPWH budget, she would ask the agency for an accurate and detailed report on the bridges affected by typhoon Paeng, an assessment and monitoring of the same, and a timetable for reconstruction, as there were available budgets of more than P15 billion from the OP, QRF, and NDRRMC Fund.

#### MANIFESTATION OF SENATE PRESIDENT ZUBIRI

Senate President Zubiri reminded Senator Marcos, chairperson of the Committee on Foreign Relations, about the Regional Comprehensive Economic Partnership (RCEP). He noted that the Philippines is the only ASEAN member country that has yet to ratify the treaty. He asked that the treaty be sponsored on the floor for the Body's consideration.

#### ACKNOWLEDGMENT OF THE PRESENCE OF GUESTS

At this juncture, Senate President Zubiri acknowledged the presence in the gallery of the members of the Senate Spouses Foundation, Inc. (SSFI) headed by Mrs. Audrey Zubiri.

He reminded the Body that the session would be suspended at six o'clock in the evening that day for the lighting of the lanterns outside the building. He stated that the SSFI had requested the presence of the senators, their staff, and the Senate Secretariat to join the activity.

#### SUSPENSION OF SESSION

Upon motion of Senator Villanueva, the session was suspended.

It was 3:39 p.m.

#### **RESUMPTION OF SESSION**

At 5:41 p.m., the session was resumed.

#### PRIVILEGE SPEECH OF SENATOR TULFO

Availing himself of the privilege hour, Senator Tulfo delivered the following speech:

May mga nagsasabi na tuwing nagsasalita ako, I make them uncomfortable. I tend to be harsh. But, I have come to learn in the years that I have been a broadcaster that discomfort drives changed. And that is why I stand before you today because it seems that we have become desensitized with regard to the plight of our laborers in the cases they file with the NLRC. Recently, there has been an increase in incidents of employees encountering difficulties in recovering their money claims or executing judgments that they fought so hard for.

Just last week, my attention was called regarding incidents involving cases that they brought before the NLRC. A heartbreaking example is the case of Tommy Flaviano at ang kanyang mga kasamahan na kahit nanalo na sila sa NLRC nahihirapan silang makasingil ng kanilang panalo. Nagsimula sila na bente sila na complainants at dahil sa tinagal at bagal ng proseso, siyam sa kanila ang namatay na. Labing-isa na lang ang natitira. Dinarasal ng natitirang 11 na ito na sana madatnan pa nila na sila ay mga buhay pa at matanggap ang kanilang ipinanalong pera. We will make sure that things like this should and will not ever happen again.

Ironically, the Constitution provides as a policy that "The State affirms labor as a primary social economic force. It shall protect the rights of workers and promote their welfare." But, if you go to the office of the NLRC and ask them if they feel that they are valued as a primary social economic force, I am quite sure they will either laugh at you or they will be clueless about what that means.

Indeed, the enforcement of rights through litigation is not the same for employers and employees. Iba ang pinagdadaanan ng abusadong employer at ng kaniyang kawawang manggagawa. Ang employer, 'pag nanalo, hindi mahirap para ipa-execute ang desisyon. Kadalasan, inaaprubahan lang ang pagtanggal ng empleyado. Pero pag nanalo ang empleyado, pahirapan. Parang treasure hunt ang paghahanap ng mananagot sa award ng korte.

Saan ba ang problema pagdating sa mga proseso sa NLRC? Based on interviews and research that we have conducted, the concerns arise at the very beginning when the parties go through the SENA, or Single-Entry Approach, where the parties appear before a mediation officer to possibly reach an amicable settlement. Even if these procedures provide that only the parties will attend, sometimes the employer-party sends their lawyer posing as their representatives to attend the conference. The employees are easily intimidated. I propose that only non-lawyers could represent parties before the SENA. Further, the SENA officers must be given guidelines by the NLRC on unreasonable settlements being proposed at the SENA level. The officers must be able to protect the employees against these kinds of agreements when their rights are really being violated.

When the parties do not reach a settlement before the SENA, they proceed to file the case before the labor arbiter. At this point, delays have been noted in the resolution of cases. During the hearing before the Committee on Labor, Employment and Human Resources Development before our staunch labor defender Sen. Jinggoy Estrada, the NLRC admitted that the delay has been caused by the delay in the filing and service of pleadings and processes. But I would like to point out that during the pandemic, the courts, and even the NLRC, have resorted to electronic filing. I implore that the NLRC institutionalize the use of this digital technology in its filing and service. The Supreme Court has provided sufficient guidelines when it comes to electronic filing and service. The NLRC could follow suit.

But the biggest problem our employees have is execution. Kumbaga, parati silang nganga matapos nila ilaban ang kaso nila. True, the rules of the NLRC provide for a cash bond and a surety bond. But the problem is the cash bond and surety bond only arise when the case is appealed from the labor arbiter to the NLRC. Most employers who want to evade the payment of money claims would stop fighting their cases with their employees at the labor arbiter level. Because if they appeal to the Commission, they would have to file a cash bond or surety bond equivalent to the award. Thus, it is easier to simply hide. Taguan na ng mga ari-arian.

We have to do something about this because the rights that we provide in our laws become useless when the employees could not enforce them in the end; hence, resulting in just paper victory. Nagpagod lang ang kawawang empleyado.

I will file a proposal to provide a way to garnish the properties of the employers at the labor arbiter level. This will ensure that even while the case is pending, the employees will have something to run after to answer for a favorable judgment. And during execution, it seems that the sheriffs are always at a loss in running after corporate employers who either close down or empty the coffers of the corporate entity to avoid paying the judgment award. It is difficult to have to prove the piercing of corporate entities in executing judgments. I propose that if the employer-party fails to appear during the execution conference of labor money claims and could not provide for the settlement of the judgment claims, there would be a presumption that the piercing doctrine will apply and the officers and directors will be solitarily liable for the judgment award.

We provide our laborers with so much benefits, but when it is violated and we do not ensure its enforcement, our work here in the legislature becomes useless. I would like to end my speech with a quote from social activist Bryan Stevenson. He said that: "The opposite of poverty is not wealth; the opposite of poverty is justice." Social justice mandates us to give our less fortunate laborers a fighting chance with the laws that we implement. *Hindi basta bigay lang tayo nang bigay ng karapatan at benepisyo. Kailangan siguraduhin natin na ang mga ito ay maipapatupad.*

#### **COMMITTEE REPORT NO. 3**

(Continuation)

Upon motion of Senator Villanueva, there being no objection, the Body resumed consideration of Committee Report No. 3 Re: PRIVILEGE SPEECH OF SENATE PRESIDENT JUAN MIGUEL "MIGZ" ZUBIRI, ENTITLED "FIASCO SUGAR ORDER NO. 4," delivered on August 15, 2022.

Senator Villanueva stated that the parliamentary status was still the period of interpellations.

Thereupon, the Chair recognized Senator Tolentino, sponsor of the measure.

#### TERMINATION OF THE PERIOD OF INTERPELLATIONS

There being no further interpellation, upon motion of Senator Villanueva, there being no objection, the Body closed the period of interpellations and proceeded to the period of committee amendments.

#### **COMMITTEE AMENDMENTS**

As submitted by Senator Tolentino, there being no objection, the Body approved the following committee amendments, one after the other:

1. On page 36, delete the paragraphs starting on line 15 to line 3 of page 37, and replace them with the following paragraphs:

**SEN. PIMENTEL.** CORRECT, SIR. KAYA NGA GANITO. IF YOU GO BACK TO THE BASIC ECONOMICS PRINCIPLE OF SUPPLY AND DEMAND, ARE YOU TELLING THIS COMMITTEE THAT THE P70 PER KILO IS AN ARTIFICIAL PRICE?

#### MR. LOBREGAT. YES.

**SEN. PIMENTEL.** SO, SOMEBODY IS ABSORBING A LOSS WHEN IT SELLS AT P70 PER KILO.

**MR. LOBREGAT.** NOT NECESSARILY A LOSS; AN OPPORTUNITY TO MAKE MORE MONEY.

**SEN. PIMENTEL.** IYON, PRECISELY AN OPPORTUNITY TO MAKE MORE MONEY. SO, AT P110 PER KILO, WHO IS HAVING THIS OPPORTUNITY TO MAKE A LOT OF MONEY?

MR. LOBREGAT. MR. SENATOR, I DO NOT WANT TO ACCUSE.

ELABORATING FURTHER ON A QUESTION OF SENATOR PIMENTEL AS TO WHO IS HAVING THE OPPORTUNITY TO MAKE MORE MONEY, MR. LOBREGAT RESPONDED, TO WIT:

MR. LOBREGAT. MR. SENATOR, I JUST WANT TO MAKE A STATEMENT THAT THE SUGAR INDUSTRY IS THE MOST ORGANIZED AGRICULTURAL PRODUCT IN THE COUNTRY. WE DID NOT WANT THESE HIGH PRICES AND THIS IS WHY WE WERE PUSHING FOR IMPORTATION WHEN WE SAW THAT THERE WAS A NEED TO BALANCE THE SUPPLY AND DEMAND **REQUIREMENT. BUT THERE WERE MANY OTHER THINGS THAT PREVENTED** THIS. THAT WAS EXPLAINED VERY CLEARLY IN MY CONGRESSIONAL PRESENTATION, WHICH I THINK WE GAVE-IT'S ON YOUTUBE, BUT WE ALSO GAVE THIS TO THE SENATE. IT IS A VERY SHORT EXPLANATION, VERY SIMPLE TO UNDERSTAND. AND I CALLED IT "THE PERFECT STORM." WE GOT HIT BY A STORM WHICH PARALYZED NEGROS MOMENTARILY BUT IT DID HAVE LINGERING EFFECTS ON REFINED SUGAR PRODUCTION. THEN AN IMPORTATION PROGRAM WAS DELAYED. SUGAR ORDER NO. 3 WAS DELAYED BY A TRO. THE ELECTIONS HAPPENED, THERE WAS PARALYSIS IN THE GOVERNMENT FOR A WHILE-I MEAN "PARALYSIS", IN QUOTATION-UNTIL THE NEW ADMINISTRATION TOOK OVER. AND THIS IS WHY PRICES WERE ALARMINGLY HIGH. AND WE WERE TRYING TO STOP THIS BY BRINGING IN AN IMPORTATION PROGRAM. WE WERE SAYING FROM THE VERY BEGINNING, THERE IS GOING TO BE A BIG DEFICIT. AND IF IT IS NOT CORRECTED, THEN PRICES ARE JUST GOING TO GO UP BECAUSE WHEN THERE IS A BIG DEMAND AND THERE IS A VERY SMALL SUPPLY-IF I GAVE FIVE PIECES OF SUGAR TO SELL AND ONCE ONE STARTS BIDDING, A BUYER STARTS OUTBIDDING THE OTHER, WHAT AM I GOING TO DO, RIGHT? I WILL SELL IT TO THE HIGHEST BIDDER. HERE, I HAVE NO ONE. WHO WANTS IT?;

- 2. On page 57, line 1, insert the following sentence: EXCEPT FOR THOSE IN THE MILITARY AND UNIFORMED PERSONNEL SERVICES, THOSE DESIGNATED AS OFFICER IN CHARGE IN ALL GOVERNMENT AGENCIES, INCLUDING GOVERNMENT-OWNED AND -CONTROLLED CORPORATIONS, SHALL HAVE A LIMITED NON-EXTENDIBLE TENURE OF NOT MORE THAN SIXTY (60) DAYS.
- 3. On page 75, delete lines 5 to 11 and replace it with the following sentence: LET A COPY OF THIS COMMITTEE REPORT BE FURNISHED THE DEPARTMENT OF JUSTICE, THE COMMISSION ON AUDIT, THE OFFICE OF THE OMBUDSMAN, AND THE BUREAU OF IMMIGRATION AND DEPORTATION FOR THEIR INFORMATION AND APPRO-PRIATE ACTION, INCLUDING BUT LIMITED TO THE CONDUCT OF NECESSARY PRELIMINARY INVESTIGATION, SECTORAL PERFORMANCE AUDIT, AND THE POSSIBLE ISSUANCE OF IMMIGRATION LOOKOUT BULLETIN AGAINST THE RESPONDENTS, IF THE CASE WARRANTS; and
- 4. On the same page, after line 11, insert the following sentence: THE MINORITY VIEW OR THE MINORITY REPORT SHALL BE APPENDED AND MADE PART OF THE COMMITTEE REPORT FOR PURPOSES OF TRANSMITTAL TO OTHER GOVERNMENT AGENCIES AND TO THE PUBLIC.

#### TERMINATION OF THE PERIOD OF COMMITTEE AMENDMENTS

There being no further committee amendment, upon motion of Senator Villanueva, there being no objection, the Body closed the period of committee amendments and proceeded to the period of individual amendments.

#### MANIFESTATION OF SENATOR PIMENTEL

Senator Pimentel manifested that the members of the Minority would no longer be proposing individual amendments since the Minority report that they have filed, which was already appended to the committee report, would already suffice.

#### TERMINATION OF THE PERIOD OF INDIVIDUAL AMENDMENTS

There being no other individual amendment, upon motion of Senator Villanueva, there being no objection, the Body closed the period of individual amendments.

#### APPROVAL OF COMMITTEE REPORT NO. 3 AND ITS RECOMMENDATIONS

Upon motion of Senator Villanueva, there being no objection. Committee Report No. 3, as well as the recommendations contained therein, was approved by the Body.

#### MANIFESTATION OF SENATOR VILLANUEVA

Senator Villanueva congratulated Senator Tolentino for his hard work as the chairperson of the Committee on Accountability of Public Officers and Investigations.

Senate President Zubiri also praised Senator Tolentino for obtaining his third Master of Laws degree from Columbia University.

#### MANIFESTATION OF SENATE PRESIDENT ZUBIRI

Senate President Zubiri requested the Members of the Senate to attend the "Light a Lantern" Ceremony at the Senate grounds to start the Christmas festivities. He said that Jose Mari Chan would be singing during the ceremony.
