AN ACT

**DECLARING TORRIJOS WHITE BEACH LOCATED IN THE MUNICIPALITY OF TORRIJOS, PROVINCE OF MARINDUQUE, A TOURISM DESTINATION**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

- 1           **SECTION 1. *Torrijos White Beach as Tourism Destination.*** – The Torrijos White  
2 Beach located in the Municipality of Torrijos, Province of Marinduque, is hereby declared a  
3 tourism destination. Pursuant thereto, its development shall be prioritized and supported by  
4 the Department of Tourism (DOT), subject to the rules and regulations governing the  
5 development of tourism destinations.

1           **SEC. 2. *Tourism Development Plan.*** – Within one (1) year after the approval of this  
2 Act, the municipal government of Torrijos shall, in coordination with the DOT, Department of  
3 Environment and Natural Resources (DENR), the Representative of the Lone District of  
4 Marinduque and concerned agencies of the government, prepare a tourism development plan  
5 that shall include the construction, installation and maintenance of such appropriate  
6 infrastructure and facilities to enhance tourism in the area: *Provided*, That said development  
7 plan shall ensure the preservation and conservation of the natural beauty and resources of the  
8 area: *Provided, further*, That the implementation of the tourism development plan shall be  
9 included in the budget of the municipal government of Torrijos.,

10           **SEC. 3. *Torrijos White Beach Tourism Governing Board.*** – The Torrijos White  
11 Beach Tourism Governing Board, hereinafter referred to as the Board, is hereby created. It  
12 shall be composed of the following members:

- 13           (a) Mayor of the Municipality of Torrijos, as Chairperson;
- 14           (b) Secretary of the DOT, or a duly authorized representative;
- 15           (c) Secretary of the DENR, or a duly authorized representative;
- 16           (d) Representative of the Lone District of Marinduque, or a duly authorized  
17           representative;
- 18           (e) Representative from an accredited non-government organization whose advocacy  
19           is environmental preservation;
- 20           (f) Representative from the academe; and
- 21           (g) Representative from the business sector.

22           The Board shall, in coordination with the DOT and concerned agencies of the  
23 government, promulgate rules and regulations to implement this Act; and shall, whenever  
24 necessary, amend, modify or revise such rules and regulations to meet existing needs.

1           The municipal government of Torrijos shall provide a Secretariat for the Board  
2 including the funding necessary to cover expenses for the performance of its official functions  
3 and activities.

4           **SEC. 4. *Role of the DOT.*** – The DOT shall assist the municipal government of Torrijos  
5 in the implementation of the tourism development plan by providing technical assistance in  
6 tourism capacity building. It shall also include Torrijos White Beach in its national and regional  
7 promotion programs.

8           **SEC. 5. *Appropriations.*** – The funding for the implementation of this Act shall be  
9 included in the annual budget of the municipal government of Torrijos. The DOT may augment  
10 such allocation with internally-generated funds.

11           **SEC. 6. *Separability Clause.*** – If any provision of this Act shall be declared  
12 unconstitutional or invalid, the other provisions not affected thereby shall remain in full force  
13 and effect.

14           **SEC. 7. *Repealing Clause.*** – All laws, rules, regulations, presidential decrees and other  
15 issuances inconsistent with any of the provisions of this Act are hereby deemed repealed or  
16 amended accordingly.

17           **SEC. 8. *Effectivity.*** – This Act shall take effect fifteen (15) days after its publication in  
18 the *Official Gazette* or in a newspaper of general circulation.
