Recommending the approval of House Bill No. 4635, with amendments.

Sponsor: Senator Francis G. Escudero

**MR. PRESIDENT:**

The Committee on Higher, Technical and Vocational Education to which was referred **House Bill No. 4635**, introduced by Representatives Adiong, Balindong, Go (M.) and Mariano-Hernandez, entitled:

**"AN ACT**

**EXTENDING THE TERM OF OFFICE OF THE PRESIDENT OF THE ADIONG MEMORIAL STATE COLLEGE FROM THREE (3) YEARS TO FOUR (4) YEARS IN ACCORDANCE WITH REPUBLIC ACT NO. 8292, OTHERWISE KNOWN AS THE "HIGHER EDUCATION MODERNIZATION ACT OF 1997", AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 8651, AS AMENDED, AND APPROPRIATING FUNDS THEREFOR"**

has considered the same and has the honor to report it back to the Senate with the recommendation that House Bill No. 4635, be approved with the following amendments:

1. Page 1, Section 1, lines 1 to 10, is amended to read as follows:

"SECTION 1. Section 9 of **REPUBLIC ACT NO. 7935, AS AMENDED BY** Republic Act No. 8651, is hereby **FURTHER** amended to read as follows:

"SEC. 9. The State College shall be headed by a president WHO SHALL RENDER FULL-TIME SERVICE. THE PRESIDENT SHALL [to] be appointed by the Board, [of Trustees] subject to [a selection process] **ITS** GUIDELINES, QUALIFICATIONS, AND STANDARDS [SET BY THE BOARD,] **AND UPON THE** RECOMMENDATION OF [A] **ITS** DULY CONSTITUTED SEARCH COMMITTEE, [and] [shall] [hold office for] **FOR** [SERVE] a term of [three (3)] **FOUR (4)** years, [AND SHALL BE] ELIGIBLE [renewable] for REAPPOINTMENT FOR another [three (3) years] TERM.

xxx."

2. Finally, amend the title of the Bill, which shall now read as follows:

**"AN ACT**



AN ACT

EXTENDING THE TERM OF OFFICE OF THE PRESIDENT OF THE ADRIANO MEMORIAL STATE COLLEGE FROM THREE (3) YEARS TO FOUR (4) YEARS IN ACCORDANCE WITH REPUBLIC ACT NO. 8292, OTHERWISE KNOWN AS THE "HIGHER EDUCATION MODERNIZATION ACT OF 1997", AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 8651, AS AMENDED, AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled*

1 SECTION 1. Section 9 of Republic Act No. 8651 is hereby amended to read as follows:

3 "SEC. 9. The State College shall be headed by a president WHO SHALL  
4 RENDER FULL-TIME SERVICE. THE PRESIDENT SHALL [to] be appointed by  
5 the Board, [of Trustees] subject to [a selection process] GUIDELINES,  
6 QUALIFICATIONS, AND STANDARDS SET BY THE BOARD, UPON  
7 RECOMMENDATION OF A DULY CONSTITUTED SEARCH COMMITTEE,  
8 [and] shall [hold office for] SERVE a term of [three (3)] FOUR years, AND SHALL  
9 BE ELIGIBLE [renewable] for REAPPOINTMENT FOR another [three (3) years]

14 SEC. 2. The Governing Board of the State College, in consultation with the Commission  
15 on Higher Education, shall formulate the guidelines to fully implement the provisions of this Act  
16 within ninety (90) days from its effectivity.

18 SEC. 3. The provisions of Republic Act No. 8292, otherwise known as the "Higher  
19 Education Modernization Act of 1997" shall form part of this Act.
