CONVERTING THE MUNICIPALITY OF BAYAMBANG INTO A COMPONENT CITY OF THE PROVINCE OF PANGASINAN TO BE KNOWN AS THE CITY OF BAYAMBANG

EXPLANATORY NOTE

Bayambang is located in Southern Pangasinan, along the banks of the Agno River, and is bounded on the north by the municipality of Malasiqui, on the south by the municipality of Camiling in Tarlac, on the east by the municipality of Bautista, and on the west by the municipality of Urbiztondo. The Municipality of Bayambang has 77 Barangays and ranks among the top five most populated localities in the Province of Pangasinan, alongside the cities of San Carlos, Urdaneta, and Dagupan.

Bamyambang served as the Fifth Capital and Final Seat of the short-lived First Philippine Republic. During the Japanese occupation, Bayambang also served as the provincial capital. During the Philippine Revolution, Bayambang was one of the first towns to be subjected to the "Juez de Cuchillo," or the total annihilation of Filipino inhabitants in declared zones within uprising areas.

The town served as the UNESCO National Community Training Center's first pilot town in the Far East, making Bayambang into a showcase for education. To date, it remains not just the "*cornbelt of Pangasinan*" and "*the onion capital of Pangasinan*," but also a bustling university town. The St. Vincent Ferrer Catholic Church and Convent, town plaza, Mangabul Lake in Brgy. San Gabriel II, Tanolong Underground Church, and Geo-Farm in Brgy. Mangayao are some of the town's places of attraction with potential for tourism investment. This bill seeks to convert the first class Municipality of Bayambang, in the southern part of Central Pangasinan, into a component city of the Province of Pangasinan. This will promote inclusive growth by enabling qualified municipalities outside of metropolitan areas to participate in attracting investments, tourists, and commerce to spread development throughout the country. This is also in line with the United Nations (UN) Sustainable Development Goals, one of which is to *"make cities and human settlements inclusive, safe, resilient, and sustainable."* Hence, Cityhood will empower the Municipality of Bayambang.

For the foregoing reasons, the immediate passage of this bill is earnestly sought.

AN ACT

CONVERTING THE MUNICIPALITY OF BAYAMBANG INTO A COMPONENT CITY OF THE PROVINCE OF PANGASINAN TO BE KNOWN AS THE CITY OF BAYAMBANG

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** *Title.* – This Act shall be known as the "Charter of the City of Bayambang".

3 SECTION 2. The City of Bayambang. – The Municipality of Bayambang shall be
 4 converted into a component city to be known as the City of Bayambang, hereinafter
 5 referred to as City.

SECTION 3. *Territorial Boundary of the City of Bayambang.* – The City of Bayambang shall comprise the present jurisdiction of the Municipality of Bayambang in the Province of Pangasinan over which it has jurisdiction. The territorial jurisdiction of the City shall be within the present metes and bounds of the Municipality of Bayambang containing an area of 16,800 hectares or about 3.082% of the land area of the Pangasinan Province, as per approved cadastral survey.

Bayambang is located in the south (east, west, north or south?) portion of Pangasinan Province at geographical coordinates between 120°25'E and 120°30'E ° Iongitude and between 15°45' N ° and 15°50'N ° latitude. It is bounded on the north by Malasiqui and Basista; on the south by the Province of Tarlac particularly the Municipality of Camiling, on the east by Bautista and Alcala and on the west by the Municipalities of Urbiztondo and Mangatarem.

1 The foregoing provision shall be without prejudice to the resolution by the 2 appropriate agency or forum of existing boundary disputed or cases involving questions 3 of territorial jurisdiction between the City of Bayambang and the adjoining local 4 government units.

5 **SECTION 4.** *Corporate Powers of the City.* – The City constituted a political 6 body corporate and as such is endowed with the attributes of perpetual succession and 7 possessed of the powers, which pertain to Municipal Corporation to be exercised in 8 conformity with the provision of this Charter. The City shall have the following corporate 9 powers:

- 10 (a) To have a continuous succession in its corporate name;
- 11 (b) To sue and be sued;
- 12 (c) To have and use a corporate seal;
- 13 (d) To acquire, hold and convey real or personal property;
- 14 (e) To enter into any contracts and/or agreements; and
- 15 (f) To exercise such other powers, prerogatives or authority subject to the 16 limitations provided in this Act or laws.

SECTION 5. General Powers of the City - The city shall have a common 17 seal and may alter the same at pleasure. It shall exercise the powers to levy taxes; to 18 close and open roads, streets, alleys, parks or squares; to take, purchase, receive, hold, 19 lease, convey and dispose of real and personal property for the general interests of the 20 21 City; to appropriate or condemn private property for public use; to contact and be contracted with, to sue and be sued; to prosecute and defend to final judgment and 22 execution suits wherein the City is involved or interested in and to exercise all the 23 24 powers as are granted to corporations or as hereinafter conferred.

25 **SECTION 6.** *Liability for Damages.* – The City and its officials shall not be 26 exempt from liability for death or injury to persons or damage to property.

SECTION 7. *Jurisdiction of the City.* – The jurisdiction of the City of Bayambang for police purposes only, shall be coextensive with its territorial jurisdiction and for the purpose of protecting and ensuring the purity of the water supply of the City such police jurisdiction shall also extend over all the territory within the drainage area of such water supply, or within one hundred meters (100 m.) of any reservoir, conduit, canal, aqueduct or pumping station used in connection with the city water service.

The city court of the City of Bayambang shall have concurrent jurisdiction with 1 the city or municipal trial courts of the adjoining municipalities to try crimes and 2 misdemeanor committed within the said drainage area, or within said spaces of one 3 hundred meters (100 m.). The court first taking jurisdiction of such offense shall 4 thereafter retain exclusive jurisdiction thereof. The police force of several municipalities 5 concerned shall have concurrent jurisdiction with the police force of the City for the 6 maintenance of good order and the enforcement of ordinances throughout said zone, 7 area and spaces. But any license that may be issued within said zone, area or spaces 8 shall be granted by the proper authorities of the city or municipality concerned, and 9 the fees arising therefrom shall accrue to the treasury of the said city or municipality. 10

ARTICLE II CITY OFFICIALS IN GENERAL

SECTION 8. The Officials of the City of Bayambang. - (a) There shall be 11 in the City: a city mayor, a city vice mayor, sangguniang panlungsod members, a 12 secretary to the sangguniang panlungsod, a city treasurer and an assistant city 13 treasurer, a city assessor and an assistant city of assessor, a city accountant, a city 14 budget officer, a city planning and development coordinator, a city engineer, a city 15 health officer, a city civil registrar, a city administrator, a city legal officer, a city 16 veterinarian, a city social welfare and development officer, a city general services 17 officer; a city agriculturist, a city environment and natural resources officer, a city 18 information and communications technology officer, and a city population officer; 19

20 (b) In addition, thereto, the city mayor may appoint a city architect, and a 21 city cooperative development officer;

(c) The City shall establish a city fire station to be headed by a city fire
 marshal, a city jail to be headed by a city jail warden, a city school division to be headed
 by a city school division superintendent; and

- 25 (d) The City of Bayambang may:
- 26 (1) Maintain existing offices not mentioned in subsections (a) and (b) thereof;
- (2) Create such other offices as may be necessary to carry out the purposes
 of the city government; or
- (3) Consolidate the functions of any office with those of another in theinterest of efficiency and economy,

Unless otherwise provided herein, heads of departments and offices shall be appointed by the city mayor with the concurrence of the majority of all the sangguniang panlungsod members, subject to civil service law, rules and regulations. The 1 sangguniang panlungsod shall act on the appointment within fifteen (15) days from the

2 day of its submission, otherwise the same shall be deemed confirmed.

ARTICLE III THE CITY MAYOR AND VICE MAYOR

3 SECTION 9. The City Mayor. – (a) The city mayor shall be the chief executive
 4 of the City. He shall be elected at large by the qualified voters of the City.

5 No person shall be eligible for the position of city mayor unless at the time of 6 the election:

- 7 (1) He is at least twenty-one (21) years of age;
- 8 (2) An actual resident of the City for at least one (1) year prior to his election;
 9 and
- 10 (3) A qualified voter therein.

He shall hold office for three (3) years, unless sooner removed, and shall receive a minimum monthly compensation corresponding to Salary Grade Thirty (30) as prescribed under Republic Act No. 6758 and the implementing guidelines issued pursuant thereto.

15 (b) The city mayor, as the chief executive of the city government shall 16 exercise such powers and perform such duties and functions as provided by the Local 17 Government Code of 1991 and other laws:

- 18 (1) Exercise those powers expressly granted to him by law, 19 those necessarily implied therefrom, as well as powers necessary, 20 appropriate, or incidental for the efficient and effective governance 21 of the City and those which are essential to the promotion of 22 general welfare:

SECTION 10. *The City Vice-Mayor*. – (a) There shall be a vice mayor who shall be elected in the same manner as the city mayor shall at the time of his election possess the same qualifications as the city mayor. He shall hold office for three (3) years, unless sooner removed, and shall receive a monthly compensation corresponding to salary grade twenty-six (26) as prescribed under Republic Act No. 6758 and the implementing guidelines issued pursuant thereto.

- 26 (b) The City vice mayor shall exercise the following duties:
- (1) Act as presiding officer of the sangguniang panlungsod and sign all
 warrants drawn on the city treasury for all expenditures appropriated for
 the operation of the sangguniang panlungsod;
- (2) Subject to civil service law, rules and regulations, appoint all officials and
 employees of the sangguniang panlungsod, except those whose manner
 of appointments is specifically provided for under existing laws;
- (3) Assume the office of the city mayor for the unexpired term of the latter
 in the event of permanent vacancy;

 (4) Exercise the powers and perform the duties and functions of the city mayor in cases of temporary vacancy; and
 (5) Perform such other duties and functions and exercise such other powers as provided for under Republic Act No. 7160, otherwise known as the Local Government Code of 1991 and those that are prescribed by law or ordinance.

ARTICLE IV THE SANGGUNIANG PANLUNGSOD

SECTION 11. The Sangguniang Panlungsod. – The sangguniang
 panlungsod, the legislative body of the City, shall be composed of the city vice mayor
 as presiding officer, the regular sanggunian members, the president of the city chapter
 of the liga ng mga barangay, the president of the panlungsod na pederasyon ng mga
 sangguniang kabataan and the sectoral representatives, as members.

(a) In addition thereto, there shall be three (3) sectoral representatives; one (1) from the women; and shall be determined by the sangguniang panlungsod within ninety (90) days prior to the holding of the local elections, one (1) from the agricultural or industrial workers; and one (1) from the others sectors, including the urban poor, indigenous cultural communities or disabled persons.

(b) The regular members of the sangguniang panlungsod and the sectoral representatives shall be elected in the manner as may be provided for by law. The elective members of the sangguniang panlungsod shall possess the same qualifications as that of the city mayor and city vice mayor except that candidates for said position must be at least eighteen (18) years of age on election day.

(c) They shall receive a minimum monthly compensation corresponding to
 Salary Grade Twenty-five (25) as prescribed under the Salary Standardization Law and
 the implementing guidelines issued pursuant thereto, and such other compensation,
 emoluments and allowances as may be determined by law.

ARTICLE V PROCESS OF LEGISLATION

SECTION 12. Internal Rules of Procedure. – (a) On the first regular
 session following the election of its members and within ninety (90) days thereafter,
 the sangguniang panlungsod shall adopt or update its existing rules of procedure.

4 (b) The rules of procedures shall provide for the following:

(1) The organization of the sanggunian and the election of its officers as 5 well as the creation of standing committees which shall include, but shall 6 not be limited to, the committees on appropriations, revenues, 7 engineering and public works, education and health, women and family, 8 human rights, youth and sports development, environmental protection, 9 peace and order and traffic, and cooperatives; the general jurisdiction 10 of each committee; and the election of the chairman and members of 11 each committee; 12

- 13 (2) The order and calendar of business for each session;
- 14 (3) The legislative process;
- 15 (4) The parliamentary procedures which include the conduct of members16 during sessions;
- (5) The discipline of members for disorderly behavior and absences without 17 justifiable cause for four (4) consecutive sessions for which they may be 18 censured, reprimanded, or excluded from the session, suspended for not 19 more than sixty (60) days, or expelled: Provided, That the penalty of 20 suspension or expulsion shall require the concurrence of at least two-21 thirds (2/3) vote of all the sangguniang members: Provided, further, 22 That the member convicted by final judgment to imprisonment of at 23 least one (1) year for any crime involving moral turpitude shall be 24 automatically expelled from the sanggunian; and 25
- 26 (6) Such other rules as the sanggunian may adopt.

SECTION 13. Full Disclosure of Financial and Business Interest of Sangguniang Panlungsod Members. – (a) Every sangguniang panlungsod member shall, upon assumption to office, make a full disclosure of his business and financial interests. He shall also disclose any business, financial, professional relationship or any relation by affinity or consanguinity within the fourth civil degree, which he may have with any person, firm or entity affected by any ordinance or resolution under 1 consideration by the sanggunian of which he is a member, which relationship may 2 result in conflict of interests. Such relationship shall include:

3 4 (1) Ownership of stock or capital, or investment in the entity or firm which the ordinance or resolution may apply; and

(2) Contracts or agreements with any person or entity which the ordinance
 or resolution under consideration may affect.

In the absence of a specific constitutional or statutory provision applicable to this situation, "conflict of interest" refers in general to one where it may be reasonably deduced that a member of a sanggunian may not act in the public interest due to some private, pecuniary or other personal considerations that may tend to affect his judgment to the prejudice of the service or the public.

(b) The disclosure required under this Act shall be made in writing and submitted
 to the secretary of the sanggunian or the secretary of the committee of which he is a
 member. The disclosure shall, in all cases, form part of the record of the proceedings
 and shall be made in the following manner.

- 16 (1) Disclosure shall be made before the member participates in the 17 deliberations on the ordinance or resolution under consideration: 18 *Provided*, that if the member did not participate during the deliberations, 19 the disclosure shall be made before voting on the ordinance or resolution 20 on second and third readings; and
- (2) Disclosure shall be made when a member takes a position or makes a
 privilege speech on a matter that may affect the business interest,
 financial connection, or professional relationship described herein.

SECTION 14. Sessions. – (a) On the first day of the session immediately following the election of its members, the sangguniang panlungsod shall, by resolution, fix the day, time and place of its sessions. The minimum number of regular sessions shall be once a week for the sangguniang panlungsod.

(b) When the public interest so demands, special sessions may be called by the city mayor or by a majority of the members of the sanggunian.

(c) All sanggunian sessions shall be open to public unless a closed-door session
 is ordered by an affirmative vote of a majority of the members present, there being a
 quorum, in the public interest or for reasons of security, decency or morality. No two
 (2) sessions, regular or special, may be held in a single day.

1 (d) In the case of special sessions of the sanggunian, a written notice to the 2 members shall be served personally at the members' usual place of residence at least 3 twenty-four (24) hours before the special session is held.

4 Unless otherwise concurred in by two-thirds (2/3) vote of the sanggunian 5 members present, there being a quorum, no other matters may be considered at a 6 special session except those stated in the notice.

(e) The sanggunian shall keep a journal and record of its proceedings which may
 be published upon resolution of the sangguniang panlungsod.

9 **SECTION 15.** *Quorum.* – (a) A majority of all members of the sanggunian who 10 have been elected and qualified shall constitute a quorum to transact official business. 11 Should a question of a quorum be raised during a session, the presiding officer shall 12 immediately proceed to call the roll of the members and thereafter announce the 13 results.

(b) Where there is no quorum, the presiding officer may declare a recess until such times as a quorum is constituted, or a majority of the members present may adjourn from day to day and may compel the immediate attendance of any member absent without justifiable cause by designating a member of the sanggunian, to be assisted by a member or members of the police force assigned in the territorial jurisdiction of the City of Bayambang, to arrest the absent member and present him at the session.

(c) If there is still no quorum despite the enforcement of the immediately
 preceding subsection, no business shall be transacted. The presiding officer, upon
 proper motion duly approved by the members present, shall then declare the session
 adjourned for lack of quorum.

SECTION 16. *Approval of Ordinances.* – (a) Every ordinance enacted by the sangguniang panlungsod shall be presented to the city mayor. If the city mayor approves the same, he shall affix his signature on each and every page thereof; otherwise, he shall veto it and return the same with his objections to the sanggunian, which may proceed to reconsider the same. The sanggunian may override the veto of the city mayor by two-thirds (2/3) vote of all its members, thereby making the ordinance or resolution effective for all legal intents and purposes.

(b) The veto shall be communicated by the city mayor to the sanggunian within
 ten (10) days; otherwise, the ordinance shall be deemed approved as if he had signed
 it.

SECTION 17. Veto Power of the City Mayor. – (a) The city mayor may veto any ordinance of the sangguniang panlungsod on the ground that it is ultra vires or prejudicial to the public welfare, stating his reasons thereof in writing.

(b) The city mayor shall have the power to veto any particular item or items of 4 an appropriations ordinance, an ordinance, or resolution adopting a local development 5 plan, any public investment program or an ordinance directing the payment of money 6 or creating liability. In such case, the veto shall not affect the item or items which are 7 not objected to. The vetoed item or items shall not take effect unless the sangguniang 8 panlungsod overrides the veto in the manner herein provided; otherwise, the item or 9 items in the appropriations ordinance of the previous year corresponding to those 10 vetoed, if any, shall be deemed reenacted. 11

(c) The city mayor may veto an ordinance or resolution only once. The
 sanggunian may override the veto of the city mayor by two-thirds (2/3) vote of all its
 members, thereby making the ordinance effective even without the approval of the city
 mayor.

16 **SECTION 18.** *Review of City Ordinance by the Sangguniang* 17 *Panlalawigan.* – (a) Within three (3) days after approval, the secretary to the 18 sangguniang panlungsod shall forward to the sangguniang panlalawigan for review, 19 copies of approved ordinances and the resolutions approving the local development 20 plans and public investment programs formulated by the local development councils.

(b) If the sangguniang panlalawigan finds that such an ordinance or resolution is beyond the power conferred upon the sangguniang panglungsod concerned, it shall declare such ordinance or resolution invalid in whole or in part. The sangguniang panlalawigan shall enter its action in the minutes and shall advise the corresponding city authorities of the action it has taken.

26

(c) If no action has been taken by the sangguniang panlalawigan within thirty
(30) days after submission of such an ordinance or resolution, the same shall be
presumed consistent with law and therefore valid.

30 **SECTION 19.** *Review of Barangay Ordinances by the Sangguniang* 31 *Panlungsod.* – (a) Within ten (10) days after its enactment, the sangguniang 32 barangay shall furnish copies of all barangays ordinances to the sangguniang 33 panlungsod for review as to whether the ordinance is consistent with law and city 34 ordinances.

(b) If the sangguniang panlungsod fails to take action on barangay ordinances
 within thirty (30) days from receipt thereof, the same shall be deemed approved.

1 (c) If the sangguniang panlungsod finds the barangays ordinances inconsistent 2 with law or city ordinances, the sangguniang panglungsod shall, within thirty (30) days 3 from receipt thereof, return the same with its comments and recommendations to the 4 sangguniang barangay concerned for adjustment, amendment or modification; in 5 which case, the effectivity of the barangay ordinance is suspended until such time as 6 the revision called for is effected.

SECTION 20. Enforcement of Disapproved Ordinances or Resolutions.
 Any attempt to enforce any ordinance or any resolution approving the local development plan and public investment program, after the disapproval thereof, shall be sufficient ground for the suspension or dismissal of the official or employee concerned.

SECTION 21. *Effectivity of Ordinances or Resolutions.* – (a) Unless otherwise stated in the ordinance or the resolution approving the local development plan and the public investment program, the same shall take effect after ten (10) days from the date a copy thereof is posted in a bulletin board at the entrance of the City Hall of the City of Bayambang and in at least two other conspicuous places in the City of Bayambang.

(b) The secretary of the sangguniang panlungsod shall cause the posting of an
 ordinance or resolution in the bulletin board at the entrance of the City Hall of
 Bayambang, and in at least two (2) conspicuous places in the City of Bayambang not
 later than five (5) days after approval thereof.

The text of the ordinance or resolution shall be disseminated and posted in Filipino or English and in the language or dialect understood by the majority of the people in the City and the secretary of the sangguniang panlungsod shall record such fact in a book kept for the purpose, stating the dates of approval and posting.

(c) The main features of the ordinance or resolution duly enacted or adopted
shall, in addition to being posted, be published once in a local newspaper of general
circulation within the City: *Provided*, that in the absence thereof the ordinance or
resolution shall be published in any newspaper of general circulation: *Provided, further*,
That the gist of all ordinances with penal sanctions shall also be published in a
newspaper of general circulation.

ARTICLE VI DISQUALIFICATION AND SUCCESSION FOR ELECTIVE CITY OFFICIALS

SECTION 22. Disqualifications for Elective Public City Officials. - The 1 following persons are not qualified from running for any elective position in the City: 2 3 (a) Those who did not meet the age and residency requirement for the position 4 running for; 5 (b) Those sentenced by final judgment for an offense involving moral turpitude 6 or an offense punishable by one (1) year or more of imprisonment within two (2) years 7 after serving sentence; 8 (c) Those removed from office as a result of an administrative case; 9 (d) Those convicted by final judgment for violating the oath of allegiance to the 10 Republic of the Philippines; 11

- 12 (e) Those with dual citizenship;
- 13 (f) Fugitives from justice in criminal or nonpolitical here and abroad;

14 (g) Permanent residents in a foreign country or those who have acquired the 15 right to reside abroad and continue to avail of the same right after the effectivity of 16 the Local Government Code; and

17 (h) The insane or freeble-minded.

SECTION 23. Permanent Vacancy in the Offices of the City Mayor and 18 City Vice Mayor. - (a) If a permanent vacancy occurs in the office of the city mayor, 19 the city vice mayor shall become the city mayor. If a permanent vacancy occurs in the 20 office of the city vice mayor, the highest ranking sangguniang panlungsod member or, 21 in case of his permanent incapacity, the second highest ranking sangguniang 22 panlungsod member shall become the city vice mayor. If permanent vacancies occur 23 in both the offices of the city mayor and the city vice mayor, the first and second 24 highest ranking sangguniang panlunsod members, or in case of permanent incapacity 25 of one or both of them, the next highest ranking sangguniang panlungsod member or 26 members, shall become the city mayor or city vice mayor, respectively. Subsequent 27 vacancies in said offices shall be filled automatically by the other sanggunian members 28 according to their ranking as defined herein. 29

30 (b) A tie between or among the highest ranking sangguniang panlungsod 31 members shall be resolved by drawing of lots. 1 (c) The successors as defined herein shall serve only the unexpired terms of 2 their predecessors.

For purposes of this Act, a permanent vacancy arises when an elective local official fills a higher vacant office, refuses to assume office, fails to qualify, dies, is removed from office, voluntarily resigns or is otherwise permanently incapacitated to discharge the functions of his office.

For purposes of succession as provided in this Act, ranking in the sanggunian shall be determined on the basis of the proportion of votes obtained by each winning candidate to the total number of registered voters in the City immediately preceding local election.

11 **SECTION 24.** *Permanent Vacancies in the Sanggunian.* – Permanent 12 vacancies in the sangguniang panlungsod where automatic succession as provided 13 above does not apply shall be filled by appointments in the following manner:

- 14 (1) The provincial governor shall make the aforesaid appointments;
- (2) Only the nominee of the political party under which the sanggunian 15 member concerned had been elected shall be appointed in the manner 16 herein provided. The appointee shall come from the political party as that 17 of the sanggunian member who caused the vacancy and shall serve the 18 unexpired term of the vacant office. In the appointment herein 19 mentioned, a nomination and a certificate of membership of the 20 appointee from the highest official of the political party concerned are 21 conditions sine qua non, and any appointment without such nomination 22 and certification shall be null and void ad initio and shall be a ground for 23 administrative action against the official responsible therefor. 24
- (3) In case the permanent vacancy is caused by a sanggunian member who
 does not belong to any political party, the city mayor shall, upon
 recommendation of the sangguniang panlungsod, appoint a qualified
 person to fill vacancy; and
- (4) In case of vacancy in the representation of the youth and the barangay
 in the sangguniang panlungsod, said vacancy shall be filled automatically
 by the official next in rank of the organization concerned.

SECTION 25. *Temporary Vacancy in the Office of the Mayor.* – (a) When the city mayor is temporarily incapacitated to perform his duties for physical or legal reasons such as, but not limited to, leave of absence, travel abroad, and suspension from office, the city vice mayor or the highest ranking sangguniang panlungsod member, as the case maybe, shall automatically exercise the powers and perform the 1 duties and functions of the city mayor, except the power to appoint, suspend, or 2 dismiss employees which can only be exercised if the period of temporary incapacity 3 exceeds thirty (30) working days.

4 (b) Said temporary incapacity shall terminate upon submission to the 5 sangguniang panlungsod of a written declaration by the city mayor that he has reported 6 back to office. In case where the temporary incapacity is due to legal cause, the city 7 mayor shall also submit necessary documents showing the said legal cause no longer 8 exist.

9 (c) When the city mayor is traveling within the country but outside territorial 10 jurisdiction for a period not exceeding three (3) consecutive days, he may designate in 11 writing the officer-in-charge of his office. Such authorization shall specify the powers 12 and functions that the local official concerned shall exercise in the absence of the city 13 mayor except the power to appoint, suspend, or dismiss employees.

(d) In the event, however, that the city mayor fails or refuses to issue such
 authorization, the city vice mayor shall have the right to assume the powers, duties
 and functions of the said office on the fourth day of absence of the city mayor, subject
 to the limitations provided in subsection (c) hereof.

(e) Except as provided above, the city mayor shall in no case authorize any local official to assume the powers, duties and functions of the office, other than the city vice mayor.

ARTICLE VII THE APPOINTIVE OFFICIALS OF THE CITY: THEIR QUALIFICATIONS, POWERS AND DUTIES

SECTION 26. The Secretary of the Sangguniang Panlungsod. – (a) there shall be a secretary of the sangguniang panlungsod who shall be a career official with the rank and salary equal to a head of a department or office, who shall be appointed by the city mayor with the concurrence of the majority of all the sangguniang panlungsod members, subject to civil service law, rules and regulations.

(b) No person shall be appointed secretary to the sangguniang panlungsod unless he is a citizen of the Philippines, a resident of the City of Bayambang, of good moral character, a holder of a college degree preferably in law, commerce or public administration from a recognized college or university, and a first grade civil service eligible or its equivalent.

(c) The secretary of the sangguniang panlungsod shall receive such compensation, emoluments and allowances as may be determined by law.

1 2	(d) The secretary to the sangguniang panlungsod shall take charge of the office of the sangguniang panlungsod, and shall:

SECTION 27. *The City Treasurer.* – (a) The city treasurer shall be appointed by the Secretary of Finance from a list of at least three (3) ranking eligible recommendees of the city mayor, subject to the civil service law, rules and regulations.

4 (b) The City treasurer shall be under the administrative supervision of the city 5 mayor,

6 to whom he shall report regularly on the tax collection efforts of the city.

7 (c) No person shall be appointed treasurer unless he is a citizen of the 8 Philippines, a resident of the City of Bayambang, of good moral character, a holder of 9 a college degree in commerce, public administration or law from a recognized college 10 or university, and a first grade civil eligible or its equivalent. He must have acquired 11 experience in treasury or accounting service for at least five (5) years.

12 (d) The city treasurer shall receive such compensation, emoluments and 13 allowances as may be determined by law.

- 14 (e) The city treasurer shall take charge of the city treasury office, and shall:
- (1) Advise the city mayor, the sangguniang panlungsod and other local
 government and national officials concerned regarding disposition of local
 government funds and on such other matters relative to public finance;
- 18 (2) Take custody and exercise proper management of the funds of the City;
- (3) Take charge of the disbursement of all funds of the City and such other
 funds the custody of which may be entrusted to him by law or other
 competent authority;
- (4) Inspect private commercial and industrial establishments within the
 jurisdiction of the City in relation to the implementation of tax ordinances
 pursuant to the provisions of the Local Government Code;
- 25 (5) Maintain and update the tax information system of the City; and
- (6) Perform such other duties and functions and exercise such other powers
 as provided for under Republic Act No. 7160, otherwise known as the
 Local Government Code of 1991, and those that are prescribed by law or
 ordinance.

SECTION 28. *The Assistant City Treasurer.* – (a) the assistant city treasurer may be appointed by the Secretary of Finance from a list of at least three (3) ranking eligible recommendees of the city mayor, subject to civil service law, rules and regulations. (b) No person shall be appointed assistant city treasurer unless he is a citizen of
the Philippines, a resident of the City of Bayambang, of good moral character, a holder
of a college degree preferably in commerce, public administration, or law from a
recognized college or university, and a first grade civil service eligible or its equivalent.
He must have acquired at least five (5) years' experience in treasury or accounting.

6 (c) The assistant city treasurer shall receive such compensation, emoluments 7 and allowances as may be determined by law.

8 (d) The assistant city treasurer shall assist the city treasurer and perform such 9 other duties as the latter may assign him. He shall have authority to administer oaths 10 concerning notices and notifications to those delinquents in the payment of the real 11 property tax and concerning official matters relating to the accounts the city treasurer 12 or otherwise arising from the offices of the city treasurer and the city assessor.

SECTION 29. *The City Assessor.* – (a) The city assessor must be a citizen of the Philippines, a resident of the City of Bayambang, of good moral character, a holder of a college degree preferably in civil or mechanical engineering, commerce, or any other related course from a recognized college or university, and a first grade civil service eligible or its equivalent. He must have acquired experience in real property assessment work or in any related field for at least five (5) years,

19 (b) The city assessor shall receive such compensation, emoluments and 20 allowances as may be determined by law.

- 21 (c) The city assessor shall take charge of the city assessor's office, and shall:
- (1) Ensure that all laws and policies governing the appraisal and assessment

He must have acquired experience in government budgeting or in any related field for at least five (5) years immediately preceding the date of his appointment.

ARTICLE VIII THE CITY FIRE STATION SERVICE, THE CITY JAIL SERVICE AND THE CITY SCHOOL DIVISION

SECTION 48. *The City Fire Station Service.* – (a) There shall be established in the City at least one (1) fire station with adequate personnel, firefighting facilities and equipment, subject to the standards, rules and regulations that may be promulgated by the Department of the Interior and Local Government. The City shall provide necessary land or site of the station.

10 (b) The city fire station service shall be headed by a city fire marshal whose 11 qualifications shall be as those provided for under Republic Act No. 6975, otherwise 12 known as the Philippine National Police Law.

13 (c) The city fire station shall be responsible for the protection and various 14 emergency services such as rescue and evacuation of injured people at fire-related 15 incidents and, in general fire prevention and suppression measures to secure the safety 16 of life and property of the citizenry.

SECTION 49. *The City Jail Service.* – (a) There shall be established and maintained in the City a secured, clean, adequately equipped and sanitary jail for the custody and safekeeping prisoners, any fugitive from justice, or person detained awaiting investigation or trial and or transfer to the national penitentiary, and/or violent mentally ill person who endangers himself or the safety of others, duly certified a such by the proper medical health officer, pending the transfer to a mental institution.

(b) The city jail service shall be headed by a city jail warden who must be a graduate of a four (4) year course in psychology, psychiatry, sociology, nursing, social work or criminology who shall assist in the immediate rehabilitation of individuals or detention of prisoners. Great care must be exercised so that human rights of these prisoners are respected and protected, and their spiritual and physical well-being are properly and promptly attended to. Likewise, the City shall ensure that proper separate detention centers for juveniles and women are provided for.

30 SECTION 50. *The City School Division*. – (a) The Department of Education
 31 shall establish and maintain a school division of the City of Bayambang whose area of
 32 jurisdiction will cover all the school districts within the City; and

ARTICLE IX TRANSITORY AND FINAL PROVISIONS

3 **SECTION 51.** *Municipal Ordinance Existing at the Time of the Approval* 4 *of this Act.* – All municipal ordinances of the Municipality of Bayambang existing at 5 the time of the approval of this Act shall continue to be enforce within the City of 6 Bayambang until the sangguniang panlungsod ordinance shall provide otherwise.

7

8 **SECTION 52.** *Plebiscite.* – The City of Bayambang shall acquire corporate 9 existence upon the ratification of its creation by a majority of the votes cast by the 10 qualified voters in a plebiscite to be conducted in the present Municipality of 11 Bayambang within sixty (60) days from the approval of this Act. The expenses for such 12 plebiscite shall be borne by the Municipality of Bayambang. The Commission on 13 Elections shall conduct and supervise such plebiscite.

SECTION 53. *Officials of the City of Bayambang.* – The present elective officials of the Municipality of Bayambang shall continue to exercise their powers and functions until such a time that a new election is held and the duly-elected officials shall have already qualified and assumed their officers. The appointive officials and employees of the Municipality shall likewise continue exercising their functions and duties and they shall be automatically absorbed by the City Government of Bayambang.

20 **SECTION 54.** *Succession Clause*. – The City of Bayambang shall succeed to 21 all the assets, properties, liabilities, and obligations of the Municipality of Bayambang.

SECTION 55. *Election of Provincial Governor and Sangguniang Panlalawigan Members of the Province of Pangasinan.* – The qualified voters of the City of Bayambang shall qualify to vote and run for any elective position in the elections for provincial governor, provincial vice-governor, sangguniang panlalawigan members and other elective offices for the Province of Pangasinan.

SECTION 56. *Jurisdiction of the Province of Pangasinan*. – The City of Bayambang shall, unless otherwise provided by law, continue to be under the jurisdiction of Pangasinan Province.

30 **SECTION 57.** *Suspension of Increase in Rules of Local Taxes.* – No 31 increase in the rates of local taxes shall be imposed by the City within the period of five 32 (5) years from its acquisition of corporate existence. 1 **SECTION 58.** *Legislative District.* – Until otherwise provided by law, the City 2 of Bayambang shall continue to be part of the Third Congressional District of 3 Pangasinan Province.

4 **SECTION 59.** *Applicability of Laws.* – The provisions of Republic Act No. 5 7160, otherwise known as the Local Government Code of 1991 and such laws as are 6 applicable to component cities shall govern the City of Bayambang insofar as they are 7 not inconsistent with the provisions of this Act.

8 **SECTION 60.** *Separability Clause.* – If any part of this Act is declared invalid 9 or unconstitutional, the other parts or provisions thereof shall remain valid and 10 effective.

SECTION 61. Effectivity Clause. – This Act shall take effect after fifteen (15) days following the completion of its publication in the Official Gazette or in a newspaper of general circulation in the Philippines.
