AN ACT  
CREATING A BARANGAY IN THE MUNICIPALITY OF BAROBO, PROVINCE OF SURIGAO  
DEL SUR, TO BE KNOWN AS BARANGAY GUINHALINAN

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           **SECTION 1. *Creation of Barangay Guinhalinan.*** – There is hereby created a barangay in  
2 the Municipality of Barobo, Province of Surigao del Sur, to be known as Barangay Guinhalinan.

3           **SEC. 2. *Territorial Boundaries.*** – The territorial boundaries of Barangay Guinhalinan shall  
4 be described as follows:

5           “Bounded on the North by Barangay Javier, Barobo, Surigao del Sur: Pls-44 Survey: Lot  
6 Nos. 2153, 2154, 2157, 2158, 2528, 2161, 2162, 2296, 2166, 2169, 2170, 2106, 2174, 2177, 3329,  
7 2178, 2181, 2182, 2185, 2186, 2189, 2190, 2193, 2552 Or CAD-949-D Survey Lot No. 8892, 8897,  
8 8898, 8907, 8912, 8917, 8920 part, 8921, 8961, 8940, 8946, 8952, 8960, 8965, 8970, 8978 part, 8028  
9 part, 8018, 8019, 8020, 8002, 8004, 8005, 7750, 7755;

10           On the East by Barangay Batunan, Tagbina, Surigao del Sur;

11           On the West by Barangay Javier, Barobo, Surigao del Sur: Pls-44 Survey: Lot Nos. 2151,  
12 2126, including homestead road adjacent to said lots or CAD-949-D Survey: Lot Nos. 8885, 8856,  
13 8838, 8837, 8833, 8776, CSD-13-004043-D Survey: Lot 49, 51 part, 52 part, 56 part, 61 part, 63  
14 part; Timberland: Straightline from West of Lot 2152, 2243, all of Pls-44 up to Binooyan Creek,  
15 traverse along the Binooyan Creek (crossing on the left side), up to boundary of the Province of  
16 Agusan del Sur;

1                   On the South by the Province of Agusan del Sur.”

2                   The entire territorial jurisdiction of Barangay Guinhalinan shall contain an approximate land  
3 area of more or less Two thousand three hundred seventy (2,370) hectares.

4                   **SEC. 3. *Conduct and Supervision of Plebiscite.*** -- The plebiscite conducted and supervised  
5 by the Commission on Elections pursuant to *Sangguniang Panlalawigan ng Surigao* Provincial  
6 Resolution No. 79 - 16, which was duly ratified and proclaimed by the Plebiscite Board of Canvassers  
7 on August 1, 1979, shall serve as substantial compliance with the plebiscite requirement under  
8 Section 10 of Republic Act No. 7160, as amended, otherwise known as the Local Government Code  
9 of 1991.

10                  **SEC. 4. *Incumbent Barangay Officials.*** -- The incumbent elected barangay officials of  
11 Barangay Guinhalinan shall continue to hold office until such time that their successors have been  
12 duly elected and qualified.

13                  **SEC. 5. *Public Infrastructures and Facilities.*** -- All public infrastructures and facilities  
14 existing therein at the time of the approval of this Act are hereby transferred without cost or  
15 compensation to and shall be administered by the new barangay.

16                  **SEC. 6. *National Tax Allotment Shares.*** -- Barangay Guinhalinan shall be entitled to  
17 National Tax Allotment shares pursuant to Section 285 of the Local Government Code of 1991, as  
18 amended.

19                  **SEC. 7. *Repealing Clause.*** - All laws, decrees, executive orders, rules, and regulations  
20 which are inconsistent with this Act are hereby repealed or modified accordingly.

21                  **SEC. 8. *Effectivity.*** - This Act shall take effect fifteen (15) days after its publication in the  
22 *Official Gazette* or in a newspaper of general circulation.
