## **MR. PRESIDENT:**

The Committees on Higher, Technical and Vocational Education; and Finance, to which were referred **House Bill No. 6552**, introduced by Representatives Romualdez (Y.M.), Romualdez (F.M.), Acidre, Go (M.), Macapagal-Arroyo, Gonzales (A.), Teves (J.), Delos Santos, Chatto, Rodriguez (E.), Abunda, Olivarez, Collantes, Khonghun, Suansing (M.A.), Ortega, Cagas, Suan, Bordado, Balindong, Domingo, Aquino, Gullas, Cari, Galeos, Abalos, Cardema, Zamora (M.C.), Vergara, Verzosa, Buhain, Guintu, Mariano-Hernandez, Nava, Tulfo (R.W.), Rodriguez (R.), Dalog, Padiernos, Veloso-Tuazon, Mercado-Revilla, Co (E.), Yap (C.), Revilla (R.J.) and Mastura, entitled:

## "AN ACT

CONVERTING THE SAN ISIDRO SATELLITE CAMPUS OF THE LEYTE NORMAL UNIVERSITY LOCATED IN THE MUNICIPALITY OF SAN ISIDRO, PROVINCE OF LEYTE, INTO A REGULAR CAMPUS OF THE LEYTE NORMAL UNIVERSITY TO BE KNOWN AS THE LEYTE NORMAL UNIVERSITY - SAN ISIDRO CAMPUS, AND APPROPRIATING FUNDS THEREFOR"

have considered the same and have the honor to report it back to the Senate with the recommendation that House Bill No. 6552 be approved with the following amendments:

- On page 1, line 1, after the figure "1" and period "(.)", insert the phrase, to serve as title of Section 1, "SHORT TITLE", followed by a period "(.)" and a hyphen "(-)";
- 2. On the same page, line 4, after the figure "2" and period "(.)", insert the phrase, to serve as title of Section 2, "CONVERSION OF LNU-SAN ISIDRO CAMPUS INTO A REGULAR CAMPUS", followed by a period "(.)" and a hyphen "(--)";
- 3. On the same page, line 8, after the figure "3" and period "(.)", insert the phrase, to serve as title of Section 3, "GENERAL MANDATE", followed by a period "(.)" and a hyphen "(-)";
- 4. On the same page, line 9, after the word "specialization" and a comma "(,)", insert the phrase "PURSUANT TO THE MANDATE OF THE LNU, AND ACCORDING TO ITS CAPABILITY";
- 5. On the same page, line 12, delete the phrase "Region VIII", and insert the phrase "**THE EASTERN VISAYAS REGION**";

- On page 2, line 1, delete the phrase "is also", and insert the phrase "SHALL BE";
- 7. On the same page, lines 5 to 9, rephrase the entire Section 4 to read as follows:

"SEC. 4. SUPERVISION AND MANAGEMENT OF LNU-SAN ISIDRO CAMPUS. — THE LNU-SAN ISIDRO CAMPUS SHALL BE HEADED BY A CAMPUS ADMINISTRATOR, TO BE APPOINTED BY THE BOARD SUBJECT TO THE GUIDELINES, QUALIFICATIONS AND STANDARDS SET BY THE BOARD, AND UPON THE RECOMMENDATION OF A SEARCH COMMITTEE DULY CONSTITUTED FOR THE PURPOSE OF SELECTING THE CAMPUS ADMINISTRATOR."

8. On the same page, lines 11 to 13, rephrase the entire Section 5 to read as follows:

"SEC. 5. COMPLIANCE WITH THE REQUIREMENTS OF THE COMMISSION ON HIGHER EDUCATION. — THE LNU SHALL ENSURE THE COMPLIANCE OF THE LNU-SAN ISIDRO CAMPUS WITH THE POLICIES, STANDARDS AND GUIDELINES OF THE COMMISSION ON HIGHER EDUCATION (CHED) FOR THE OPERATION OF REGULAR CAMPUSES, INCLUDING THOSE RELATED TO THE OFFERING OF COURSES AND THE INTRODUCTION OF NEW OR REVISED PROGRAMS PRIOR TO ITS CONVERSION AS A REGULAR CAMPUS."

9. On the same page, line 15, after the figure "6" and period "(.)", insert the phrase, to serve as title of Section 6, "MANAGEMENT OF PERSONNEL,

**ASSETS AND RECORDS OF THE CAMPUS**" followed by a period "(.)" and a hyphen "(–)";

- 10.On the same page, line 27, after the figure "7" and period "(.)", insert the phrase, to serve as title of Section 7, "**SUPPLETORY APPLICATION**" followed by a period "(.)" and a hyphen "(–)";
- 11.On the same page, line 30, after the figure "8" and period "(.)", insert the word, to serve as title of Section 8, "APPROPRIATIONS" followed by a period "(.)" and a hyphen "(-)";
- 12. On the same page, same line, after the word "Act", insert a comma "(,)", the phrase "INCLUDING THOSE REQUIRED TO FUND THE PLANTILLA POSITIONS OF TEACHING AND NON-TEACHING PERSONNEL OF THE LNU-SAN ISIDRO CAMPUS" and another comma "(,)";
- 13.On the same page, line 37, after the figure "9" and period "(.)", insert the phrase, to serve as title of Section 9, "IMPLEMENTING RULES AND REGULATIONS" followed by a period "(.)" and a hyphen "(-)";
- 14. On the same page, line 41, after the figure "10" and period "(.)", insert the phrase, to serve as title of Section 10, "**SEPARABILITY CLAUSE**" followed by a period "(.)" and a hyphen "(–)";
- 15. On the same page, line 47, after the figure "11" and period "(.)", insert the phrase, to serve as title of Section 11, "**REPEALING CLAUSE**" followed by a period "(.)" and a hyphen "(–)"; and
- 16. Finally, on the same page, line 49, after the figure "12" and period "(.)", insert the word, to serve as title of Section 12, "EFFECTIVITY" followed by a period "(.)" and a hyphen "(-)".

#### AN ACT

CONVERTING THE SAN ISIDRO SATELLITE CAMPUS OF THE LEYTE NORMAL UNIVERSITY LOCATED IN THE MUNICIPALITY OF SAN ISIDRO, PROVINCE OF LEYTE, INTO A REGULAR CAMPUS OF THE LEYTE NORMAL UNIVERSITY TO BE KNOWN AS THE LEYTE NORMAL UNIVERSITY-SAN ISIDRO CAMPUS, AND APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:* 

SECTION I. This Act shall be known as the "Leyte Normal University (LNU) San Isidro Campus Act."

SEC. 2. The LNU-San Isidro Satellite Campus located in the Municipality of San
Isidro, Province of Leyte, is hereby converted into a regular campus of the LNU to be
known as the LNU-San Isidro Campus.

8 SEC. 3. The LNU-San Isidro Campus shall offer short-term, technical-vocational, 9 undergraduate, and graduate courses within its areas of competency and specialization, as 10 the Board of Regents, hereinafter referred to as the Board, may deem necessary for the 11 accomplishment of its objectives, and those which respond to the human resource 12 development needs of the Province of Leyte and Region VIII.

The LNU-San Isidro Campusis also mandated to undertake research and extension services, and production activities in support of the socio-economic development and to 3 provide progressive leadership in these areas.

SEC. 4. The LNU-San Isidro Campus shall be headed by a Campus Administrator who shall render full-time service and shall be appointed by the Board, subject to the qualifications standards prescribed by the Board, and based on the recommendation of a search committee duly constituted for the purpose of selecting the Campus Administrator.

SEC. 5. The LNU shall ensure that the minimum requirements of the 12 Commission on Higher Education (CHED) for the operation of the LNU-San Isidro 13 Campus, including those related to its course offerings, are fully complied with. 14

15 SEC 6. All assets, both real and personal, personnel, and records of the LNU-16 San Isidro Satellite Campus, as well as its liabilities or obligations, shall be transferred to the LNU. The positions, rights, and security of tenure of faculty members and 17 18 personnel therein employed under existing laws prior to the conversion into a regular 19 campus shall be respected. 20

All parcels of land belonging to the government occupied by the LNU-San Isidro Satellite Campus shall be transferred to the LNU: Provided, That should the campus or the LNU cease to exist or be abolished or should such aforementioned parcels of land be no longer needed by the LNU, the same shall revert to the local government unit concerned or to the Republic of the Philippines, as the case may be.

27 SEC. 7. The provisions of Republic Act No. 8292, otherwise known as the 28 "Higher Education Modernization Act of 1997", shall form part of this Act. 29

30 SEC. 8. The amount necessary to carry out the provisions of this Act shall be 31 included in the annual General Appropriations Act (GAA). 32

33 The Municipality of San Isidro shall provide the same assistance until such time 34 that the amount necessary for the continued operation and maintenance of the LNU-San 35 Isidro Campus shall be included in the annual GAA. 36

37 SEC. 9. Within sixty (60) days from the effectivity of this Act, the Board shall, in consultation with the CHED, issue rules and regulations to implement the provisions 38 39 of this Act. 40

41 SEC. 10. If, for any reason, any part or provision of this Act is declared invalid 42 or unconstitutional, the remaining parts or provisions not affected shall remain in full 43 force and effect. 44

45 SEC. 11. All other laws, presidential decrees, executive orders, rules and regulations contrary to or inconsistent with the provisions of this Act are repealed or 46 47 modified accordingly.
