A RESOLUTION
DIRECTING THE APPROPRIATE SENATE COMMITTEE TO
CONDUCT AN INQUIRY, IN AID OF LEGISLATION, ON THE
KILLING OF JERHODE JEMBOY BALTAZAR BY SIX POLICE
OFFICERS IN NAVOTAS CITY

1 **WHEREAS**, it is the Constitutionally ordained responsibility of the
2 local police agencies to preserve peace and order within the regions¹;

3
4 **WHEREAS**, pursuant to this Constitutional mandate, it is the
5 policy of the State to promote peace and order, ensure public safety and
6 further strengthen local government capability aimed towards the
7 effective delivery of the basic services to the citizenry through the
8 establishment of a highly efficient and competent police force that is
9 national in scope and civilian in character²;

10
11 **WHEREAS**, on August 2, 2023, around 2:45 a.m., six Navotas
12 policemen were on a follow-up operation after a shooting that killed a
13 certain Cristelo Mahinay in Barangay NBBS Kaunlaran, Navotas City. A
14 suspect had been arrested but another escaped and was reported to be
15 hiding in a boat³;

1 **WHEREAS**, upon arriving at the scene, the policemen saw Jerhode
2 Jemboy Baltazar and a friend on a boat preparing to go fishing—and
3 suddenly fired at them. The teenager’s friend, who survived unharmed,
4 said they tried to surrender but the officers kept shooting, prompting
5 Baltazar to jump into the river⁴;

6
7 **WHEREAS**, according to Baltazar’s mother and sister, the bullets
8 hit the teenager in the face, giving him “no chance to live.”⁵;

9
10 **WHEREAS**, PNP public information chief Col. Redrico Maranan
11 said that all six had been disarmed and would be placed under restrictive
12 custody at the Northern Police District headquarters in Caloocan City.
13 Withholding their names, he said the six had undergone inquest
14 proceedings in the Navotas prosecutor’s office on charges of “reckless
15 imprudence resulting to homicide”⁶;

16
17 **WHEREAS**, as defined in Article 365 of the Revised Penal Code,
18 reckless imprudence consists in voluntarily, but without malice, doing or
19 failing to do an act from which material damage results by reason of
20 inexcusable lack of precaution on the part of the person performing or
21 failing to perform such act, taking into consideration his employment or
22 occupation, degree of intelligence, physical condition and other
23 circumstances regarding persons, time and place;

24
25 **WHEREAS**, according the Revised Philippine National Police
26 Operational Procedures, the use of firearm is justified only if the offender
27 poses imminent danger of causing death or injury to the police officer or
28 other persons. The use of firearm is also justified under the doctrines of
29 self-defense, defense of a relative, and defense of a stranger. However,
30 one who resorts to self-defense must face a real threat on his life, and the
31 peril sought to be avoided must be actual, imminent and real. Unlawful
32 aggression should be present for self-defense to be considered as a
33 justifying circumstance⁷;

1 **WHEREAS**, a policeman is never justified in using unnecessary
2 force or in treating the offender with wanton violence, or in resorting to
3 dangerous means when the arrest could be affected otherwise⁸;

4
5 **WHEREAS**, the events as reported show no indication of any
6 justification for the use of firearms by the six policemen;

7
8 **WHEREAS**, this incident in Navotas is only one of the many
9 operational lapses committed by the Philippine National Police which
10 resulted in death. On June 16, 2021, 16-year-old Johndy Maglante in
11 Laguna was allegedly shot by police even as he was wearing handcuffs⁹.
12 On December 9, 2022, 34-year-old Gilbert Dalogdog Ranes was
13 allegedly mauled by a police officer and experienced difficulty in
14 breathing before he was pronounced dead while under custody¹⁰;

15
16 **WHEREAS**, leaving this matter uninvestigated amounts to
17 permitting wanton abuse of police authority, sanctioning selective justice
18 which unduly favors police personnel, and standing by as public trust
19 towards our police force is eroding;

20
21 **NOW, THEREFORE, BE IT RESOLVED** as it is hereby
22 resolved, to direct the appropriate Senate Committee to conduct an
23 inquiry, in aid of legislation, on the killing of Jerhode Jemboy Baltazar
24 by six police officers in Navotas City.
