

**AN ACT**

**SEPARATING THE SITIOS OF KIMBUAYA, LONGBOY, BULALA, KINAPIAN, INDADANGAN, KUMANIBE AND MACAAG FROM BARANGAY SUYO PROPER IN THE MUNICIPALITY OF SUYO, PROVINCE OF ILOCOS SUR, AND CONSTITUTING THEM INTO A DISTINCT AND INDEPENDENT BARANGAY TO BE KNOWN AS BARANGAY KINAPIAN**

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           **SECTION 1. *Creation of Barangay Kinapian.*** – The sitios of Kimbuaya, Longboy, Bulala,  
2 Kinapian, Indadangan, Kumanibe and Macaag are hereby separated from Barangay Suyo Proper  
3 in the Municipality of Suyo, Province of Ilocos Sur, and constituted into a distinct and  
4 independent barangay to be known as Barangay Kinapian.

5           **SEC. 2. *Territorial Boundaries.*** – The territorial boundaries of Barangay Kinapian are  
6 hereby described as follows:

1           **SEC. 3. *Conduct and Supervision of Plebiscite.*** – Pursuant to Section 10 Republic Act No.  
2 7160, as amended, otherwise known as the Local Government Code of 1991, the new Barangay  
3 Kinapian shall come into existence upon the affirmation of the majority of the votes cast in a  
4 plebiscite to be conducted and supervised by the Commission on Elections in Barangay Suyo  
5 Proper, in the Municipality of Suyo, Province of Ilocos Sur within ninety (90) days from the  
6 effectivity of this Act.

7           The expenses for the plebiscite shall be borne by the Municipality of Suyo, Province of  
8 Ilocos Sur.

9           **SEC. 4. *Barangay Officials.*** – The first set of barangay officials of Barangay Kinapian shall  
10 be appointed by the President of the Philippines and shall hold office until such time that the  
11 new set of officers have been duly elected and qualified.

12           **SEC. 5. *Public Infrastructure and Facilities.*** – All public infrastructure and facilities  
13 existing therein at the time of the approval of this Act are hereby transferred without cost or  
14 compensation to and shall be administered by the new Barangay Kinapian.

15           **SEC. 6. *National Tax Allotment Shares.*** – Barangay Kinapian shall be entitled to National  
16 Tax Allotment shares pursuant to Section 285 of the Local Government Code of 1991, as  
17 amended.

18           **SEC. 7. *Effectivity.*** – This Act shall take effect fifteen (15) days after its publication in the  
19 *Official Gazette* or in a newspaper of general circulation.
