

Re: House Bill No. 7091

Recommending the approval of House Bill No. 7091 with amendments, taking into consideration Senate Bill No. 2025.

Sponsor: Senator Francis G. Escudero

#### **MR. PRESIDENT:**

The Committees on Higher, Technical and Vocational Education; and Finance, to which were referred **House Bill No. 7091**, introduced by Representatives Olivarez, Go (M.), Mariano-Hernandez and Co (E.), entitled:

#### "AN ACT

CONVERTING THE CAMPUS OF THE **POLYTECHNIC** UNIVERSITY OF THE PHILIPPINES LOCATED IN THE CITY OF PARAÑAQUE, INTO **CAMPUS** REGULAR OF THE POLYTECHNIC UNIVERSITY OF THE PHILIPPINES, TO BE KNOWN AS THE POLYTECHNIC UNIVERSITY OF PHILIPPINES-PARAÑAQUE CAMPUS, **AND** CITY **APPROPRIATING FUNDS THEREFOR"** 

taking into consideration **Senate Bill No. 2025**, introduced by Senator Marcos, entitled:

#### "AN ACT

CONVERTING THE CAMPUS OF THE **POLYTECHNIC** UNIVERSITY OF THE PHILIPPINES LOCATED IN THE CITY OF PARAÑAQUE, INTO A **REGULAR CAMPUS OF** THE POLYTECHNIC UNIVERSITY OF THE PHILIPPINES, TO BE KNOWN AS THE POLYTECHNIC UNIVERSITY OF THE PHILIPPINES-PARAÑAQUE CITY CAMPUS, AND APPROPRIATING FUNDS THEREFOR"

have considered the same and have the honor to report it back to the Senate with the recommendation that House Bill No. 7091, taking into consideration Senate Bill No. 2025, be approved with the following amendments:

- On page 1, line 1, after the figure "1" and period "(.)", insert the phrase, to serve as title of Section 1, "SHORT TITLE", followed by a period "(.)" and a hyphen "(-)";
- 2. On the same page, line 4, after the figure "2" and period "(.)", insert the phrase, to serve as title of Section 2, "CONVERSION OF PUP-PARAÑAQUE CITY CAMPUS" followed by a period "(.)" and a hyphen "(-)";
- 3. On the same page, line 8, after the figure "3" and period "(.)", insert the phrase, to serve as title of Section 3, "GENERAL MANDATE" followed by a period "(.)" and a hyphen "(-)";
- 4. On the same page, line 14, delete the phrase "is also", and insert the phrase "SHALL ALSO BE";

- 5. On the same page, lines 18 to 22, delete the entire section 4 and replace with the following:
  - "SEC. 4. SUPERVISION AND MANAGEMENT OF PUP-PARAÑAQUE CITY CAMPUS. THE PUP-PARAÑAQUE CITY CAMPUS SHALL BE HEADED BY A FULL-TIME CAMPUS ADMINISTRATOR, WHO SHALL BE APPOINTED BY THE BOARD SUBJECT TO THE GUIDELINES, QUALIFICATIONS AND STANDARDS SET BY THE BOARD, AND UPON THE RECOMMENDATION OF A SEARCH COMMITTEE DULY CONSTITUTED BY THE BOARD FOR THE PURPOSE OF SELECTING THE CAMPUS ADMINISTRATOR."
- 6. On page 2, lines 1 to 3, delete the entire section 5 and replace with the following:
  - "SEC. 5. COMPLIANCE WITH CHED REQUIREMENTS. THE PUP, PRIOR TO THE CONVERSION OF THE PUP-PARAÑAQUE CITY CAMPUS INTO A REGULAR CAMPUS AND THE OFFERING OF NEW AND REVISED COURSES AND PROGRAMS RELATED THERETO, SHALL ENSURE COMPLIANCE WITH THE APPLICABLE POLICIES, STANDARDS AND GUIDELINES OF THE CHED."
- 7. On the same page, line 5, after the figure "6" and period "(.)", insert the phrase, to serve as title of Section 6, "MANAGEMENT OF PERSONNEL, ASSETS AND RECORDS OF THE CAMPUS" followed by a period "(.)" and a hyphen "(-)";

- 8. On the same page, line 17, after the figure "7" and period "(.)", insert the phrase, to serve as title of Section 7, **"SUPPLETORY APPLICATION"** followed by a period "(.)" and a hyphen "(-)";
- 9. On the same page, line 20, after the figure "8" and period "(.)", insert the word, to serve as title of Section 8, "APPROPRIATIONS" followed by a period "(.)" and a hyphen "(-)";
- 10.On the same page, line 27, after the figure "9" and period "(.)", insert the phrase, to serve as title of Section 9, "IMPLEMENTING RULES AND REGULATIONS" followed by a period "(.)" and a hyphen "(-)";
- 11.On the same page, line 31, after the figure "10" and period "(.)", insert the phrase, to serve as title of Section 10, "SEPARABILITY CLAUSE" followed by a period "(.)" and a hyphen "(-)";
- 12.On the same page, line 35, after the figure "11" and period "(.)", insert the phrase, to serve as title of Section 11, "REPEALING CLAUSE" followed by a period "(.)" and a hyphen "(-)"; and
- 13. Finally, after the figure "12" and period "(.)", insert the word, to serve as title of Section 12, "EFFECTIVITY" followed by a period "(.)" and a hyphen "(-)".

#### AN ACT

CONVERTING THE CAMPUS OF THE POLYTECHNIC UNIVERSITY OF THE PHILIPPINES LOCATED IN THE CITY OF PARAÑAQUE, INTO A REGULAR CAMPUS OF THE POLYTECHNIC UNIVERSITY OF THE PHILIPPINES, TO BE KNOWN AS THE POLYTECHNIC UNIVERSITY OF THE PHILIPPINES-PARAÑAQUE CITY CAMPUS, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION I. This Act shall be known as the "Polytechnic University of the Philippines (PUP)-Parañaque City Campus Act."
- SEC. 2. The campus of the PUP located in the City of Parañaque, National Capital Region (NCR) is hereby converted into a regular campus of the PUP to be known as the PUP-Parañaque City Campus.
- **SEC. 3.** The PUP-Parañaque City Campus shall offer short-term, technical-vocational, undergraduate, and graduate courses within its areas of competency and specialization, as the Board of Regents, hereinafter referred to as the Board, may deem necessary for the accomplishment of its objectives, and those which respond to the human resource development needs of the City of Parañaque and the NCR.

The PUP-Parañaque City Campus is also mandated to undertake research and extension services, and production activities in support of the socio-economic development and to provide progressive leadership in these areas.

**SEC. 4.** The PUP-Parañaque City Campus shall be headed by a Campus Administrator who shall render full-time service and shall be appointed by the Board, subject to the qualification standards prescribed by the Board, and based on the recommendation of a search committee duly constituted for the purpose of selecting the Campus Administrator.

SEC. 5. The PUP shall ensure that the minimum requirements of the Commission on Higher Education (CHED) for the operation of the PUP-Parañaque City Campus, including those related to its course offerings, are fully complied with.

SEC. 6. All assets, both real and personal, personnel, and records of the PUP-Parañaque City Campus, as well as its liabilities or obligations, shall be transferred to the PUP. The positions, rights, and security of tenure of faculty members and personnel therein employed under existing laws prior to the conversion into a regular campus shall be respected.

All parcels of land belonging to the government to be occupied by the PUP-Parañaque City Campus shall be transferred to the PUP: *Provided*, That should the campus or the PUP cease to exist or be abolished or should such aforementioned parcels of land be no longer needed by the PUP, the same shall revert to the City of Parañaque or to the Republic of the Philippines, as the case may be.

- SEC. 7. The provisions of Republic Act No. 8292, otherwise known as the "Higher Education Modernization Act of 1997", shall form part of this Act.
- **SEC. 8.** The amount necessary to carry out the provisions of this Act shall be included in the annual General Appropriations Act (GAA).

The City of Parañaque shall provide the same amount of financial assistance to the campus until such time that the amount necessary for the continued operation and maintenance of the PUP-Parañaque City Campus shall be included in the annual GAA.

- SEC. 9. Within sixty (60) days from the effectivity of this Act, the Board shall, in consultation with the CHED, issue rules and regulations to implement the provisions of this Act.
- SEC. 10. If, for any reason, any part or provision of this Act is declared invalidor unconstitutional, the remaining parts or provisions not affected shall remain in full force and effect.
- SEC. 11. All other laws, presidential decrees, executive orders, rules and regulations contrary to or inconsistent with the provisions of this Act are repealed or modified accordingly.
- SEC. 12. This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a newspaper of general circulation.
