

FURTHER AMENDING SECTION 10(B) OF REPUBLIC ACT NO. 10160, OTHERWISE KNOWN AS THE "CHARTER OF THE CITY OF BACOOR"

EXPLANATORY NOTE

Section 384 of the Local Government Code of 1991 emphasized that the barangay, as the basic political unit, "serves as the primary planning and implementing unit of government policies, plans, programs, projects, and activities in the community."

However, when the local government of the City of Bacoor formulated plans for the city's future development, it was found out that of the 73 barangays, 47 are not generating sufficient annual revenues to independently finance their daily operations and support the needs of their constituents.

To address this, thorough studies and consultations with local leaders and affected barangays were made which resulted in the passage of City Ordinance No. 275-2023 that sought to merge various barangays of the city and rename the affected barangays resulting from the said merging.

On July 31, 2023, a plebiscite was conducted which overwhelmingly ratified the said proposal. With the ratification, the following barangays have been merged and consequently renamed, to wit:

FURTHER AMENDING SECTION 10(B) OF REPUBLIC ACT NO. 10160, OTHERWISE KNOWN AS THE "CHARTER OF THE CITY OF BACOOR"

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. Section 10(b) of Republic Act No. 10160, otherwise known as the "*Charter of the City of Bacoor*", is hereby amended to read as follows:

3 "SEC. 10. *Composition. -* (a) The sangguniang panlungsod, the legislative body of the City, shall be composed of the city vice mayor as the presiding officer, 4 the twelve (12) regular sanggunian members, the president of the city chapter 5 of the liga ng mga barangay, the president of the panlungsod na pederasyon 6 7 ng mga sangguniang kabataan and the three (3) sectoral representatives, as 8 members, who shall come from the following sectors: one (1) from the women sector; and, as shall be determined by the sangguniang panlungsod within 9 ninety (90) days prior to the holding of the local elections, one (1) from the 10 agricultural or industrial workers sector; and one (1) from the other sectors, 11 12 including urban poor, indigenous cutlural communities or persons with disabilities. 13

"(b) The regular members of the sangguniang panlungsod and sectoral
 representatives shall be elected in the manner as may be provided by law:
 Provided, That for purposes of representation in the sangguniang panlungsod,
 six (6) regular members shall be elected from each of the following districts by
