#### AN ACT

SEPARATING THE BACUNGAN NATIONAL HIGH SCHOOL – MANGOP **EXTENSION IN BARANGAY MANGOP, MUNICIPALITY OF LEON B. POSTIGO, PROVINCE OF ZAMBOANGA DEL NORTE FROM THE BACUNGAN NATIONAL** HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS THE MANGOP NATIONAL HIGH SCHOOL, AND **APPROPRIATING FUNDS THEREFOR** 

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The Bacungan National High School – Mangop Extension in Barangay Mangop, Municipality of Leon B. Postigo, Province of Zamboanga del Norte is hereby 2 separated from the Bacungan National High School and converted into an independent national 3 high school to be known as the Mangop National High School. 4

SEC. 2. All personnel, assets, liabilities, and records of the Bacungan National High School - Mangop Extension are hereby transferred to and absorbed by the Mangop National High School. 8

SEC. 3. The Secretary of Education shall immediately include in the Department's 10 program the operationalization of the Mangop National High School, the initial funding of 11 which shall be charged against the current year's appropriation of the Bacungan National High 12 School - Mangop Extension. Thereafter, the amount necessary for the continued operation of 13 the school shall be included in the annual General Appropriations Act. 14

SEC. 4. Within ninety (90) days from the approval of this Act, the Secretary of 16 Education shall formulate the rules and regulations implementing the provisions of this Act. 17 Such implementing rules and regulations shall provide for the school's organization, 18 administration, operations and management, in accordance with Republic Act No. 9155, or the 19 "Governance of Basic Education Act of 2001", Republic Act No. 10533, or the "Enhanced 20 Basic Education Act of 2013", and other basic education-related laws. 21

SEC. 5. This Act shall take effect fifteen (15) days after its publication in the Official 23 Gazette or in a newspaper of general circulation. 24
