AN ACT DECLARING THE PHILIPPINE STATE COLLEGE OF AERONAUTICS AS THE NATIONAL PROFESSIONAL INSTITUTION FOR AVIATION, RENAMING IT THE NATIONAL AVIATION ACADEMY OF THE PHILIPPINES, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- 1 SECTION 1. Short Title. This Act shall be known as the
- 2 "National Aviation Academy of the Philippines Charter Act".
- 3 SEC. 2. Declaration of Policy. The State shall promote
- 4 quality and accessible education relevant to the changing needs

- 1 of the people and society. It shall establish, maintain, and support
- 2 a complete, adequate, and integrated aviation education and
- 3 training system by strengthening the curricula of various
- 4 aviation and other related courses consistent with international
- 5 standards on aviation learning.
- To this end, the National Aviation Academy of the
- 7 Philippines, the leading higher education institution for aviation
- 8 studies, is hereby declared the national professional institution
- 9 for aviation.
- 10 Sec. 3. National Aviation Academy of the Philippines. –
- 11 The existing Philippine State College of Aeronautics (PhilSCA), is
- 12 hereby renamed the National Aviation Academy of the
- 13 Philippines (NAAP). As such, the NAAP shall specialize in
- 14 aviation and aviation-related programs.
- 15 SEC. 4. General Mandate. The NAAP shall develop
- 16 leaders in the Philippine aviation and aerospace
- 17 industries, both in the private/commercial sector and the
- 18 government, including the Armed Forces of the Philippines
- 19 (AFP) and its three (3) main branches the Philippine Air

- 1 Force (PAF), the Philippine Navy (PN), and the Philippine
- 2 Army (PA), as well as the uniformed personnel.
- To attain this purpose, the NAAP shall:
- 4 (a) Provide world-class academic and professional
  5 training to young Filipinos in the field of aviation and
  6 other related fields, and mold them into becoming
  7 responsible citizens who are aware of their role in nation-
- 8 building;
- 9 (b) Produce efficient and well-trained aviation
  10 professionals with technical capabilities comparable to
  11 their counterparts in other countries and who can
  12 competently respond to the needs of the local and
  13 international aviation industry;
- 14 (c) Offer advanced professional studies and 15 specialization for aviation and other related courses, 16 primarily for those who serve as faculty of the State and 17 private colleges and universities;
- (d) Strengthen aviation and other related programsby developing and offering industry-driven programs;

- spearheading collaboration between the academe and the aviation industry; and leading in the implementation of innovative teaching methods in aviation education;
- (e) Serve as the premier academic institution in 4 aviation and related fields of specialization by offering 5 6 undergraduate. graduate. and professional degree programs, promoting collaboration with various colleges 7 8 and universities in the country offering aviation programs, 9 and contributing to the dissemination and application of 10 knowledge on aviation and other related fields: Provided, That technical and regulatory aviation training required 11 for compliance with international standards shall remain 12 under the exclusive authority of the Civil Aviation 13 Training Center (CATC) of the Civil Aviation Authority of 14 the Philippines (CAAP); 15
  - (f) Intensify innovative professional skills, as well as technological research and development in aviation, in collaboration with the CAAP and other attached agencies

- 1 of the Department of Transportation, Department of
- 2 National Defense, and the Philippine Space Agency;
- 3 (g) Offer ladderized undergraduate and graduate
- 4 professional programs in aviation and other related fields
- 5 of study as the Board of Trustees may deem necessary to
- 6 carry out its objectives;
- 7 (h) Provide deserving students greater access to
- 8 aviation education;
- 9 (i) Serve as a regional and global aviation hub in
- 10 cooperation with international academic institutions,
- 11 various networks of the aviation industry, and scholarly
- 12 and professional associations in the Asia Pacific region and
- 13 around the world; and
- 14 (j) Foster a globally competitive and culturally
- 15 sensitive institution, by cultivating a deep understanding
- 16 and appreciation of the role aviation plays in tourism,
- 17 cultural exchange, and national development.
- 18 Sec. 5. Curricular Offerings. The NAAP shall offer
- 19 short-term technical-vocational, undergraduate, and

- 1 graduate courses and specialization in the field of aviation
- 2 and aviation-related programs such as the following:
- 3 Bachelor of Science in Air Transportation specializing in
- 4 Commercial Pilot; Bachelor of Science in Aeronautical
- 5 Engineering, including Drone Technology; Associate in
- 6 Aircraft Maintenance Technology; and Associate in
- 7 Aircraft Electronic Technology leading to Baccalaureate in
- 8 Aircraft Maintenance Technology and Baccalaureate in
- 9 Aircraft Electronics Technology.
- The NAAP shall also provide education in Aviation
- 11 Safety and Security, Supply Chain Management
- 12 specializing in Aviation Logistics, and Aviation
- 13 Information Technology.
- 14 The NAAP shall also develop and design academic
- 15 offerings and confer degrees as appropriate, in accordance
- 16 with relevant policies, standards, and guidelines of the
- 17 Commission on Higher Education (CHED), the Philippine
- 18 Qualifications Framework, and with the CAAP Civil
- 19 Aviation Regulations Part 3, Approved Training
- 20 Organizations, and undergraduate and graduate programs

1 in the fields of aviation.

The CHED and CAAP may appoint faculty and graduates of the NAAP and other colleges and universities to serve as technical evaluators upon acquiring the necessary qualifications and certifications in the field of aviation.

To meet the needs of the national government and the local and international aviation industry requirements, the NAAP may add, remove, or revise undergraduate and graduate degree programs or diploma courses according to its capabilities and as the Board of Trustees may deem necessary to carry out its objectives: *Provided*, That no undergraduate and graduate degree program shall be offered without compliance with the prescribed policy, standards, and guidelines of CHED and, as may be applicable, the CAAP.

SEC. 6. The NAAP Campuses. – The NAAP shall be composed of both regular and extension campuses established by its Board of Trustees upon the recommendation of its President.

1	The regular campuses of the NAAP shall include
2	the following: Villamor Air Base Campus in Pasay City as
3	the main campus; the Basa Air Base Campus in
4	Floridablanca, Pampanga; the Fernando Air Base Campus
5	in Lipa City, Batangas; the Brigadier General Benito N.
6	Ebuen Air Base (BGBNEAB) Campus in Lapu-Lapu City,
7	Cebu, and those that may be created in the future.
8	The extension campuses of the NAAP shall include
9	the following existing campuses: Basa-Palmayo Campus in
10	Floridablanca, Pampanga; the BGBNEAB Campus in
11	Medellin, Cebu; and those that may be created in the
12	future.
13	SEC. 7. Academic Freedom. – The NAAP shall enjoy
14	academic freedom, as provided in Republic Act No. 8292 or
15	the "Higher Education Modernization Act of 1997", and
16	Paragraph 2, Section 5 of Article XIV of the Constitution.
17	SEC. 8. Commitment to National Development. – The
18	NAAP shall utilize the expertise of the members of its
19	community and other individuals concerning the country's
20	goals towards national development in the primary areas

- 1 of aviation and other related fields for the improvement of
- 2 the quality of life, growth of the economy, and
- 3 transformation of the society.
- 4 With profound scientific and professional
- 5 knowledge, the NAAP and its community members shall
- 6 contribute to or take a solicited involvement in the public
- 7 policy process.
- 8 As the national professional institution for aviation,
- 9 the NAAP shall ensure the following:
- 10 (a) All programs and their total enrollment shall be
- 11 in aviation and other related fields;
- 12 (b) Programs not allied with aviation and other
- 13 related fields shall be discontinued; and
- 14 (c) Faculty development and training programs in
- 15 aviation and other related fields shall be accelerated.
- 16 SEC. 9. Democratic Access. The NAAP shall
- 17 democratize the admission process to enhance access to its
- 18 programs and services for disadvantaged students, such as
- 19 indigenous peoples and poor but deserving students,
- 20 valedictorians and salutatorians of public high schools, and

1 students from depressed areas.

It shall admit at least one (1) student from every region, who shall be recommended by the respective regional councils, to the Bachelor of Science in Air Transportation and Bachelor of Science in Aeronautical Engineering programs: Provided, That applicants must pass the basic requirements for admission: Provided, further. That upon determination that there is no qualified applicant from a particular region, another qualified applicant, irrespective of domicile, shall be considered for such slot. 

No student shall be denied admission to the NAAP by reason of age, gender, nationality, religious belief, economic status, ethnicity, physical disability, and political opinion or affiliation.

SEC. 10. Institutional Autonomy and Excellence. –
As the national professional aviation institution, the NAAP
shall enjoy institutional autonomy, pursuant to Paragraph
2, Section 5 of Article XIV of the Constitution, as well as
the responsibility to maintain and enhance its high

- 1 academic aviation standards in the performance of its
- 2 instruction, extension, and community service.
- 3 SEC. 11. Administration. The NAAP shall have
- 4 the general powers of a corporation set forth in Republic
- 5 Act No. 11232 or the "Revised Corporation Code of the
- 6 Philippines". The administration of the NAAP and the
- 7 exercise of its corporate powers shall be vested exclusively
- 8 in the Board of Trustees and the President of the NAAP.
- 9 SEC. 12. Heads of NAAP Campuses. The
- administration of each campus shall be vested in a Campus
- 11 Director who shall serve as head or administrator of each
- 12 of the campuses and shall render full-time service for a
- 13 term of two (2) years and may be reappointed to another
- 14 term.
- 15 The campus director shall be appointed or
- 16 designated by the Board of Trustees, upon the
- 17 recommendation of the search committee and the NAAP
- 18 President, subject to guidelines, qualifications, and
- 19 standards set by the Board: Provided, That upon the
- 20 effectivity of this Act, the incumbent Campus Directors of

- 1 the existing campuses of the NAAP shall continue to serve
- 2 as such until the expiration of their term.
- 3 SEC. 13. The Governing Board. The governing body
- 4 of the NAAP shall be the Board of Trustees, hereinafter
- 5 referred to as the Board, which shall be chaired by the
- 6 Chairperson of the CHED. The President of the NAAP
- 7 shall be the vice-chairperson of the Board and the following
- 8 shall be the members:
- 9 (a) Chairperson of the Committee on Higher,
- 10 Technical and Vocational Education of the Philippine
- 11 Senate;
- 12 (b) Chairperson of the Committee on Higher and
- 13 Technical Education of the House of Representatives;
- 14 (c) Secretary of the Department of Economy,
- 15 Planning, and Development (DEPDev);
- 16 (d) Commanding General of the PAF;
- 17 (e) Director General of the CAAP;
- 18 (f) President of the federation of faculty associations
- 19 of the NAAP;

- 1 (g) President of the federation of student councils of2 the NAAP;
- 3 (h) President of the federation of alumni associations4 of the NAAP; and
- 5 (i) Two (2) private sector representatives who have 6 distinguished themselves in their professions or fields of 7 specialization.

The Board shall appoint two (2) private sector representatives who shall be selected from a list of at least five (5) qualified persons, as recommended by a search committee constituted by the President of the NAAP, in consultation with the CHED Chairperson and other Board members, based on the standards and qualifications for the position set by the Board: *Provided*, That one of the private sector representatives must have a distinctive contribution in the field of aviation and advancement of aviation education in the country, and in the reputable practice of the profession. They shall serve for a term of two (2) years from the date of appointment.

The terms of office of the presidents of the federation of faculty associations, federation of student councils, and federation of alumni associations shall be coterminous with their terms of office, as provided under their respective constitutions and bylaws.

For the purpose, the associations of faculty, alumni, and student councils in each campus shall organize themselves to form their respective federations, which in turn, shall elect their federation officials: *Provided*, That the alumni representative to the Board must not be a faculty or an employee of the NAAP, regardless of status or rank, at the time of representation.

SEC. 14. *Compensation*. – The members of the Board shall serve without compensation but shall be entitled to reimbursement of actual and necessary expenses incurred to attend meetings of the Board and other official business authorized by the Board, subject to existing laws, rules, and regulations.

- SEC. 15. Powers and Duties of the Board. The administration of the NAAP and the exercise of its corporate powers are vested in the Board, which shall have the following specific powers and duties in addition to its general powers of administration and the exercise of all the powers granted to the Board of Directors of a Corporation under Section 35 of Republic Act No. 11232:
- 8 (a) Promulgate and implement policies in accordance 9 with the declared State policies and the provisions of the 10 Constitution on education and science and technology, as 11 well as the policies, standards, and thrusts of the CHED 12 under Republic Act No. 7722 or the "Higher Education Act 13 of 1994";
  - (b) Approve the curricula, institutional programs, and rules on student discipline drawn by the Administrative and Academic Councils, as herein provided;

17 (c) Appoint, upon the recommendation of the NAAP
18 President, the vice presidents, deans, directors, heads of

- campuses, faculty members, and other officials of theNAAP;
- 3 (d) Prescribe the salaries of faculty members,
  4 administrative officials, and employees, subject to the
  5 provisions of Republic Act No. 11466 or the "Salary
  6 Standardization Law of 2019", and other laws amendatory
  7 thereto, Civil Service rules and regulations governing
  8 hours of service and such other requirements and
  9 conditions, other pertinent laws, rules, and regulations;

(e) Fix the tuition fees and other necessary school charges, such as matriculation, graduation, and laboratory fees, as the Board may deem proper to impose, after due consultation with the concerned sectors. The fees and charges, including government subsidies and other income generated by the NAAP, shall constitute its funds to be used exclusively to pursue its mandate as a state university, and shall be deposited in any authorized government depository bank. All interests accruing therefrom shall form part of the same funds for the use of

- the NAAP. Any provision of existing laws, rules, or 1 2 regulations to the contrary notwithstanding, any income 3 generated by the NAAP from tuition fees and other charges as well as from the operation of auxiliary services and land 4 5 grants shall be retained by the NAAP and may be 6 disbursed by the Board for instruction, research, extension services, and other programs and projects of the NAAP: 7 Provided. That all fiduciary fees shall be disbursed for the 8 9 specific purposes for which these are collected: Provided, 10 further, That if, for reasons beyond its control, the NAAP shall not be able to pursue a project for which the funds 11 have been appropriated and allocated under its approved 12 program of expenditures, the Board may authorize the use 13 14 of said funds for any reasonable and legal purposes which, in its discretion, may be necessary and urgent for the 15 16 attainment of the objectives and goals of the NAAP:
- 17 (f) Adopt and implement a socialized scheme of 18 tuition and other school fees for greater access by poor but 19 deserving students in accordance with Republic Act No.

- 1 10931 or the "Universal Access to Quality Tertiary
- 2 Education Act";
- 3 (g) Establish professional chairs in the NAAP and
- 4 provide fellowship for qualified faculty members, and
- 5 scholarships to deserving students;
- 6 (h) Receive and appropriate sums as may be
- 7 provided by law for the support of the NAAP, and all other
- 8 sums in the manner it may, in its discretion, determine to
- 9 carry out the purposes and functions of the NAAP;
- 10 (i) Set the policies on admission and graduation of
- 11 students;
- 12 (j) Award honorary degrees upon persons in
- 13 recognition of learning, statesmanship, or eminence in the
- 14 field of aviation, engineering, science, technology,
- education, public service, or in any field of specialization
- 16 within the academic competency of the NAAP, and
- 17 authorize the awarding of certificates of completion of
- 18 nondegree and nontraditional courses;

- 1 (k) Establish professional training centers, in 2 collaboration with CAAP, to promote the development of 3 the NAAP;
- 4 (l) Develop academic arrangements for institutional
  5 capability building in the aviation and aviation-related
  6 fields and in the appropriate institutions and agencies,
  7 whether public or private, local or foreign, and appoint
  8 experts or specialists as consultants, part-time, visiting, or
  9 exchange professors, and scholars, as the case may be;
- 10 (m) Adopt, whenever applicable, modern and
  11 innovative modes of transferring knowledge to allow
  12 greater access to education, such as the use of information
  13 technology, the dual training system, open distance
  14 learning, and community laboratory;
- 15 (n) Authorize an external management audit of the
  16 NAAP, to be financed by the CHED, subject to the rules
  17 and regulations of the Commission on Audit (COA), and
  18 institute reforms, including academic and structural
  19 changes, based on the audit results and recommendations;

1	(o)	Develop	consortia	and	other	economic	forms	of

- 2 linkages with local government units as well as public,
- 3 private, local, or foreign institutions and agencies for the
- 4 furtherance of the purposes and objectives of the NAAP;
- 5 or publications, instruments, (p) Import books equipment, and apparatuses for economic, technical, 6
- 7 cultural, and aviation-related purposes;

- 8 (q) Enter into joint ventures or public-private partnerships with business and industry for the profitable 9 development and management of the economic assets, the 10 proceeds of which shall be used for the development and strengthening of the NAAP; 12
  - (r) Receive in trust all legacies, gifts, and donations of real and personal properties of all kinds and administer and dispose of the same when necessary for the benefit of the NAAP and subject to the limitations, discretions, and instructions of the donor, if any;
- (s) Extend the term of the President of the NAAP 18 beyond the age of retirement, but not beyond the age of 19

- 1 seventy (70), based on the guidelines, qualifications, and
- 2 standards set by the Board: *Provided*, That such extension
- 3 shall be subject to the term limits provided in Section 17 of
- 4 this Act: *Provided*, *further*, That the President's
- 5 performance has been rated by the Board as outstanding
- 6 and a unanimous recommendation for such extension has
- 7 been decided upon by the Search Committee;
- 8 (t) Delegate any of its powers and duties to the
- 9 President and other officials of the NAAP, as it may deem
- 10 appropriate, to efficiently and effectively administer the
- 11 affairs of the NAAP;
- 12 (u) Where most advantageous to the NAAP,
- 13 outsource the management of non-academic services such
- 14 as health, food, building or grounds or property
- 15 maintenance, and other similar activities;
- 16 (v) Authorize the construction or repair of its
- 17 buildings, machinery, equipment, and other facilities, and
- 18 the acquisition of real property, including the necessary
- 19 supplies, materials, and equipment; and

- 1 (w) Promulgate rules and regulations as may be
- 2 necessary to carry out the purposes and functions of the
- 3 NAAP.
- 4 SEC. 16. Meetings of the Board. The Board shall
- 5 regularly convene once every three (3) months. The
- 6 Chairperson of the Board may, however, call a special
- 7 meeting whenever necessary: *Provided*, That members are
- 8 notified in writing at least three (3) working days prior to
- 9 the conduct of said meeting.
- A guorum of the Board shall consist of a majority of
- all its members holding office at the time of the meeting:
- 12 Provided, That the Chairperson of the Board or the
- 13 President of the NAAP is among those present in the
- 14 meeting.
- 15 In case the Chairperson of the CHED cannot attend
- 16 a meeting of the Board, a CHED Commissioner duly
- 17 designated as representative to the meeting by the CHED
- 18 Chairperson shall have all the rights and responsibilities of
- 19 a regular member: *Provided*, That during the meeting, the

- 1 President of the NAAP, as Vice Chairperson, shall be the
- 2 presiding officer: Provided, further, That the provision
- 3 notwithstanding, the CHED Chairperson may designate a
- 4 CHED Commissioner as the regular Chairperson to the
- 5 Board, in which case, the said CHED Commissioner shall
- 6 act as the presiding officer.

7 In case the Chairpersons of the Senate Committee on 8 Higher, Technical and Vocational Education, the House 9 Committee on Higher and Technical Education, the 10 Commanding General of the PAF, the Secretary of the DEPDev, and the Director General of the CAAP shall not 11 be able to attend the Board meeting, they may designate 12 their respective representatives who shall have the same 13 rights and responsibilities as regular members of the 14 Board: Provided, That the DEPDev shall be represented by 15 its Director designated by the Secretary of the DEPDev, 16 17 and CAAP shall be represented by an Assistant Director

General designated by the Director General of the CAAP.

- 1 SEC. 17. The NAAP President. The NAAP shall be
- 2 headed by a President who shall be appointed by the
- 3 Board, subject to its guidelines, qualifications, and
- 4 standards, and based on the recommendation of a Search
- 5 Committee duly constituted for the purpose of selecting the
- 6 President.
- 7 The President shall be the chief executive officer,
- 8 academic officer, and head of the NAAP and of the faculty.
- 9 As such, the President shall exercise the powers
- specifically provided in this Act, those determined by the
- 11 Board, those that usually pertain to the Office of the
- 12 President of similar educational institutions, and those
- 13 that are related or necessary to its functions.
- 14 The NAAP President shall render full-time service for
- 15 a term of four (4) years, and may be reappointed to another
- 16 term.
- 17 The powers and duties of the President of the NAAP,
- 18 in addition to those provided in this Act, shall include

- those usually pertaining to the Office of the President of
  similar state colleges and those delegated by the Board.
- The salary of the President of the NAAP shall be in accordance with Republic Act No. 11466 or the "Salary Standardization Law of 2019", and such other laws amendatory thereto, which may hereinafter be enacted, and on the joint circular for state universities and colleges' leveling instruments, and guidelines of the CHED and the Department of Budget and Management (DBM).
  - Within six (6) months before the expiration of the term of office of the President of the NAAP, the Board shall constitute the Search Committee for the presidency, and shall ensure the appointment or reappointment of a President on or before the expiration of the term.

In case of vacancy in the Office of the President by reason of death, compulsory retirement, resignation, removal for cause, or incapacity of the President to perform the functions of the office, the Board shall designate an

- 1 Officer-in-Charge (OIC) of the NAAP, pending the
- 2 appointment of a new President.
- The President of the NAAP shall be assisted by the
- 4 following officials: Vice President for Academic Affairs;
- 5 Vice President for Administration, Planning, and Finance;
- 6 and the Vice President for Research, Development, and
- 7 Extension, who shall be appointed by the Board upon the
- 8 recommendation of the President of the NAAP.
- 9 SEC. 18. The Secretary of the NAAP. The Board
- 10 shall appoint a Secretary who shall serve as such for both
- 11 the Board and the NAAP and shall keep all records and
- 12 proceedings of the Board in addition to other duties and
- 13 responsibilities. The Secretary of the NAAP shall serve
- 14 upon each member of the Board the appropriate notice of
- 15 Board meetings.
- 16 Sec. 19. *The Treasurer of the NAAP*. The Treasurer
- 17 of the Philippines shall be the ex officio Treasurer of the
- 18 NAAP.

- SEC. 20. *The Administrative Council.* There shall be an Administrative Council consisting of the President of the NAAP, as Chairperson, and the vice presidents, deans, directors, and other officials of equal rank, as members whose duty is to review and recommend to the Board such policies governing the administration, management, and development planning of the NAAP.
- 8 SEC. 21. *The Academic Council*. There shall be an 9 Academic Council consisting of the President of the NAAP as chairperson, and all academic staff with the rank of at 11 least an assistant professor as members.

The Academic Council shall review and recommend the curricular offerings, fix the requirements for the admission of students, as well as for their graduation and conferment of degrees, exercise disciplinary power over the students, and formulate rules and regulations on student discipline, subject to the review and approval of the Board through the President of the NAAP.

SEC. 22. The Skills Training Council. - There shall be a Skills Training Council, which shall be composed of the NAAP President, as Chairperson; the Dean of the Institute of Engineering and Technology, as vice chairperson; and a Senior Faculty with the rank of Associate Professor and having a license issued by the CAAP and the Professional Regulation Commission, as member. The Council shall act as an advisory body to the Board on matters relating to setting skills training directions, planning, fund sourcing, and allocation, and formulating and reviewing policies and guidelines pertaining to the skills training program of the NAAP. 

SEC. 23. The Faculty. – No political belief, gender preference, cultural or community affiliation or ethnic origin, or religious opinion or affiliation shall be a matter of inquiry in the appointment of faculty members of the NAAP: Provided, That said appointment shall be subject to the guidelines, qualifications, and standards set by the Board: Provided, further, That no member of the faculty

- 1 shall teach for or against any particular church or religious
- 2 sect.
- 3 Sec. 24. Technical Faculty, Employees, and
- 4 Consultants. To ensure quality, relevant, and up-to-date
- 5 education, the NAAP shall also maintain a pool of local and
- 6 international part-time faculty members who shall teach
- 7 technical subjects, as well as employees and consultants
- 8 who shall perform technical work. These technical faculty,
- 9 employees, and consultants shall possess special
- 10 knowledge, skills, and know-how in the various fields of
- 11 aviation. They shall receive fair and appropriate
- 12 compensation comparable to that of their counterparts in
- 13 the private sector, as determined by the Board. They shall
- 14 also have the privilege to arrange their specific work
- schedules, subject to existing Civil Service laws, rules, and
- 16 regulations.
- 17 SEC. 25. Scholarship Programs and Admission. The
- 18 NAAP shall provide scholarships and other affirmative

- 1 action programs to assist poor but deserving students who
- 2 qualify for admission to the NAAP.
- 3 No student shall be denied admission to the NAAP by
- 4 reason of gender, religion, political, cultural or community
- 5 affiliation, or ethnic origin.
- 6 SEC. 26. Student Affairs. There shall be established
- 7 in the NAAP the following student councils: for every
- 8 college or institute, a student council; for every campus, a
- 9 campus student council; and for the entire NAAP, a
- 10 federation of all student councils. The student council shall
- serve as the primary student body that shall advance the
- 12 interests, welfare, and aspirations of the students of the
- 13 NAAP. It shall have the power to adopt internal rules of
- 14 procedure consistent with the provisions of this Act.
- 15 Subject to due and comprehensive consultation with
- 16 the students, there shall be a student publication
- 17 established in every campus to be funded by student fees.
- 18 Freedom of expression and autonomy in all matters of

SEC. 27. Land Grants and Other Real Properties of

- 1 editorial and fiscal policy shall be guaranteed, especially in
- 2 the selection of its editors and staff.

- the NAAP. The State shall support the NAAP as the
   professional institution for aviation through the annual
   General Appropriations Act and other financial benefits,
- 8 other real properties. To carry out the intent of these

and in kind, through land grants and donations and use of

- 9 grants, income derived from the development of all land
- 10 grants and real properties shall be used to further the ends
- of the NAAP, as may be determined by the Board.
  - Such parcels of land ceded by law, decree, or Presidential issuance to the NAAP are declared to be reserved for the purposes intended. The absolute ownership of the NAAP over these landholdings, including those covered by original and transfer certificates of title in the name of the NAAP and their future derivatives, is hereby confirmed. Where the issuance of proper certificates of title for these landholdings is yet pending, the

- 1 appropriate government office may expedite the issuance
- 2 thereof within six (6) months from the date of effectivity of
- 3 this Act: Provided, That all registration requirements
- 4 necessary for the issuance of the said titles have been
- 5 submitted and complied with.
- 6 The Board may plan, design, approve, and cause the
- 7 implementation of land leases: Provided, That such
- 8 mechanisms and arrangements shall sustain and protect
- 9 the environment in accordance with law, and exclude the
- 10 academic core zone of the campuses of the NAAP:
- 11 Provided, further, That such mechanisms and
- 12 arrangements shall not conflict with the academic mission
- of the NAAP.
- 14 The Board may allow the use of income from real
- 15 properties of the NAAP as security for transactions to
- 16 generate additional revenues, when needed, for
- 17 educational purposes.
- 18 The Board may approve the implementation of joint
- 19 ventures: Provided, That in the event that the real

- properties of the NAAP are involved, only the income derived by NAAP from the use of real properties shall be the subject of its participation or obligation in the joint ventures: *Provided, further*, That no joint venture shall result in the alienation of the real properties owned by the NAAP.
- Any plan to generate revenues and other sources 7 8 from land grants and other real properties entrusted to the 9 NAAP shall be consistent with the academic mission and 10 orientation of the NAAP, as well as protect it from undue influence and control of commercial interests: Provided, 11 That such programs, projects, or mechanisms shall be 12 approved by the Board, subject to a transparent and 13 democratic process of consultation with the constituents of 14 the NAAP: Provided, further, That funds generated from 15 such programs, projects or mechanisms shall not be meant 16 17 to replace in whole or in part the annual appropriations 18 provided by the national government to the NAAP.

- 1 Sec. 28. Safeguards on Assets Disposition. The
- 2 preservation of the value of the assets of the NAAP shall be
- 3 of primary consideration.
- 4 The sale of any existing property of the NAAP shall
- 5 be prohibited: *Provided*, That the Board may alienate real
- 6 property donated after the effectivity of this Act if the
- 7 terms of the donation specifically allow it.
- 8 Sec. 29. Authority to Loan or Transfer Apparatus,
- 9 Equipment, Supplies and Detail of Personnel. The heads
- 10 of national government agencies and instrumentalities
- 11 may, upon the request of the Board, through the President
- of the NAAP, loan or transfer such apparatus, equipment
- 13 or supplies as may be needed by the NAAP, and detail
- 14 personnel for duty therein: Provided, That such loan,
- 15 transfer, or detail shall not be detrimental to public
- 16 service.
- 17 The personnel so detailed shall perform such duties
- 18 as required by the President of the NAAP and the time

- thus served shall be counted as part of their regularservice.
- 3 SEC. 30. Management of Assets, Liabilities, Personnel and Records of the NAAP. - All assets, real and personal, 4 5 personnel, records, as well as liabilities or obligations of the PhilSCA are hereby transferred to the NAAP: 6 7 *Provided*, That the positions, rights, and security of tenure 8 of its faculty members and personnel under existing laws 9 prior to the conversion to an academy shall be respected: 10 Provided, further, That the incumbents occupying the positions shall remain in the same status until otherwise 11 provided by the Board: Provided, finally, That the NAAP 12 shall also accordingly upgrade or increase its human 13 14 resource component as may be deemed appropriate by the Board. 15
  - All parcels of land belonging to the government occupied by the PhilSCA and all its campuses are hereby declared as property of the NAAP, and shall be titled under its name, except those that are titled under the AFP

through the PAF, which NAAP may continue to use for the purposes stated herein, under a usufructuary agreement or any other arrangement as may be agreed upon by the parties: Provided, That should the NAAP cease to exist or be abolished, or should such aforementioned parcels of land be no longer needed by the NAAP, the same shall revert to the concerned local government unit or to the Republic of the Philippines, as the case may be: Provided, further, That such reversion shall not impair obligation of contracts.

SEC. 31. Duty and Tax Exemptions. – The importation of books or publications, instruments, equipment, and apparatuses, which are for economic, technical-vocational, scientific, philosophical, historical, legal, cultural or aviation-related purposes, including aircraft and aircraft tools and equipment, computers and software equipment, made by the NAAP, upon certification by the CHED, shall be exempt from customs duties in accordance with the provisions of Republic Act No. 10863 or the "Customs Modernization and Tariff Act (CMTA)".

- All grants, bequests, endowments, donations, and 1 2 contributions made to and used actually, directly, and 3 exclusively for educational purposes by the NAAP, shall be exempt from donor's tax and the same shall be considered 4 5 as allowable deductions from gross income for purposes of 6 computing the taxable income of the donor in accordance with the provisions of the National Internal Revenue Code 7 of 1997, as amended. 8
- 9 SEC. 32. Development Plan, Management Audit, and
  10 Organizational, Administrative, and Academic Structure. –
  11 Within one hundred twenty (120) days after the approval
  12 of this Act, the NAAP shall accomplish the following:
- 13 (a) Submit a five (5)-year development plan, 14 including its program budget to the CHED for 15 recommendation of the DBM;
- 16 (b) Submit the revised Land Use Development and
  17 Infrastructure Plan (LUDIP), in accordance with Republic
  18 Act No. 11396 or the "SUCs Land Use Development and
  19 Infrastructure Plan (LUDIP) Act";

- 1 (c) Set up its organizational, administrative, and
- 2 academic structure, including the appointment of key
- 3 officials of the NAAP; and
- 4 (d) Undergo a management audit in coordination
- 5 with CHED.
- 6 SEC. 33. Reportorial Requirements and Auditing of
- 7 Accounts. The NAAP shall submit an annual report to
- 8 Congress containing the financial statements, statement of
- 9 assets and liabilities, and statement of income from tuition
- 10 fees and other revenue sources. All accounts and
- disbursements of the NAAP shall be audited by the COA.
- 12 SEC. 34. Rules of Construction. No statutory or
- 13 other issuances shall diminish the powers, rights,
- 14 privileges, and benefits accorded to the NAAP under this
- 15 Act, or those enjoyed at present under other issuances not
- 16 otherwise modified or repealed under this Act unless
- 17 subsequent legislation expressly provides for their repeal,
- 18 amendment, or modification. Any doubt in the
- 19 interpretation of any of the provisions of this Charter shall

- 1 be resolved in favor of the academic freedom and
- 2 institutional autonomy of the NAAP.
- 3 SEC. 35. Suppletory Application. The provisions of
- 4 Republic Act No. 8292 or the "Higher Education"
- 5 Modernization Act of 1997", shall form part of this Act.
- 6 SEC. 36. Appropriations. The amount necessary
- 7 for the initial implementation of this Act shall be charged
- 8 against the current year's appropriations of the PhilSCA.
- 9 Thereafter, such amount shall be included in the annual
- 10 General Appropriations Act.
- 11 SEC. 37. Transitory Provision. To provide strategic
- 12 direction and leadership to the NAAP as the PhilSCA
- 13 transitions to its pioneer status as the national
- 14 professional institution for aviation and to ensure the
- 15 attainment of its distinctive and purposeful mandate, as
- 16 provided in this Act, the incumbent President of the
- 17 PhilSCA shall serve as the first President of the NAAP for
- 18 a term of four (4) years without reappointment.

- 1 Sec. 38. Implementing Rules and Regulations. -
- 2 Within sixty (60) days from the approval of this Act, the
- 3 Board shall, in consultation with the CHED and the CAAP,
- 4 issue rules and regulations to implement its provisions.
- 5 SEC. 39. Separability Clause. If, for any reason, any
- 6 part or provision of this Act is declared invalid or
- 7 unconstitutional, the remaining parts or provisions not
- 8 affected are in full force and effect.
- 9 SEC. 40. Repealing Clause. Presidential Decree No.
- 10 1078, titled "Converting the Basa Air Base Community
- 11 College into the Philippine Air Force College of
- 12 Aeronautics, Providing for a Charter for this Purpose", and
- 13 Republic Act No. 7605, titled "An Act Converting the
- 14 Philippine Air Force College of Aeronautics into a State
- 15 College to be Known as the Philippine State College of
- 16 Aeronautics and for Other Purposes, Amending
- 17 Presidential Decree Numbered Ten Hundred and Seventy-
- 18 Eight, titled, 'Converting the Basa Air Base Community
- 19 College into the Philippine Air Force College of

- 1 Aeronautics, Providing for a Charter for this Purpose', and
- 2 all other laws, decrees, orders, rules and regulations, and
- 3 issuances inconsistent with the provisions of this Act are
- 4 amended, repealed, or modified accordingly.
- 5 SEC. 41. *Effectivity Clause*. This Act shall take effect
- 6 fifteen (15) days after its complete publication in the
- 7 Official Gazette or in a newspaper of general circulation.
