AN ACT CONVERTING THE VICTORIA – LA PAZ ROAD IN THE  
MUNICIPALITIES OF VICTORIA AND LA PAZ, PROVINCE OF  
TARLAC INTO A NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in  
Congress assembled:*

1           SECTION 1. The Victoria – La Paz Road in the municipalities of  
2 Victoria and La Paz, Province of Tarlac is hereby converted into a national  
3 road.

4           SEC. 2. The Secretary of the Department of Public Works and  
5 Highways shall issue the necessary rules, orders and circulars to implement the  
6 provision of this Act.

7           SEC. 3. This Act shall take effect upon its approval.
