AN ACT CONVERTING THE PANGLAO ISLAND CIRCUMFERENTIAL ROAD IN THE MUNICIPALITIES OF PANGLAO AND DAUIS, INCLUDING THE AMBASSADOR PABLO SUAREZ BRIDGE IN SITIO UBOS-TOTULAN, TAGBILARAN CITY, PROVINCE OF BOHOL INTO A NATIONAL ROAD

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1           SECTION 1. The Panglao Island Circumferential Road in the  
2 municipalities of Panglao and Dauis, including the Ambassador Pablo Suarez  
3 Bridge in Sitio Ubos-Totulan, Tagbilaran City, Province of Bohol is hereby  
4 converted into a national road.

5           SEC. 2. The Secretary of the Department of Public Works and  
6 Highways shall issue the necessary rules, orders and circulars to implement the  
7 provision of this Act.

8           SEC. 3. This Act shall take effect upon its approval.
