#### **EXPLANATORY NOTE**



## INTRODUCED BY HON, MANNY VILLAR

# AN ACT TO DECLARE THE MONTH OF MAY OF EVERY YEAR AS "MOUNTAINEERING MONTH"

Be it enacted by the Senate and House of Representatives of the Philippines in congress assembled:

SECTION 1. Declaration of Policy.- It is the policy of the State to promote physical education, encourage and sustain the development of sports in the country to foster physical fitness, self-discipline, teamwork and excellence for the development of a healthy and alert citizenry.

SECTION 2. The month of May of every year is hereby declared as "Mountaineering Month".

SECTION 3. Lead Agency.- In the observance of this yearly occasion, the Philippine Sports Commission shall conduct activities and programs in order to celebrate the glorious event.

SECTION 4. Implementing Rules and Regulations.- The Philippine Sports Commission shall promulgate the appropriate rules and regulations necessary for the effective implementation of this Act within sixty (60) days from its approval.

SECTION 5. Separability Clause.- If any provision or part thereof is held invalid or unconstitutional, the remainder of the law or the provision not otherwise affected shall remain valid and subsisting.

SECTION 6. Repealing Clause.- Any law, presidential decree or issuance, executive order, letter of instruction, administrative order, rule or regulation contrary to or inconsistent with the provision of this Act is hereby repealed, modified or amended accordingly.

SECTION 7. Effectivity Clause.- This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in at least two (2) newspapers of general circulation.
