EXPLANATORY NOTE

The value of human rights must be inculcated in our youth.

Various sectors in society, the Church included, have acknowledged the urgent need for human rights to be discussed with the young citizens of our country.

The subject of Human Rights however is being taught by Philippine schools only on a voluntary basis.

Article XIV, Section 3(1 & 2) of the 1987 Constitution states:

"(1) All educational institutions shall include the study of the Constitution as part of the curricula."

"(2) They shall inculcate patriotism, foster love of humanity, respect for human rights, appreciation of the role of national heroes in the historical development of the country, teach the rights and duties of citizenship, strengthen ethical and spiritual values, develop moral character and personal discipline, encourage critical and creative thinking, broaden scientific and technological knowledge, and promote efficiency."

Moreover, the Constitution empowers and mandates tile Commission on Human Rights as provided in Article XIII, Section 18 (5) to:

"(5) Establish a continuing program of research, education, and information to enhance respect for the primacy of human rights."

In its Resolution 49/184 dated December 23, 1994, the United Nations General Assembly proclaimed the ten-year period beginning January 1, 1995 as the United Nations Decade for Human Rights Education.

To implement the aforesaid constitutional provisions more effectively, and in observance of the U.N. Decade for Human Rights Education, this bill is being filed to make the teaching of human rights a mandatory part of the curriculum of all educational institutions.

Approval of this bill is earnestly requested.

AN ACT REQUIRING THE TEACHING OF HUMAN RIGHTS AS MANDATORY IN ALL PUBLIC AND PRIVATE SCHOOLS AND FOR OTHER PURPOSES

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. All public and private schools shall include human rights courses in their curricula. No school shall be established or allowed to operate unless this requirement is complied with.

SEC. 2. The Department of Education (DepEd), in consultation with the Commission on Human Rights (CHR), shall formulate courses on human rights to be taught as separate courses or incorporated in existing subjects now being taught in all levels of education throughout the country.

SEC. 3. The Department of Education (DepEd) shall also consult and coordinate with the Commission on Human Rights (CHR) in the writing, printing and publication of text books, memorials and other reading materials to be issued in the said human rights courses.

SEC. 4. This Act shall be initially implemented within the framework of the Budget of the Department of Education (DepEd) for the year it is enacted into law. As far as practicable, the funds required therefore shall be drawn from its appropriations for policy formulation, program planning, standards development and instructional materials development.

Thereafter, such amounts as may be necessary for the implementation of this Act shall be included in tile budget of the Department of Education (DepEd) in the annual General Appropriations Act.

SEC. 5. The Department of Education (DepEd), in consultation with the Commission on Human Rights (CHR), shall, within six (6) months from the approval of this Act, prepare implementing rules and regulations necessary to carry out the provisions of this Act.

SEC. 6. This Act shall take effect after fifteen (15) days from its publication in at least two (2) national newspapers of general circulation.
