### CALL TO ORDER

At 4:08 p.m., the Senate President, Hon. Manny Villar, called the session to order.

### **PRAYER**

The Body observed a minute of silent prayer.

### ROLL CALL

Upon direction of the Chair, the Secretary of the Senate, Emma Lirio-Reyes, called the roll, to which the following senators responded:

With 19 senators present, the Chair declared the presence of a quorum.

Senators Biazon, Cayetano (A) and Lapid arrived after the roll call.

Senator Trillanes was unable to attend the session.

# MOTION OF SENATOR PANGILINAN

Senator Pangilinan moved that the Body dispense with the reading of the Journal of Session No. 13 and consider it approved.

### MANIFESTATION OF SENATOR LACSON

At this juncture, Senator Lacson called the attention of the Body to a potential constitutional crisis in the Chamber, considering that on page 171 of the Journal of August 13, 2007, five senators from the Minority were elected members of the Commission on Appointments (CA), namely, Senators Madrigal, Legarda, Biazon, Roxas and Trillanes; and on page 283 of the previous day's Journal, eight senators from the Majority were elected as members of the CA, namely, Senators Arroyo, Defensor Santiago, Enrile, Gordon, Lapid, Cayetano (A), Ejercito Estrada and Pangilinan, or a total of 13 senators which definitely exceeded what the Constitution allows — 12 senators in the CA.

In reply, Senator Pangilinan cited the Record of the Senate that showed that with respect to the membership in the CA, Senator Pimentel qualified the nomination to the effect that should the Minority be entitled to one additional seat, it would go to Senator Trillanes.

Senator Pimentel confirmed Senator Pangilinan's explanation, stating that if he had nominated more than what the Minority was entitled to, he would withdraw the membership of Senator Trillanes. On a related matter, he said that party affiliation should also be addressed by the Body in determining the membership in the CA, as he noted that Senator Arroyo, being an independent, should not be entitled to any seat at all.

The Chair suggested that the matter be discussed during the caucus, to which Senator Pangilinan agreed.

Senator Lacson called on the Members to uphold the rule of law consistently as Section 18, Article VI of the Constitution is very clear with respect to the membership in the CA, and that the Supreme Court had ruled accordingly in the case of Guingona v. Tañada and Gonzales.

## MANIFESTATION OF SENATOR GORDON

Senator Gordon stated that he has not affiliated with any political party even before he ran in the elections, and he has never taken an oath as a member of the *Lakas* party.

### SUSPENSION OF SESSION

Upon motion of Senator Pangilinan, the session was suspended to allow the senators to meet in caucus at the Senators' lounge.

It was 4:17 p.m.

### RESUMPTION OF SESSION

At 6:22 p.m., the session was resumed.

### CHANGE OF REFERRAL

On the matter of the "Hello Garci" issue, which was the subject of the privilege speeches of Senators Lacson and Gordon, upon motion of Senator Pangilinan, there being no objection, the Body approved the change of its referral from the Committee of the Whole to the Committee on National Defense and Security as the primary committee, and the Committee on Accountability of Public Officers and Investigations and the Committee on Constitutional Amendments, Revision of Codes and Laws as the secondary committees, because anyway the memberships of the three committees comprise more or less the entire Senate. Moreover, he pointed out that the change of referral would facilitate the hearing of other important measures pending before the committees.

Senator Pangilinan informed the Body that the chairmen of the three committees would meet to thresh out the proceedings and the schedule of the hearings.

## MOTION OF SENATOR PANGILINAN

Upon motion of Senator Pangilinan, there being no objection, the Body authorized the committees to conduct only one hearing on measures that had reached plenary debates in the 13th Congress and to submit the corresponding committee reports for sponsorship on the floor without prejudice to Members asking questions if they so desire. He said that the move seeks to facilitate the enactment of priority measures that would benefit the people.

### SUSPENSION OF SESSION

Upon motion of Senator Pangilinan, the session was suspended.

### REMARKS OF SENATOR PIMENTEL

On the matter of the referral of the privilege speeches on the "Garci tapes," Senator Pimentel disclosed that the outcome of the caucus was the product of serious discussions. He noted that the agreement to refer the speeches to the three committees was a product of "Ping-Pong" diplomacy.

Upon motion of Senator Pangilinan, the session was suspended.

### REMARKS OF SENATOR LEGARDA

Senator Legarda stated that if there was anyone who should have complained about the change of referral of the Garcillano issue from the Committee of the Whole to the three committees it should be her because she was a victim of the election fraud of 2004. But after the thorough deliberations, she said that she concurred with the change of referral as the memberships of the three committees comprise the whole Senate; thus, the investigation can begin on the issues raised in Senator Lacson's speech at the same time that the Body continues with its legislative work.

### COMMISSION ON APPOINTMENTS

Relative thereto, Senator Pangilinan stated that, as agreed upon during the caucus, the contingent of the Minority to the Commission on Appointments is five while the Majority is entitled to seven. Consequently, he said that his membership in the CA was deemed withdrawn.
