INTRODUCED BY THE HONORABLE MAR ROXAS

EXPLANATORY NOTE

The passage of R.A. No. 1161 on 18 June 1954 marks the establishment of the Social Security System (SSS) for our country's wage earners and low-salaried employees. It took three (3) years from the time the law was enacted to formulate a complex system for a pension plan that will provide lifetime retirement income to employees. The creation of SSS is the response of the state to its duty to promote social justice by insuring the well-being and economic stability of the people in all phases of national development as stated in Section 10 of the Constitution. Henceforth, R.A. No. 1161 was enacted pursuant to the "policy of the Republic of the Philippines to develop, establish gradually and perfect a social security system which shall be suitable to the needs of the people throughout the Philippines and shall provide protection to employees against the hazards of disability, sickness, old age and death."

From the time the Social Security Act was implemented in 1957 up to 1989, the membership of SSS grew at a rate of 15%. Collective data from 1957 to 1989 show that it was the period whereby twenty-six (26) contributions were equivalent to one (1) benefit. As of the latest data from SSS in 2003, the ratio is one (1) contribution for every (1) benefit. This has been the case since 1985. Clearly, the amount of benefits that the SSS provides exceeds the rate of growth in the number of new entrants and contributions.

This bill seeks to address the fund deficiencies that the SSS will face in the future if these problems are not addressed. Specifically, this bill ensures that increases in the value or additions to the kinds of benefits should be supported by a corresponding increase in the rate of contribution. It will also free four percent (4%) of administrative and operating costs to more productive and profitable uses for the institution. Furthermore, to reduce the incidence of delinquent payments by employers and other offenses, the fine was increased by ten times.

In view of the foregoing, approval of this bill is earnestly requested.

AN ACT

TO STRENGTHEN THE SOCIAL SECURITY SYSTEM THEREBY AMENDING FOR THIS PURPOSE, REPUBLIC ACT NO. 1161, AS AMENDED, OTHERWISE KNOWN AS THE SOCIAL SECURITY LAW

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

19 "Sec. 18. *Employee's Contributions.* - (a) Beginning as of the last day of the calendar 20 month when an employee's compulsory coverage takes effect and every month 21 thereafter during his employment, the employer shall deduct and withhold from such 22 employee's monthly salary, wage, compensation or earnings, AS the employee's

"Sec. 25. Deposits and Disbursements. - All money paid to or collected by the SSS 5 every year under this Act, and all accruals thereto shall be deposited, administered 6 and disbursed in the same manner and under the same conditions and requirements 7 8 as provided by law for other public special funds: Provided, That not more than [twelve] EIGHT percent [(12%)] (8%) of the total yearly contributions plus three 9 percent (3%) of other revenues shall be disbursed for operational expenses such as 10 salaries and wages, supplies and materials, depreciation and the maintenance of 11 12 offices of the SSS: Provided, further, That if the expenses in any year are less than the maximum amount permissible, the difference shall not be availed of as additional 13 14 expenses in the following years.

15 SEC. 4. Section 28 of Republic Act No. 1161, as amended, is hereby further amended
16 to read as follows:

17 "Sec. 28. *Penal Clause.* - (a) Whoever, for the purpose of causing any payment to be 18 made under this Act, or under an agreement thereunder, where none is authorized to 19 be paid, shall make or cause to be made false statement or representation as to any 20 compensation paid or received or whoever makes or causes to be made any false 21 statement of a material fact in any claim for any benefit payable under this Act, or 22 application for loan with the SSS, or whoever makes or causes to be made any false statement, representation, affidavit or document in connection with such claim or
 loan, shall suffer the penalties provided for in Article One hundred seventy-two of
 the Revised Penal Code.

"(b) Whoever shall obtain or receive any money or check under this Act or any
agreement thereunder, without being entitled thereto with intent to defraud any
member, employer or the SSS, shall be fined not less than [five] FIFTY thousand pesos
[(P5,000.00)] P50,000.00 nor more than [twenty] TWO HUNDRED thousand pesos
[(P20,000.00)] P200,000.00 and imprisoned for not less than six (6) years and one (1)
day nor more than twelve (12) years.

10 "(c) Whoever buys, sells, offers for sale, uses, transfers or takes or gives in exchange, or pledges or gives in pledge, except as authorized in this Act or in regulations made 11 pursuant thereto, any stamp, coupon, ticket, book or other device, prescribed 12 pursuant to Section Twenty-three hereof by the Commission for the collection or 13 payment of contributions required herein, shall be fined not less than [five] FIFTY 14 thousand pesos [(P5,000.00)] P50,000.00 nor more than [twenty] TWO HUNDRED 15 thousand pesos [(P20,000.00)] P200,000.00, or imprisoned for not less than six (6) 16 years and one (1) day nor more than twelve (12) years, or both, at the discretion of 17 the court. 18

19 "(d) Whoever, with intent to defraud, alters, forges, makes or counterfeits any stamp, 20 coupon, ticket, book or other device prescribed by the Commission for the collection 21 or payment of any contribution required herein, or uses, sells, lends, or has in his 22 possession any such altered, forged or counterfeited materials, or makes, uses, sells or 23 has in his possession any such altered, forged, material in imitation of the material 24 used in the manufacture of such stamp, coupon, ticket, book or other device, shall be

fined not less than [five] FIFTY thousand pesos [(P5,000.00)] P50,000.00 nor more than [twenty] TWO HUNDRED thousand pesos [(P20,000.00)] P200,000.00 or imprisoned for not less than six years (6) and one (1) day nor more than twelve (12) years, or both, at the discretion of the court.

"(e) Whoever fails or refuses to comply with the provisions of this Act or with the 5 6 rules and regulations promulgated by the Commission, shall be punished by a fine of not less than [five] FIFTY thousand pesos [(P5,000.00)] P50,000.00 nor more than 7 [twenty] TWO HUNDRED thousand pesos [(P20,000.00)] P200,000.00, or 8 9 imprisonment for not less than six (6) years and one (1) day nor more than twelve (12) years, or both, at the discretion of the court: *Provided*, That where the violation 10 consists in failure or refusal to register employees or himself, in case of the covered 11 self-employed or to deduct contributions from the employees' compensation and 12 13 remit the same to the SSS, the penalty shall be a fine of not less Five thousand pesos (P5,000.00) nor more than Twenty thousand pesos (P20,000.00) and imprisonment for 14 not less than six (6) years and one (1) day nor more than twelve (12) years. 15

"(J) WHENEVER THERE IS A DELAY IN THE REMITTANCE OF CONTRIBUTION
TO THE COMMISSION, THE SAME AMOUNT SHALL BE PAID TO THE LATTER
AND SHALL INCLUDE THREE PERCENT (3%) INTEREST PAYMENT

Repealing Clause. - All laws, proclamations, executive orders, rules and 2 regulations or parts thereof inconsistent with this Act are hereby repealed, modified or 3 amended accordingly: *Provided*, That no person shall be deemed to be vested with any 4 property or other right by virtue of the enactment or operation of this Act.

5 SEC. 7. *Effectivity Clause.* - This Act shall take effect fifteen (15) days after its 6 complete publication in the *Official Gazette* or in at least two (2) national newspapers of 7 general circulation whichever comes earlier.
