EXPLANATORY NOTE

There is an increasing public concern on the failure of the civil service to cope with technological strides, particularly in computerization of government offices. The lag is not only due to the lack of computers, but also in the absence or lack of personnel technically proficient to operate computers, or both.

This bill seeks to place our civil service at par with the private sector in the use of computer technology. All clerical, technical, supervisory, and even executive officers and employees of the government, who are professional or non-professional civil service eligibles, will be required to undergo basic training in computer and technology.^{*}

AN ACT
REQUIRING COMPUTER EDUCATION AND
APPROPRIATING FUNDS FOR THE PURPOSE

4 Be it enacted by the Senate and the House of Representatives of the Philippines in 5 Congress assembled:

6 SECTION 1. Short Title. - This Act shall be cited as the "Computer Education and
7 Training of Government Employees Act."

8 SECTION 2. *Mandatory Computer Education*. – All employees of the government in all 9 branches, subdivisions, instrumentalities, and agencies thereof, who are professional or non-10 professional civil service eligibles or their equivalent, holding clerical, technical, supervisory, 11 and executive positions, of all ranks and levels, are required to undergo a training program in 12 basic computer science and technology. Employees of the government who are employed on a 13 casual or contractual basis and those holding maintenance or janitorial positions are excluded 14 from the requirements of this Act.

15 SECTION 3. *Program to be Developed by the Civil Service Commission.* – The Civil 16 Service Commission is mandated to develop a program providing the training required under the 17 preceding section, which program shall be undertaken by the employee during office hours and 18 shall be credited as part of the hours worked by the employee in the performance of his duties 19 and functions.

SECTION 4. Computer Proficient Employees Exempted from the Provisions of this Act. –
 The Civil Service Commission shall include in the program under the preceding section a

method whereby an officer or employee already proficient in computer science and technology
 may be exempted from the basic computer training in this Act.

3 SECTION 5. *Provision for Implementation of this Act.* – The amount of One Hundred 4 Million Pesos (P100,000,000.00), to be included in the national budget for the incoming fiscal 5 year, shall be applied to implement the provisions of this Act. Appropriations for the 6 implementation of this Act for the succeeding years shall be automatically included in the annual 7 General Appropriations Act.

8 SECTION 6. Separability Clause. – If any provision or part hereof, is held invalid or 9 unconstitutional, the remainder of the law of the provision not otherwise affected shall remain 10 valid and subsisting.

11 SECTION 7. *Repealing Clause.* – Any law, presidential decree or issuance, executive 12 order, letter of instruction, administrative order, rule or regulation contrary to or inconsistent 13 with the provisions of this Act is hereby repealed, modified or amended accordingly.

SECTION 8. *Effectivity Clause.* – This Act shall take effect fifteen (15) days after its
 publication in at least two (2) newspapers of general circulation.
